18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:							
19	SECTION 1. NEW LAW A new section of law to be codified							
20	in the Oklahoma Statutes as Section 4020 of Title 69, unless there

SECTION 2. NEW LAW A new section of law to be codified
 in the Oklahoma Statutes as Section 4020.1 of Title 69, unless there
 is created a duplication in numbering, reads as follows:

Route 66 is one of the original highways within the U.S. Highway 4 5 System. Officially, the numerical designation 66 was assigned to the Chicago-to-Los Angeles route on November 11, 1926. From the 6 7 outset, public road planners intended U.S. 66 to connect the main 8 streets of rural and urban communities along its course for the most 9 practical of reasons; most small towns had no prior access to a 10 major national thoroughfare. This was certainly true in Oklahoma. 11 Oklahoma's stretch of Route 66 runs from Miami through Tulsa and 12 Oklahoma City to Erick, passing through cities and towns of all 13 sizes and vast expanses of rural landscape, before entering Texas 14 and continuing on its way to Santa Monica, California. The Oklahoma 15 Route 66 Centennial Commission is established to plan, coordinate 16 and implement programs and special events to celebrate the historic 17 highway's centennial in 2026 with the support of the Oklahoma 18 Historical Society.

The centennial is an opportunity to celebrate the important history of Route 66 in Oklahoma through commemorative, educational and community events, including programs and exhibits about the history of how local communities grew and changed with construction of the highway; the development of a modern transportation system; the cultural impact of Route 66 both within the United States and

1 internationally; the portrayal of Route 66 in music, artwork and 2 folklore; and how we maintain the mystique and appeal of Route 66 3 for future generations.

The study, preservation and maintenance of Route-66-related resources has been a public/private partnership in Oklahoma for decades. Government agencies, private organizations and individual citizens have played critical roles in these efforts, and the Oklahoma Route 66 Centennial Commission shall seek input from these partners and the general public as it develops plans for the celebration and encourages their participation.

11 The significance of the Oklahoma stretch of Route 66 is 12 demonstrated through its status as both a state and a National 13 Scenic Byway and as a segment of the Route 66 National Historic 14 Trail (legislation for NHT designation is pending in the U.S. 15 Congress). Dozens of Oklahoma properties are related to Route 66, 16 such as roadbed segments, bridges, commercial buildings, service 17 stations and tourist attractions, and are listed in the National 18 Register of Historic Places. The significance of the highway is 19 further recognized through the National Trust for Historic 20 Preservation's selection of the entire length of the highway as one 21 of its National Treasures.

22 SECTION 3. NEW LAW A new section of law to be codified 23 in the Oklahoma Statutes as Section 4020.2 of Title 69, unless there 24 is created a duplication in numbering, reads as follows:

1 Α. The Oklahoma Route 66 Centennial Commission shall be 2 composed of twenty-one (21) members. Appointed members shall 3 reflect the interests, history and importance of the communities 4 along Route 66 in Oklahoma. The members are appointed as follows: 5 1. Two members shall be appointed by the Speaker of the House of Representatives; 6 7 Two members shall be appointed by the President of the 2. 8 Senate; 9 3. Three members of the public shall be appointed by the 10 Governor; and Fourteen ex officio members shall be appointed as follows: 11 4. 12 a. the Governor or his or her designee, 13 b. the Lieutenant Governor, who shall serve as 14 chairperson, or his or her designee, 15 the Executive Director of the Oklahoma Department of с. 16 Transportation or his or her designee, 17 d. the Executive Director of the Oklahoma Historical 18 Society or his or her designee, 19 the Executive Director of the Oklahoma Department of e. 20 Commerce or his or her designee, 21 f. the Executive Director of the Oklahoma Tourism and 22 Recreation Department or his or her designee, 23 the Executive Director of the Oklahoma Arts Council or q. 24 his or her designee,

1 h. the President of the Route 66 Alliance or his or her 2 designee, the President of the Oklahoma Route 66 Association or 3 i. 4 his or her designee, 5 j. the Executive Director of Preservation Oklahoma, Inc., or his or her designee, 6 7 k. the Executive Director of the Oklahoma Museums Association or his or her designee, 8 9 1. the Executive Director of Oklahoma Humanities or his 10 or her designee, 11 the Director of the Oklahoma Municipal League or his m. 12 or her designee, and 13 the President of the Oklahoma State Chamber of n. 14 Commerce or his or her designee. 15 An ex officio member of the Commission vacates the person's position 16 on the Commission if the person ceases to hold the position that 17 qualifies the person for service on the Commission. 18 Β. The Commission shall meet at least quarterly at the times 19 and places in this state that the Commission designates. A majority 20 of the members of the Commission constitutes a quorum for 21 transacting Commission business. Subject to appropriation, the 22 Oklahoma Historical Society shall provide administrative and other 23 support to the Commission. 24 C. The Commission shall:

Plan and sponsor official Route 66 Centennial events,
 programs and activities appropriate to commemorate the Route 66
 Centennial;

2. Encourage the development of programs designed to involve
all citizens in activities that commemorate the Route 66 Centennial
events; and

7 3. Make available to the public, to the best of the
8 Commission's ability, information on Route 66 Centennial events
9 happening throughout the State of Oklahoma.

D. The Commission may accept monetary gifts, grants or appropriations from any public or private source to be held in a nonappropriated revolving fund authorized for the Oklahoma Historical Society and expended solely for the use of the Commission in performing the Commission's powers and duties under this act. The Commission may also accept in-kind gifts.

16 E. Each member of the Commission shall serve without 17 compensation or reimbursement for travel related to Commission 18 duties, aside from the compensation he or she might otherwise 19 receive as authorized by law.

F. The Commission shall be dissolved on June 30, 2027, and any assets remaining in the Commission's trust fund shall be deposited into the state's General Revenue Fund. A final report on the activities of the Oklahoma Route 66 Centennial Commission shall be delivered to the Governor no later than June 30, 2027.
