1 "SECTION 2. SECTION 1. AMENDATORY Section 1, Chapter 210, O.S.L. 2019 (62
2 O.S. Supp. 2019, Section 34.42.1), is amended to read as follows:

3 Section 34.42.1.

4
5 A. Except as provided in subsection C of this section, all
6 agencies and political subdivisions of the state shall make an
7 annual disclosure pursuant to a separate written report and
8 information available through a website maintained by or on behalf
9 of the entity of all federal funds under the control of the entity
10 and the programs for which the federal funds are used by distinct
11 expenditure categories and shall identify the priority or rank of
12 the federal funds in descending order with the funding source the
13 agency or political subdivision relies on to the greatest extent
14 listed first and the funding source the agency or political
15 subdivision relies on to the least extent listed last. The
16 information required by this subsection shall include, but shall
17 not be limited to:

18 1. A description of any action required to be taken by the
19 state government entity or political subdivision as a condition for
20 the receipt or continued receipt of federal funds;

21 2. A description of any action prohibited to be taken by the
22 state government entity or political subdivision as a condition for
23 the receipt or continued receipt of federal funds;

24 3. A description of any action required to be taken by any
25 individual or lawfully recognized business entity or other entity
26 as a condition for the benefits purported to be conferred on the
27 individual or other legal entity as a result of the use of the
28 federal funds; and

29 4. A description of any action prohibited to be taken by any
30 individual or lawfully recognized business entity or other entity
31 as a condition for the benefits purported to be conferred on the
32 individual or other legal entity as a result of the use of the
33 federal funds.

34 B. Every entity subject to the requirements of this section
35 shall make an annual disclosure, either pursuant to a separate
36 written report, information available through a website maintained
37 by or on behalf of the entity or both, of the federal funds for
38 which the agency or political subdivision must incur costs to
39 implement and shall provide such information in descending order
40 with the most costly federal funds listed first and the least
41 costly federal funds listed last.

42 C. Any agency or political subdivision receiving and
43 administering federal funds that require the receiving agency to
44 maintain any level of security clearance in order to administer
45 those funds shall be exempt from the provisions of this section."
