7 An Act relating to appropriations; making an
8 appropriation to the Oklahoma Indigent Defense
9 System; stating purpose; providing lapse dates;
10 requiring and prohibiting certain budget procedures;
11 and providing a contingent effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. There is hereby appropriated to the Oklahoma
14 Indigent Defense System from any monies not otherwise appropriated
15 from the General Revenue Fund of the State Treasury for the fiscal
16 year ending June 30, 2020, the sum of Two Million Dollars
17 (\$2,000,000.00) or so much thereof as may be necessary to implement
18 the provisions of Enrolled Senate Bill No. 252 of the 1st Session of
19 the 57th Oklahoma Legislature.

20 SECTION 2. Appropriations made by this act, not including
21 appropriations made for capital outlay purposes, may be budgeted for
22 the fiscal year ending June 30, 2020 (hereafter FY-20), or may be
23 budgeted for the fiscal year ending June 30, 2021 (hereafter FY-21).
24 Funds budgeted for FY-20 may be encumbered only through June 30,

1 2020, and must be expended by November 15, 2020. Any funds
2 remaining after November 15, 2020, and not budgeted for FY-21, shall
3 lapse to the credit of the proper fund for the then current fiscal
4 year. Funds budgeted for FY-21 may be encumbered only through June
5 30, 2021. Any funds remaining after November 15, 2021, shall lapse
6 to the credit of the proper fund for the then current fiscal year.
7 These appropriations may not be budgeted in both fiscal years
8 simultaneously. Funds budgeted in FY-20 and not required to pay
9 obligations for that fiscal year, may be budgeted for FY-21, after
10 the agency to which the funds have been appropriated has prepared
11 and submitted a budget work program revision removing these funds
12 from the FY-20 budget work program and after such revision has been
13 approved by the Office of Management and Enterprise Services.

14 SECTION 3. The provisions of this act shall not become
15 effective as law unless Enrolled Senate Bill No. 252 of the 1st
16 Session of the 57th Oklahoma Legislature becomes effective as law.
