11	effective date.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 10A O.S. 2011, Section 1-1-105, as
16	last amended by Section 1, Chapter 256, O.S.L. 2018 (10A O.S. Supp.
17	2018, Section 1-1-105), is amended to read as follows:
18	Section 1-1-105. When used in the Oklahoma Children's Code,
19	unless the context otherwise requires:
20	1. "Abandonment" means:
21	a. the willful intent by words, actions, or omissions not
22	to return for a child, or
23	b. the failure to maintain a significant parental
24	relationship with a child through visitation or

communication in which incidental or token visits or communication are not considered significant, or

- c. the failure to respond to notice of deprived proceedings;
- 2. "Abuse" means harm or threatened harm to the health, safety, or welfare of a child by a person responsible for the child's health, safety, or welfare, including but not limited to nonaccidental physical or mental injury, sexual abuse, or sexual exploitation. Provided, however, that nothing contained in the Oklahoma Children's Code shall prohibit any parent from using ordinary force as a means of discipline including, but not limited to, spanking, switching, or paddling.
 - a. "Harm or threatened harm to the health or safety of a child" means any real or threatened physical, mental, or emotional injury or damage to the body or mind that is not accidental including but not limited to sexual abuse, sexual exploitation, neglect, or dependency.
 - b. "Sexual abuse" includes but is not limited to rape, incest, and lewd or indecent acts or proposals made to a child, as defined by law, by a person responsible for the health, safety, or welfare of the child.
 - c. "Sexual exploitation" includes but is not limited to allowing, permitting, encouraging, or forcing a child to engage in prostitution, as defined by law, by any

person eighteen (18) years of age or older or by a person responsible for the health, safety, or welfare of a child, or allowing, permitting, encouraging, or engaging in the lewd, obscene, or pornographic, as defined by law, photographing, filming, or depicting of a child in those acts by a person responsible for the health, safety, and welfare of the child;

- 3. "Adjudication" means a finding by the court that the allegations in a petition alleging that a child is deprived are supported by a preponderance of the evidence;
- 4. "Adjudicatory hearing" means a hearing by the court as provided by Section 1-4-601 of this title;
 - 5. "Age-appropriate or developmentally appropriate" means:
 - a. activities or items that are generally accepted as suitable for children of the same age or level of maturity or that are determined to be developmentally appropriate for a child, based on the development of cognitive, emotional, physical, and behavioral capacities that are typical for an age or age group, and
 - b. in the case of a specific child, activities or items that are suitable for that child based on the developmental stages attained by the child with

respect to the cognitive, emotional, physical, and behavioral capacities of the specific child.

In the event that any age-related activities have implications relative to the academic curriculum of a child, nothing in this paragraph shall be construed to authorize an officer or employee of the federal government to mandate, direct, or control a state or local educational agency, or the specific instructional content, academic achievement standards and assessments, curriculum, or program of instruction of a school;

- 6. "Assessment" means a comprehensive review of child safety and evaluation of family functioning and protective capacities that is conducted in response to a child abuse or neglect referral that does not allege a serious and immediate safety threat to a child;
- 7. "Behavioral health" means mental health, substance abuse, or co-occurring mental health and substance abuse diagnoses, and the continuum of mental health, substance abuse, or co-occurring mental health and substance abuse treatment;
- 8. "Child" means any unmarried person under eighteen (18) years of age;
- 9. "Child advocacy center" means a center and the multidisciplinary child abuse team of which it is a member that is accredited by the National Children's Alliance or that is completing a sixth year of reaccreditation. Child advocacy centers shall be

classified, based on the child population of a district attorney's district, as follows:

- a. nonurban centers in districts with child populations that are less than sixty thousand (60,000), and
- b. midlevel nonurban centers in districts with child populations equal to or greater than sixty thousand (60,000), but not including Oklahoma and Tulsa counties;
- 10. "Child with a disability" means any child who has a physical or mental impairment which substantially limits one or more of the major life activities of the child, or who is regarded as having such an impairment by a competent medical professional;
- 11. "Child-placing agency" means an agency that arranges for or places a child in a foster family home, group home, adoptive home, or a successful adulthood program;
- 12. "Children's emergency resource center" means a community-based program that may provide emergency care and a safe and structured homelike environment or a host home for children providing food, clothing, shelter and hygiene products to each child served; after-school tutoring; counseling services; life-skills training; transition services; assessments; family reunification; respite care; transportation to or from school, doctors' appointments, visitations and other social, school, court or other activities when necessary; and a stable environment for children in

- crisis who are in custody of the Department of Human Services if

 permitted under the Department's policies and regulations, or who

 have been voluntarily placed by a parent or custodian during a

 temporary crisis;
- 5 "Community-based services" or "community-based programs" means services or programs which maintain community participation or 6 supervision in their planning, operation, and evaluation. 7 Community-based services and programs may include, but are not 9 limited to, emergency shelter, crisis intervention, group work, case 10 supervision, job placement, recruitment and training of volunteers, consultation, medical, educational, home-based services, vocational, 11 12 social, preventive and psychological guidance, training, counseling, early intervention and diversionary substance abuse treatment, 13 sexual abuse treatment, transitional living, independent living, and 14 15 other related services and programs;
 - 14. "Concurrent permanency planning" means, when indicated, the implementation of two plans for a child entering foster care. One plan focuses on reuniting the parent and child; the other seeks to find a permanent out-of-home placement for the child with both plans being pursued simultaneously;
 - 15. "Court-appointed special advocate" or "CASA" means a responsible adult volunteer who has been trained and is supervised by a court-appointed special advocate program recognized by the

court, and when appointed by the court, serves as an officer of the court in the capacity as a guardian ad litem;

- 16. "Court-appointed special advocate program" means an organized program, administered by either an independent, not-for-profit corporation, a dependent project of an independent, not-for-profit corporation or a unit of local government, which recruits, screens, trains, assigns, supervises and supports volunteers to be available for appointment by the court as guardians ad litem;
- 17. "Custodian" means an individual other than a parent, legal guardian or Indian custodian, to whom legal custody of the child has been awarded by the court. As used in this title, the term "custodian" shall not mean the Department of Human Services;
- 18. "Day treatment" means a nonresidential program which provides intensive services to a child who resides in the child's own home, the home of a relative, group home, a foster home or residential child care facility. Day treatment programs include, but are not limited to, educational services;
 - 19. "Department" means the Department of Human Services;
- 20. "Dependency" means a child who is homeless or without proper care or guardianship through no fault of his or her parent, legal guardian, or custodian;
 - 21. "Deprived child" means a child:
 - a. who is for any reason destitute, homeless, or abandoned,

1 b. who does not have the proper parental care or 2 quardianship, who has been abused, neglected, or is dependent, 3 C. whose home is an unfit place for the child by reason 4 d. 5 of depravity on the part of the parent or legal quardian of the child, or other person responsible for 6 the health or welfare of the child, 7 who is a child in need of special care and treatment 9 because of the child's physical or mental condition, 10 and the child's parents, legal guardian, or other custodian is unable or willfully fails to provide such 11 12 special care and treatment. As used in this 13 paragraph, a child in need of special care and treatment includes, but is not limited to, a child who 14 at birth tests positive for alcohol or a controlled 15 dangerous substance and who, pursuant to a drug or 16 alcohol screen of the child and an assessment of the 17 parent, is determined to be at risk of harm or 18 threatened harm to the health or safety of a child, 19 f. who is a child with a disability deprived of the 20 nutrition necessary to sustain life or of the medical 21 treatment necessary to remedy or relieve a life-22

threatening medical condition in order to cause or

allow the death of the child if such nutrition or

medical treatment is generally provided to similarly situated children without a disability or children with disabilities; provided that no medical treatment shall be necessary if, in the reasonable medical judgment of the attending physician, such treatment would be futile in saving the life of the child,

- g. who, due to improper parental care and guardianship, is absent from school as specified in Section 10-106 of Title 70 of the Oklahoma Statutes, if the child is subject to compulsory school attendance,
- h. whose parent, legal guardian or custodian for good cause desires to be relieved of custody,
- i. who has been born to a parent whose parental rights to another child have been involuntarily terminated by the court and the conditions which led to the making of the finding, which resulted in the termination of the parental rights of the parent to the other child, have not been corrected, or
- j. whose parent, legal guardian, or custodian has subjected another child to abuse or neglect or has allowed another child to be subjected to abuse or neglect and is currently a respondent in a deprived proceeding.

Nothing in the Oklahoma Children's Code shall be construed to mean a child is deprived for the sole reason the parent, legal guardian, or person having custody or control of a child, in good faith, selects and depends upon spiritual means alone through prayer, in accordance with the tenets and practice of a recognized church or religious denomination, for the treatment or cure of disease or remedial care of such child.

Nothing contained in this paragraph shall prevent a court from immediately assuming custody of a child and ordering whatever action may be necessary, including medical treatment, to protect the child's health or welfare;

- 22. "Dispositional hearing" means a hearing by the court as provided by Section 1-4-706 of this title;
- 23. "Drug-endangered child" means a child who is at risk of suffering physical, psychological or sexual harm as a result of the use, possession, distribution, manufacture or cultivation of controlled substances, or the attempt of any of these acts, by a person responsible for the health, safety or welfare of the child, as defined in this section. This term includes circumstances wherein the substance abuse of the person responsible for the health, safety or welfare of the child interferes with that person's ability to parent and provide a safe and nurturing environment for the child;

1 24. "Emergency custody" means the custody of a child prior to adjudication of the child following issuance of an order of the district court pursuant to Section 1-4-201 of this title or following issuance of an order of the district court pursuant to an emergency custody hearing, as specified by Section 1-4-203 of this title;

- "Facility" means a place, an institution, a building or part thereof, a set of buildings, or an area whether or not enclosing a building or set of buildings used for the lawful custody and treatment of children;
- "Failure to protect" means failure to take reasonable action to remedy or prevent child abuse or neglect, and includes the conduct of a non-abusing parent or guardian who knows the identity of the abuser or the person neglecting the child, but lies, conceals or fails to report the child abuse or neglect or otherwise take reasonable action to end the abuse or neglect;
- 27. "Foster care" or "foster care services" means continuous twenty-four-hour care and supportive services provided for a child in foster placement including, but not limited to, the care, supervision, guidance, and rearing of a foster child by the foster parent;
- "Foster family home" means the private residence of a foster parent who provides foster care services to a child. Such term shall include a nonkinship foster family home, a therapeutic

1 | foster family home, or the home of a relative or other kinship care 2 | home;

- 29. "Foster parent eligibility assessment" includes a criminal background investigation including, but not limited to, a national criminal history records search based upon the submission of fingerprints, home assessments, and any other assessment required by the Department of Human Services, the Office of Juvenile Affairs, or any child-placing agency pursuant to the provisions of the Oklahoma Child Care Facilities Licensing Act;
 - 30. "Guardian ad litem" means a person appointed by the court pursuant to the provisions of Section 1-4-306 of this title having those duties and responsibilities as set forth in that section. The term "guardian ad litem" shall refer to a court-appointed special advocate as well as to any other person appointed pursuant to the provisions of Section 1-4-306 of this title to serve as a guardian ad litem;
 - 31. "Guardian ad litem of the estate of the child" means a person appointed by the court to protect the property interests of a child pursuant to Section 1-8-108 of this title;
 - 32. "Group home" means a residential facility licensed by the Department to provide full-time care and community-based services for more than five but fewer than thirteen children;
- 23 33. "Harm or threatened harm to the health or safety of a child" means any real or threatened physical, mental, or emotional

1 injury or damage to the body or mind that is not accidental including, but not limited to, sexual abuse, sexual exploitation, 2 3 neglect, or dependency; 34. "Heinous and shocking abuse" includes, but is not limited 4 5 to, aggravated physical abuse that results in serious bodily, mental, or emotional injury. "Serious bodily injury" means injury 6 that involves: 7 a substantial risk of death, 8 9 b. extreme physical pain, protracted disfigurement, 10 C. 11 d. a loss or impairment of the function of a body member, 12 organ, or mental faculty, an injury to an internal or external organ or the 13 е. body, 14 15 f. a bone fracture, sexual abuse or sexual exploitation, 16 q. chronic abuse including, but not limited to, physical, 17 h. emotional, or sexual abuse, or sexual exploitation 18 which is repeated or continuing, 19 i. torture that includes, but is not limited to, 20 inflicting, participating in or assisting in 21 inflicting intense physical or emotional pain upon a 22 child repeatedly over a period of time for the purpose 23

This standard shall be used by the child's caregiver when determining whether to allow a child to participate in extracurricular, enrichment, cultural, and social activities. For purposes of this definition, the term "caregiver" means a foster parent with whom a child in foster care has been placed, a representative of a group home where a child has been placed or a designated official for a residential child care facility where a child in foster care has been placed;
- 57. 58. "Relative" means a grandparent, great-grandparent, brother or sister of whole or half blood, aunt, uncle or any other person related to the child;
- 58. 59. "Residential child care facility" means a twenty-four-hour residential facility where children live together with or are supervised by adults who are not their parents or relatives;
- $59. \underline{60.}$ "Review hearing" means a hearing by the court pursuant to Section 1-4-807 of this title;

60. 61. "Risk" means the likelihood that an incident of child abuse or neglect will occur in the future;

- 61. 62. "Safety threat" means the threat of serious harm due to child abuse or neglect occurring in the present or in the very near future and without the intervention of another person, a child would likely or in all probability sustain severe or permanent disability or injury, illness, or death;
- 62. 63. "Safety analysis" means action taken by the Department in response to a report of alleged child abuse or neglect that may include an assessment or investigation based upon an analysis of the information received according to priority guidelines and other criteria adopted by the Department;
- 63. 64. "Safety evaluation" means evaluation of a child's situation by the Department using a structured, evidence-based tool to determine if the child is subject to a safety threat;
- 64. 65. "Secure facility" means a facility which is designed and operated to ensure that all entrances and exits from the facility are subject to the exclusive control of the staff of the facility, whether or not the juvenile being detained has freedom of movement within the perimeter of the facility, or a facility which relies on locked rooms and buildings, fences, or physical restraint in order to control behavior of its residents;
- 65. 66. "Sibling" means a biologically or legally related brother or sister of a child. This includes an individual who

1 satisfies at least one of the following conditions with respect to a 2 child:

- a. the individual is considered by state law to be a sibling of the child, or
- b. the individual would have been considered a sibling under state law but for a termination or other disruption of parental rights, such as the death of a parent;
- 66. 67. "Specialized foster care" means foster care provided to a child in a foster home or agency-contracted home which:
 - a. has been certified by the Developmental Disabilities

 Services Division of the Department of Human Services,
 - b. is monitored by the Division, and
 - c. is funded through the Home- and Community-Based Waiver
 Services Program administered by the Division;
- 67. 68. "Successful adulthood program" means a program specifically designed to assist a child to enhance those skills and abilities necessary for successful adult living. A successful adulthood program may include, but shall not be limited to, such features as minimal direct staff supervision, and the provision of supportive services to assist children with activities necessary for finding an appropriate place of residence, completing an education or vocational training, obtaining employment, or obtaining other similar services;
