The measure proposes to amend 68 O.S. § 1356 by exempting from the sales tax levy, sales of tangible personal property or services to an organization which is the flagship program of an 501(c)(3) organization which provides support to veterans, active duty members of the Armed Forces, reservists and members of the National Guard to assist with the transition to civilian life and is known as the Coffee Bunker.

Information obtained from the Organization indicates total taxable expenditures in the amount of \$61,457 for FY 18. Applying the state sales tax rate of 4.5% yields a decrease in state sales tax collections of \$2,766.

Application of inflation rate adjustments of $2.3\%^{1}$ results in an estimated decrease in state sales tax collections of \$2,895 for FY 20.
