11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. AMENDATORY 59 O.S. 2011, Section 1354, as  
13 amended by Section 1, Chapter 345, O.S.L. 2013 (59 O.S. Supp. 2018,  
14 Section 1354), is amended to read as follows:

15 Section 1354. There is hereby re-created, to continue until  
16 July 1, ~~2019~~ 2020, pursuant to the provisions of the Oklahoma Sunset  
17 Law, the State Board of Examiners of Psychologists. The Board shall  
18 administer the provisions of the Psychologists Licensing Act. The  
19 Board shall consist of seven (7) members appointed by the Governor.  
20 Five members shall be psychologists from various areas in psychology  
21 and two members shall be lay persons. At the expiration of the term  
22 of each Board member who is a psychologist, the Governor shall  
23 appoint a successor from a list of ten licensed psychologists which  
24 is provided by the Oklahoma State Psychological Association.

1 Members shall serve for a term of four (4) years and until a  
2 successor is appointed and qualified. Before entering upon the  
3 duties of office, each member of the Board shall take the  
4 constitutional oath of office and file it with the Secretary of  
5 State.
