21	SECTION 1. AMENDATORY 68 O.S. 2011, Section 4301, as		
22	last amended by Section 1, Chapter 201, O.S.L. 2018 (68 O.S. Supp.		
23	2020, Section 4301), is amended to read as follows:

1 Section 4301. This act shall be known and may be cited as the 2 "Oklahoma Quality Events Incentive Act" and shall be in effect through June 30, <del>2021</del> 2026. 3 SECTION 2. AMENDATORY 68 O.S. 2011, Section 4303, as 4 5 last amended by Section 2, Chapter 201, O.S.L. 2018 (68 O.S. Supp. 2020, Section 4303), is amended to read as follows: 6 7 Section 4303. As used in the Oklahoma Quality Events Incentive Act: 8 9 1. "Certified sponsor" means an entity or organization authorized to promote and conduct a quality event, which is 10 11 incurring expenses for the promotion of such event to be conducted 12 within the corporate limits of an eligible municipality or an unincorporated area within a county; 13 14 "Economic impact study" means a study which includes: 2. 15 a description and, if applicable, history of the a. 16 quality event, 17 information regarding the site selection process for b. 18 the quality event, 19 an estimate of the expenses anticipated to be incurred с. 20 in connection with hosting the quality event, and 21 an estimate of the total gross sales made by vendors d. 22 during any period of time during which no quality 23 event activity occurs, 24

10 additional state sales tax revenue collected as a result of the
11 quality event, as determined by <u>an economic impact study verified by</u>
12 the Oklahoma Tax Commission <del>based on actual documentation</del>;

13 <u>6.</u> <u>7.</u> "New event" means a quality event which did not occur 14 within a period of twenty-four (24) months prior to the month during 15 which a quality event is held;

a. a new event or a meeting of a nationally recognized
organization or its members,

international or world championship, or

c. a new or existing event that is managed or produced by
 an Oklahoma-based national or international

1 <u>8. 9.</u> "Recurring event" means a quality event which occurred at 2 least once within the twenty-four (24) months prior to the month 3 during which a quality event is held;

9. 10. "State sales tax revenue" means the proceeds from the
state sales tax levy imposed pursuant to Section 1354 of this title
upon taxable transactions occurring as a result of the quality
event, as determined by <u>an economic impact study verified by</u> the
Oklahoma Tax Commission based on actual documentation; and

9 10. <u>11.</u> "Vendors" means those persons or business entities
10 making taxable sales of tangible personal property or services as a
11 result of the quality event, as determined by <u>an economic impact</u>
12 <u>study verified by</u> the Oklahoma Tax Commission <del>based on actual</del>
13 documentation and, unless the context otherwise requires, shall have
14 the same meaning as defined by Section 1352 of this title.

SECTION 3. AMENDATORY 68 O.S. 2011, Section 4304, as last amended by Section 3, Chapter 201, O.S.L. 2018 (68 O.S. Supp. 2020, Section 4304), is amended to read as follows:

Section 4304. A. Not later than six (6) months thirty (30) days prior to the initial date of a quality event, a host community may designate:

The dates during which a quality event will be hosted; and
 The type of expenses eligible for distribution of captured
 revenues to the host community including, but not limited to,
 advertising, facility rental, promotional materials and security.

B. Any designation made by a host community for purposes of the
 Oklahoma Quality Events Incentive Act shall be made pursuant to an
 ordinance or resolution duly adopted by the governing body of the
 host community.

5 C. A host community may only designate one quality event during6 the time frame in which a designated quality event will occur.

7 Within thirty (30) sixty (60) days of the date on which the D. host community adopts an ordinance or resolution pursuant to 8 9 subsection A of this section, such host community shall submit to 10 the Oklahoma Tax Commission, on such forms as the Tax Commission may 11 prescribe, a copy of such ordinance or resolution, an economic 12 impact study and the event history. The Oklahoma Tax Commission 13 shall designate a single employee or division responsible for 14 processing information, making determinations and any other duties 15 related to the Oklahoma Quality Events Incentive Act.

E. Within sixty (60) days from the date of receipt of the information from the host community as required by subsection D of this section, the Tax Commission shall approve or disapprove, in whole or in part, the submission and analysis of the required information. The Oklahoma Department of Commerce and the Oklahoma Tourism and Recreation Department shall provide such assistance and information as requested by the Tax Commission.

1 SECTION 4. AMENDATORY 68 O.S. 2011, Section 4305, as 2 last amended by Section 4, Chapter 201, O.S.L. 2018 (68 O.S. Supp. 2020, Section 4305), is amended to read as follows: 3 4 Section 4305. A. The host community shall provide to the 5 Oklahoma Tax Commission detailed information disclosing the total amount of eligible local support amounts for purposes of determining 6 7 the amount of incremental state sales tax revenue that may be paid to a host community in which a quality event occurs. 8

9 B. The Tax Commission shall verify the amount of eligible local10 support amounts prior to making any payment to a host community.

11 C. After the conclusion of an event, the host community shall 12 provide information related to the event, such as attendance 13 figures, financial information or other public information held by 14 the host community that the Tax Commission considers necessary to 15 evaluate the actual economic impact of the event.

D. The Tax Commission shall compare the total amount of eligible local support amounts with the total amount of incremental state sales tax revenues remitted by vendors, such revenues to be established based on actual documentation through the economic impact study.

E. If the Tax Commission determines through an analysis of the actual documentation <u>economic impact study</u> that the total amount of incremental state sales tax revenues is zero, no payment shall be made to a host community.

1 F. If the Tax Commission determines through an analysis of the 2 actual documentation economic impact study that the total amount of incremental state sales tax revenues is greater than zero, but less 3 4 than the total amount of eligible local support amounts, the Tax 5 Commission shall make payment, subject to the limitations of subsection I of this section, to the host community of the quality 6 7 event in an amount equal to the incremental state sales tax revenues. 8

9 G. If the Tax Commission determines through an analysis of the 10 actual documentation <u>economic impact study</u> that the total amount of 11 incremental state sales tax revenues is at least equal to the amount 12 of eligible local support amounts, the Tax Commission shall make 13 payment, subject to the limitations of subsection I of this section, 14 to the host community in which the quality event occurs in an amount 15 equal to, but not greater than, the eligible local support amounts.

H. No payment shall be made to any host community from a source other than the incremental state sales tax revenues, if any, derived from state sales tax remittances of vendors as a result of the quality event, as determined by <u>an economic impact study verified by</u> the Oklahoma Tax Commission.

I. No payment shall be made to any host community in excess of Wo Hundred Fifty Thousand Dollars (\$250,000.00) for a single quality event regardless of the amount of eligible local support paid by the host community.
