L 9	Section 122. A. This article shall not apply to lands now

or equivalent controlling equity interest of which is owned by one or more bona fide resident aliens, shall have the right to acquire and hold lands in this state upon the same terms as citizens of the State of Oklahoma during the continuance of such bona fide residence of such alien or aliens in this state as long as such alien, with respect to one natural person, is not a citizen, or with respect to two or more aliens, are not citizens of a country that prohibits real property ownership by citizens of the United States in that country: Provided; provided, that if any such resident alien or aliens shall cease to be a bona fide inhabitant of this state, such alien or business entity the controlling equity interest of which is owned by one or more aliens shall have five (5) years from the time he the alien, if the ownership of the property is by one natural person, or aliens, with respect to a business entity the controlling equity interest of which is owned by one or more aliens, ceased to be such a bona fide resident in which to alienate such lands.

B. The provisions of this section shall not be applicable to persons who become a citizen of the United States as authorized by law or to a business entity the controlling equity interest of which is owned by a person or persons who became a citizen of the United States as authorized by law.
