15	SECTION 1. AMENDATORY 43A O.S. 2021, Section 2-111, is	
16	amended to read as follows:	
17	Section 2-111. A. 1. The Board of Mental Health and Substance	
18	Abuse Services is hereby authorized and directed to create a trust	
19	into which all real property held by or for the benefit of the	
20	Department of Mental Health and Substance Abuse Services shall be	
21	transferred.	
22	2. The trust shall provide that:	
23	a. the property placed into the trust may never be sold,	
24	except for the tracts specifically described in	

subparagraph c of this paragraph, if it is determined by the trustees for the Department's Real Property Trust and by the Department that such a sale is in the best interests of the Department, and then the proceeds shall be used exclusively for tangible infrastructure improvements that benefit the persons served by the Department, otherwise the property shall be held in perpetuity for the sole benefit of the Department,

- b. the property held by the trust which is not needed for
 use by the Department may be leased or rented to
 others and all income received from such leases or
 rentals shall be payable to the Department for use by
 the Department to fulfill the purposes of the
 Department, except as provided in subparagraph d of
 this section,
- c. the following tract or tracts of land may be sold as
 set forth in subparagraph a of this paragraph:
- 19 (1) Land owned by the Department located in Sections
 20 20 and 29, Township 9 North, Range 2 West,
 21 Cleveland County, Oklahoma,
- (2) Land owned by the Department located in Block 5
 of Culbertson Heights Addition to the City of
 Oklahoma City, Oklahoma County, Oklahoma, and

14 Upon the creation of the trust authorized in subsection A of Β. 15 this section, the Office of Management and Enterprise Services is 16 directed to provide all necessary assistance to the Department of 17 Mental Health and Substance Abuse Services to identify and transfer 18 all property held by or for the benefit of the Department of Mental 19 Health and Substance Abuse Services to the trust. Except as 20 provided in subsection C of this section, the Office of Management 21 and Enterprise Services is authorized and directed to provide all 22 requested assistance to the Department of Mental Health and 23 Substance Abuse Services in leasing property placed in such trust.
