17	SECTION 1. AMENDATORY 47 O.S. 2021, Section 1132A, is
18	amended to read as follows:
19	Section 1132A. A. In any online system which provides a
20	service that a motor license agent is authorized to provide pursuant
21	to the Oklahoma Vehicle License and Registration Act there shall
22	include a step where the individual shall select a motor license
23	agent in the state to process any online transaction.

Said <u>The</u> motor license agent, as defined in Section 1102 of this
 title, does not include the Oklahoma Tax Commission. Any motor
 license agent fees collected by a state agency shall be deposited
 into the General Revenue Fund.

5 B. Motor Upon the effective date of this act through May 31, 6 <u>2023, motor</u> license agents selected as provided in subsection A of 7 this section shall receive all fees provided by the Oklahoma Vehicle 8 License and Registration Act; provided, the amount of fees remitted 9 to the motor license agent for each online transaction processed by 10 the motor license agent through any online system shall be reduced 11 by One Dollar and fifty-six cents (\$1.56).

C. The selection step required pursuant to subsection A of this section shall be installed and operational no later than January 1, 2021.

SECTION 2. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
