11	An Act relating to the Oklahoma Department of Agriculture, Food, and Forestry; requiring that
12	portions of certain appropriated funds be used for certain purposes; providing procedures; providing
13	lapse dates; and requiring and prohibiting certain budget procedures.

16	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
17	SECTION 1. From the funds appropriated to the Oklahoma
18	Department of Agriculture, Food, and Forestry in Enrolled Senate
19	Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature,
20	the sum of Four Million Dollars (\$4,000,000.00) shall, under the
21	direction of the Commissioner of Agriculture, be allocated to the
22	Oklahoma State University College of Veterinary Medicine.
23	SECTION 2. From the funds appropriated to the Oklahoma
24	Department of Agriculture, Food, and Forestry in Enrolled Senate

Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature,
the sum of One Million Five Hundred Thousand Dollars (\$1,500,000.00)
shall, under the direction of the Commissioner of Agriculture, be
allocated to the Oklahoma State University College of Veterinary
Medicine Animal Disease Diagnostic Laboratory.

6 SECTION 3. From the funds appropriated to the Oklahoma 7 Department of Agriculture, Food, and Forestry in Enrolled Senate 8 Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature, 9 the sum of One Million Dollars (\$1,000,000.00) shall, under the 10 direction of the Commissioner of Agriculture, be allocated to the 11 research centers that are affiliated with the Oklahoma State 12 University Agriculture Experiment Stations.

SECTION 4. From the funds appropriated to the Oklahoma Department of Agriculture, Food, and Forestry in Enrolled Senate Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Two Million Dollars (\$2,000,000.00) shall, under the direction of the Commissioner of Agriculture, be allocated to the extension offices that are affiliated with the Oklahoma State University Agricultural Extension Service.

20 SECTION 5. From the funds appropriated to the Oklahoma 21 Department of Agriculture, Food, and Forestry in Enrolled Senate 22 Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature, 23 the sum of Eight Million Four Hundred Fourteen Thousand Five Hundred

Fifty Dollars (\$8,414,550.00) shall be used to provide for rural
 fire operational assistance grants.

3 SECTION 6. From the funds appropriated to the Oklahoma
4 Department of Agriculture, Food, and Forestry in Enrolled Senate
5 Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature,
6 the sum of Two Million Dollars (\$2,000,000.00) shall be used to
7 provide for the Rural Fire 80/20 Match Program pursuant to the Rural
8 Fire Protection Program Fund Act.

9 SECTION 7. From the funds appropriated to the Oklahoma
10 Department of Agriculture, Food, and Forestry in Enrolled Senate
11 Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature,
12 the sum of Eight Hundred Thousand Dollars (\$800,000.00) shall be
13 used to provide for rural fire coordinators.

SECTION 8. From the funds appropriated to the Oklahoma Department of Agriculture, Food, and Forestry in Enrolled Senate Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Three Hundred Thirty Thousand Dollars (\$330,000.00) shall, under the direction of the Commissioner of Agriculture, be allocated to hire additional full-time meat inspectors.

20 SECTION 9. From the funds appropriated to the Oklahoma 21 Department of Agriculture, Food, and Forestry in Enrolled Senate 22 Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature, 23 the sum of Five Hundred Thirteen Thousand Three Hundred Twenty-five

Dollars (\$513,325.00) shall be used for the purpose of supporting
 the "Made in Oklahoma" program.

SECTION 10. From the funds appropriated to the Oklahoma 3 Department of Agriculture, Food, and Forestry in Enrolled Senate 4 5 Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Five Million Dollars (\$5,000,000.00) shall be used for 6 providing grants to incorporated municipalities affected by the 7 extreme weather event that began February 7, 2021, and ended 8 9 February 21, 2021, as provided for in Enrolled Senate Bill No. 1091 of the 2nd Session of the 58th Oklahoma Legislature. 10

SECTION 11. Appropriations made by Enrolled Senate Bill No. 11 1040 of the 2nd Session of the 58th Oklahoma Legislature, not 12 including appropriations made for capital outlay purposes, may be 13 budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23) 14 or may be budgeted for the fiscal year ending June 30, 2024 15 (hereafter FY-24). Funds budgeted for FY-23 may be encumbered only 16 through June 30, 2023, and must be expended by November 15, 2023. 17 Any funds remaining after November 15, 2023, and not budgeted for 18 FY-24, shall lapse to the credit of the proper fund for the then 19 current fiscal year. Funds budgeted for FY-24 may be encumbered 20 only through June 30, 2024. Any funds remaining after November 15, 21 2024, shall lapse to the credit of the proper fund for the then 22 current fiscal year. These appropriations may not be budgeted in 23 both fiscal years simultaneously. Funds budgeted in FY-23, and not 24

2	for FY-24, after the agency to which the funds have been
3	appropriated has prepared and submitted a budget work program
4	revision removing these funds from the FY-23 budget work program and
