of the Department; modifying name of certain  
facility; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 43A O.S. 2021, Section 3-101, is

14

amended to read as follows:

Section 3-101. The facilities within the Department of Mental

16

Health and Substance Abuse Services, which may be maintained for

17

residents of the state, are:

1. Griffin Memorial Hospital, Norman;

19

2. Oklahoma Forensic Center, Vinita;

3. Children's Recovery Center of Oklahoma, Norman;

21

4. Tulsa Center for Behavioral Health, Tulsa;

5. Carl Albert Community Mental Health and Substance Abuse

Services Center, McAlester;

1           6. Jim Taliaferro Community Mental Health and Substance Abuse  
2 Services Center, Lawton;

3           7. Central Oklahoma Community Mental Health and Substance Abuse  
4 Services Center, Norman;

5           8. Northwest Center for Behavioral Health, Woodward;

6           9. Oklahoma County Crisis Intervention Center, Oklahoma City;

7           10. Oklahoma Crisis Recovery Unit, Oklahoma City; and

8           11. ~~Rose Rock Recovery Center~~ Transitions Recovery Center,  
9 Vinita.

10           SECTION 2.           AMENDATORY           43A O.S. 2021, Section 3-107, is  
11 amended to read as follows:

12           Section 3-107. A. There is hereby created and designated as a  
13 facility within the Department of Mental Health and Substance Abuse  
14 Services ~~the Rose Rock Recovery Center~~ Transitions Recovery Center  
15 at Vinita. The facility shall be operated under the supervision and  
16 administration of the Commissioner of Mental Health and Substance  
17 Abuse Services. It is the intent of the Legislature that ~~the Rose~~  
18 ~~Rock Recovery Center~~ Transitions Recovery Center at Vinita utilize  
19 and receive business management, support services and medical  
20 ancillary services of the Oklahoma Forensic Center.

21           B. There is hereby created a petty cash fund for ~~the Rose Rock~~  
22 ~~Recovery Center~~ Transitions Recovery Center at Vinita. The Director  
23 of the Office of Management and Enterprise Services and the  
24 Commissioner of Mental Health and Substance Abuse Services are

1 authorized to fix the maximum amount of the petty cash fund. The  
2 Director of the Office of Management and Enterprise Services shall  
3 prescribe the rules and procedures for the administration of the  
4 petty cash fund.

5 C. The Department of Mental Health and Substance Abuse Services  
6 is authorized to effect the transfer of property, records,  
7 equipment, supplies, funds and encumbrances from the Oklahoma  
8 Forensic Center to or from ~~the Rose Rock Recovery Center~~ Transitions  
9 Recovery Center at Vinita.

10 SECTION 3. It being immediately necessary for the preservation  
11 of the public peace, health or safety, an emergency is hereby  
12 declared to exist, by reason whereof this act shall take effect and  
13 be in full force from and after its passage and approval.
