11	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
12	SECTION 1. NEW LAW A new section of law to be codified
13	in the Oklahoma Statutes as Section 510.3 of Title 70, unless there
14	is created a duplication in numbering, reads as follows:
15	A. As used in this section, "military-connected student" means
16	a student enrolled in a public school who is a dependent of a
17	current or former member of:
18	1. The United States military;
19	2. The Oklahoma National Guard; or
20	3. A reserve force of the United States military.
21	B. Beginning with the 2022-2023 school year, the State
22	Department of Education shall designate a school district campus as
23	a Purple Star Campus if the campus applies and qualifies for the
24	designation pursuant to this section.

- C. To qualify as a Purple Star Campus, a school district or individual campus shall:
- 1. Designate a school employee as a military liaison whose duties include:
  - a. identifying military-connected students enrolled at the campus,
  - b. serving as the point of contact between the campus and military-connected students and their families,
  - c. determining appropriate campus services available to military-connected students, and
  - d. assisting in coordinating campus programs relevant to military-connected students;
- 2. Maintain on the campus website an easily accessible web page that includes resources for military-connected students and their families including information regarding:
  - a. relocation to, enrollment at, registration at and transferring records to the campus,
  - b. academic planning, course sequences and advanced classes available at the campus,
  - c. counseling and other support services available for military-connected students enrolled at the campus, and
  - d. the military liaison and his or her duties designated pursuant to paragraph 1 of this subsection;

Maintain a transition program led by students, where 1 2 appropriate, that assists military-connected students in 3 transitioning into the campus; Offer professional development for school employees on 4. 4 5 issues related to military-connected students; and 6 5. Offer at least one of the following initiatives: 7 a resolution showing support for military-connected a. students and their families, 8 9 b. recognition of the Month of the Military Child or 10 Military Family Month with relevant events hosted by 11 the campus, or a partnership with a local military installation that 12 C. 13 provides opportunities for active duty military members to volunteer at the campus, speak at an 14 assembly or host a field trip. 15 The State Board of Education shall promulgate rules to 16 D. implement the provisions of this section. 17 SECTION 2.
