11	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
12	SECTION 1. AMENDATORY Section 3, Chapter 252, O.S.L.
13	2018 (63 O.S. Supp. 2020, Section 2-1002), is amended to read as
14	follows:
15	Section 2-1002. A. The Opioid Overdose Fatality Review Board
16	shall be composed of twenty (20) <u>twenty-two (22)</u> members, or their
17	designees, as follows:
18	1. Ten Twelve of the members shall be:
19	a. the Attorney General or designee,
20	b. the Chief Medical Examiner or designee,
21	c. the State Commissioner of Health or designee,
22	d. the Chief of Injury Prevention Services of the State
23	Department of Health or designee,

1 the President of the Oklahoma State Medical Association or designee, 2 the Director of the Oklahoma Bureau of Narcotics and 3 f. Dangerous Drugs Control or designee, 4 5 g. the Commissioner of the Department of Mental Health and Substance Abuse Services or designee, 6 7 h. the President of the Oklahoma Osteopathic Association or designee, 8 9 i. the Director of the Department of Human Services or 10 designee, and the Director of the Oklahoma State Bureau of 11 j. 12 Investigation or designee; and, 13 the President of the Association of Oklahoma Narcotic k. Enforcers or designee, and 14 15 the Executive Director of the State Board of Pharmacy 1. 16 or designee; and Ten of the members shall be appointed by the Attorney 17 General, shall serve for terms of two (2) years and shall be 18 eligible for reappointment. The members shall be persons having 19 20 training and experience in matters related to opioid abuse and prevention. The appointed members shall include: 21 a county sheriff selected from a list of three names 22 a. submitted by the executive board of the Oklahoma 23

Sheriffs' Association,

1 b. a chief of a municipal police department selected from a list of three names submitted by the Oklahoma 2 Association of Chiefs of Police, 3 an attorney licensed in this state who is in private 4 C. 5 practice selected from a list of three names submitted by the Board of Governors of the Oklahoma Bar 6 Association, 7 d. a district attorney selected from a list of three 8 9 names submitted by the District Attorneys Council, a physician with emergency medical training selected 10 е. from a list of three names submitted by the Oklahoma 11 12 State Medical Association, f. a physician with experience in drug addiction 13 treatment and recovery selected from a list of three 14 names submitted by the Oklahoma Osteopathic 15 16 Association, a nurse selected from a list of three names submitted 17 q. by the Oklahoma Nurses Association, 18 two individuals, at least one of whom shall be a 19 h. person who currently receives or formerly has been a 20 consumer of addiction recovery services related to 21 opioid use, selected from a list of three names 22

submitted by the Oklahoma Department of Mental Health

and Substance Abuse Services, and

- i. a member of the judiciary selected from a list of three names submitted by the Oklahoma Supreme Court.
- B. Every two (2) years the Board shall elect from among its membership a chair and a vice-chair. The Board shall meet at least quarterly and may meet more frequently as necessary as determined by the chair. Members shall serve without compensation but may be reimbursed for necessary travel out of funds available to the Office of the Attorney General and the Department of Mental Health and Substance Abuse Services, pursuant to the State Travel Reimbursement Act; provided, that the reimbursement shall be paid in the case of state employee members by the agency employing the member.
- C. With funds appropriated or otherwise available for that purpose, the Office of the Attorney General, jointly with the Department of Mental Health and Substance Abuse Services, shall provide administrative assistance and services to the Opioid Overdose Fatality Review Board.

SECTION 2. This act shall become effective November 1, 2021.
