6	A Concurrent Resolution relating to legislative procedures; and establishing a legislative procedure
7	schedule for the 59th Oklahoma Legislature.

9	BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION OF THE 58TH OKLAHOMA
10	LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:
11	THAT the First Regular Session of the 59th Oklahoma Legislature
12	shall adhere to the following procedure schedule:
13	1. The First Regular Session of the 59th Oklahoma Legislature
14	shall convene at 12:00 noon on January 3, 2023, for the purposes
15	only of performing the duties set forth in Section 5 of Article VI
16	of the Oklahoma Constitution and organizing pursuant to the
17	provisions of Article V of the Oklahoma Constitution, and shall
18	recess no later than 5:00 p.m. on that same day until February 6,
19	2023, beginning at 12:00 noon.
20	2. December 9, 2022, shall be the final date for requesting the
21	drafting of bills and joint resolutions in the Senate and House of
22	Representatives for introduction for consideration during the First
23	Regular Session.

3. January 19, 2023, no later than 4:00 p.m., shall be the deadline for introduction of bills and joint resolutions in the Senate and House of Representatives for consideration on the floor of the Senate or House during the First Regular Session. Bills and joint resolutions subsequently introduced, if reported from Committee, shall not be placed on the Calendar for consideration in said house until the first legislative day of the Second Session.

8 4. March 23, 2023, shall be the final legislative day for third
9 reading and final passage of a bill or joint resolution in the house
10 of origin.

5. April 27, 2023, shall be the final legislative day for third reading and final passage of a bill or joint resolution in the house opposite the house of origin.

14 6. The First Regular Session shall adjourn sine die not later15 than 5:00 p.m. on May 26, 2023.

16 7. Upon a two-thirds (2/3) vote of the membership of or 17 pursuant to joint rules adopted by both chambers, a bill or joint 18 resolution can be exempt from all deadline dates in both chambers. 19 Upon a two-thirds (2/3) vote of the membership of or pursuant to 20 rules adopted by a single chamber, a bill or joint resolution can be 21 exempt from all deadline dates in that chamber only.

22 THAT the Second Regular Session of the 59th Oklahoma Legislature 23 shall adhere to the following procedure schedule:

December 8, 2023, shall be the final date for requesting the
 drafting of bills and joint resolutions in the Senate and House of
 Representatives for introduction for consideration during the Second
 Regular Session.

January 18, 2024, no later than 4:00 p.m., shall be the
deadline for introduction of bills and joint resolutions in the
Senate and House of Representatives for consideration on the floor
of the Senate or House during the Second Regular Session.

9 3. The Second Regular Session of the 59th Oklahoma Legislature
10 shall convene at 12:00 noon on February 5, 2024.

4. March 21, 2024, shall be the final legislative day for third reading and final passage of a bill or joint resolution in the house of origin.

14 5. April 25, 2024, shall be the final legislative day for third 15 reading and final passage of a bill or joint resolution in the house 16 opposite the house of origin.

17 6. The Second Regular Session shall adjourn sine die not later18 than 5:00 p.m. on May 31, 2024.

19 7. Upon a two-thirds (2/3) vote of the membership of or 20 pursuant to joint rules adopted by both chambers, a bill or joint 21 resolution can be exempt from all deadline dates in both chambers. 22 Upon a two-thirds (2/3) vote of the membership of or pursuant to 23 rules adopted by a single chamber, a bill or joint resolution can be 24 exempt from all deadline dates in that chamber only.

THAT this schedule shall be inapplicable to any joint resolution
 introduced for the purpose of disapproving or approving agency rules
 pursuant to the provisions of the Administrative Procedures Act.

THAT this schedule shall be inapplicable to any bills introduced for the purposes of incorporation and merging different versions of a statute amended in more than one measure at the same or different sessions of the Legislature as set form in Section 23.1 of Title 75 of the Oklahoma Statutes.

9 THAT this schedule shall be inapplicable to any bill or joint 10 resolution introduced for the purposes of approving, disapproving, 11 repealing or modifying rules of the Ethics Commission pursuant to 12 the provisions of Section 3 of Article XXIX of the Oklahoma 13 Constitution.

14 THAT this schedule shall be inapplicable to any bill or joint 15 resolution which proposes a special or local law and for which 16 notice of intended introduction is published in a newspaper for four 17 (4) consecutive weeks pursuant to the provisions of Section 32 of 18 Article V of the Oklahoma Constitution.

19 THAT the dates specified in this resolution for introduction of 20 bills or joint resolutions shall be inapplicable to any bill or 21 joint resolution which contains an "RB" number pursuant to the 22 provisions of the Oklahoma Pension Legislation Actuarial Analysis 23 Act. Such measures shall be submitted to the legislative actuary

not later than such dates and may be introduced not later than the
 first Monday in February following such submission.

THAT this schedule shall be inapplicable to any bill or joint resolution authored by the chairs and vice-chairs of the Senate Appropriations Committee and the House Appropriations and Budget Committee which affects the receipt, expenditure, or budgeting of state funds or funds under the control of an entity created by state law.

9 THAT this schedule shall be inapplicable to any bill or joint 10 resolution authored by the President Pro Tempore of the Senate or 11 the Speaker of the House of Representatives which is deemed by them 12 to be necessary for the preservation of public peace, health or 13 safety.
