7	An Act relating to sunset; amending 73 O.S. 2021, Section 83.1, which relates to the Capitol-Medical
8	Center Improvement and Zoning Commission; re-creating the Commission; modifying provisions related to
9	certain appointment; and modifying termination date.

11	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
12	SECTION 1. AMENDATORY 73 O.S. 2021, Section 83.1, is
13	amended to read as follows:
14	Section 83.1 A. There is hereby re-created to continue until
15	July 1, 2022 2025, in accordance with the Oklahoma Sunset Law, a
16	Capitol-Medical Center Improvement and Zoning Commission to exercise
17	the functions and perform the duties hereinafter prescribed.
18	B. The Commission shall be composed of eleven (11) members as
19	follows:
20	1. The Director of the Office of Management and Enterprise
21	Services or his or her designee, who shall be ex officio chair of
22	the Capitol-Medical Center Improvement and Zoning Commission;
23	2. The Director of the Transportation Commission or his or her
24	designee;

3. The President of the University of Oklahoma or his or her
 designee;

3 4. Two members appointed by the President Pro Tempore of the4 Senate;

5 5. Two members appointed by the Speaker of the House of6 Representatives;

7 6. The Chair of the Planning Commission of Oklahoma City or his
8 or her designee;

9 7. The Chair of the Long-Range Capital Planning Commission or
10 his or her designee; and

11 8. Two members of the Commission appointed by the Governor, 12 with the advice and consent of the State Senate, for four-year 13 staggered terms with one term expiring on January 31 of each even-14 numbered year.

15 C. One of the two members shall be appointed upon the 16 recommendation of the Citizens' Advisory Committee. The Commission 17 is authorized to appoint and hire a Director, who shall serve as the 18 chief administrative officer of the Commission, and other necessary 19 personnel. The Attorney General of the State of Oklahoma shall be 20 the legal advisor to the Commission in the same capacity as he or 21 she is to other boards and commissions.

D. At least one of the members appointed by the President Pro
Tempore of the Senate and the Speaker of the House of
Representatives shall be a resident within the boundaries of the
