9 FLOOR SUBSTITUTE

10 An Act relating to school athletics; providing a  
11 visiting high school athletic team the same rights as  
12 a home team to radio broadcast, video stream and  
13 provide telegraphic play-by-play accounts of an  
14 athletic competition if certain condition is met;  
15 providing for application beginning in certain school  
16 year; clarifying applicability to certain contracts;  
17 providing for codification; providing an effective  
18 date; and declaring an emergency.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. NEW LAW A new section of law to be codified  
21 in the Oklahoma Statutes as Section 27-105 of Title 70, unless there  
22 is created a duplication in numbering, reads as follows:

23 A. Notwithstanding any policy of a school athletic association,  
24 as defined by Section 27-102 of Title 70 of the Oklahoma Statutes,  
in all regular season high school athletic competitions in this  
state, the visiting team shall have the same rights to radio

1 broadcast, video stream and provide telegraphic play-by-play  
2 accounts as the home team as long as the visiting team has either:

3 1. A valid agreement to broadcast, video stream and/or provide  
4 telegraphic play-by-play accounts between a media organization and  
5 the school's board of education; or

6 2. The visiting team has a curricular program for students that  
7 typically provides streaming for the team's home games.

8 B. The provisions of this section shall apply to athletic  
9 competitions beginning in the 2021-2022 school year.

10 C. The provisions of this section shall apply to contracts for  
11 the rights to radio broadcast, video stream and provide telegraphic  
12 play-by-play accounts entered into or renewed on or after the  
13 effective date of this act.

14 SECTION 2. This act shall become effective July 1, 2021.

15 SECTION 3. It being immediately necessary for the preservation  
16 of the public peace, health or safety, an emergency is hereby  
17 declared to exist, by reason whereof this act shall take effect and  
18 be in full force from and after its passage and approval.
