11 Oklahoma Wildlife Conservation Commission to hunt or
12 fish - repealer - codification - effective dates]

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 4-301 of Title 29, unless there
16 is created a duplication in numbering, reads as follows:

17 A. Except as otherwise provided, no person may hunt, pursue,
18 trap, harass, catch, kill, take, or attempt to take in any manner,
19 use, have in possession, sell, or transport all or any portion of
20 any wildlife including fish, or enter any land owned, leased or
21 managed by the Department of Wildlife Conservation unless the person
22 has first obtained a license, permit or stamp from the Director or
23 any authorized agents of the Department of Wildlife Conservation.
24 Each person shall have the license, permit or stamp in their

1 possession when hunting, fishing, taking or transporting any
2 wildlife, and when entering any land owned, leased or managed by the
3 Department.

4 B. The Oklahoma Wildlife Conservation Commission shall
5 prescribe by rule the form, type, design, manner of issuance and the
6 fee for these licenses, permits and stamps and any rules necessary
7 to implement the provisions of this section; provided that the
8 Commission shall offer, but not be limited to, a three-hundred-
9 sixty-five-day hunting and fishing license.

10 C. The Commission may by rule or resolution designate
11 discounts, sales or exemptions to any license, permit or stamp.

12 D. The Department of Wildlife Conservation shall annually
13 provide a report to the President Pro Tempore of the Senate, the
14 Chair of the Agriculture and Wildlife Committee of the Senate and
15 the Speaker of the House of Representatives and the Chair of the
16 Wildlife Committee of the House of Representatives by February 1
17 setting forth information regarding license types and fees created
18 pursuant to subsections A, B and C of this section, as well as the
19 resulting license sales and revenue.

20 E. Notwithstanding the provisions of this act, the legislature,
21 under Article 5, Section 36 of the Oklahoma Constitution, maintains
22 its authority over the Oklahoma Department of Wildlife as prescribed
23 by Section 1-101 et seq. of Title 29 of the Oklahoma Statutes,
24

1 except as limited by the provisions of Article 26 of the Oklahoma
2 Constitution.

3 SECTION 2. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 4-302 of Title 29, unless there
5 is created a duplication in numbering, reads as follows:

6 A. The Oklahoma Wildlife Conservation Commission shall
7 prescribe, by rule, the form, type, design, manner of issuance and
8 the fee for these licenses, permits and stamps; and any rules
9 necessary to implement the provisions of this section.

10 B. 1. Any person convicted of violating the provisions of this
11 section shall have the commercial license revoked and forfeit the
12 privileges provided by the license. No new license shall be issued
13 for a period of at least six (6) months from and after the date on
14 which the revocation order becomes effective.

15 2. Any person convicted of violating the provisions of this
16 section shall be punished by a fine of no less than One Thousand
17 Dollars (\$1,000.00) or by imprisonment in the county jail for a
18 period not to exceed six (6) months, or by confiscation of gear, or
19 by a combination of fine, imprisonment, and confiscation.

20 SECTION 3. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 4-303 of Title 29, unless there
22 is created a duplication in numbering, reads as follows:

23 A. Except as otherwise provided in this title or in the
24 Oklahoma Farmed Cervidae Act, no person may breed or raise wildlife

1 for personal consumption or noncommercial purposes, or kill or
2 capture wildlife or take their nests or eggs for scientific purposes
3 without having first procured a license from the State Wildlife
4 Conservation Director.

5 B. The Oklahoma Wildlife Conservation Commission shall
6 prescribe, by rule, the form, type, design, manner of issuance and
7 the fee for these licenses, permits and stamps; and any rules
8 necessary to implement the provisions of this section.

9 C. 1. Any person convicted of violating the provisions of this
10 section shall have the noncommercial license revoked and forfeit the
11 privileges provided by the license. No new license shall be issued
12 for a period of at least six (6) months from and after the date on
13 which the revocation order becomes effective.

14 2. Any person convicted of violating the provisions of this
15 section shall be punished by a fine of not less than Fifty Dollars
16 (\$50.00) nor more than Five Hundred Dollars (\$500.00).

17 SECTION 4. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 110.1 of Title 29, unless there
19 is created a duplication in numbering, reads as follows:

20 The Oklahoma Wildlife Conservation Commission shall prescribe by
21 administrative rule the form, type, design, manner of issuance and
22 the fee for fishing licenses.

1 SECTION 5. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 110.2 of Title 29, unless there
3 is created a duplication in numbering, reads as follows:

4 The Oklahoma Wildlife Conservation Commission shall prescribe,
5 by administrative rule, the form, type, design, manner of issuance
6 and the fee for hunting licenses.

7 SECTION 6. AMENDATORY 29 O.S. 2011, Section 4-101, as
8 amended by Section 1, Chapter 341, O.S.L. 2013 (29 O.S. Supp. 2020,
9 Section 4-101), is amended to read as follows:

10 Section 4-101. A. All licenses and permits issued by the
11 ~~Director of State Wildlife Conservation~~ Director, the Department of
12 Wildlife Conservation or by any of its agents shall be used only in
13 conformity with the provisions of this title and the rules
14 promulgated by the Oklahoma Wildlife Conservation Commission.

15 B. All persons making application for any licenses required by
16 this section shall produce a valid license to operate a motor
17 vehicle or other positive proof of identification, age and
18 residency, and any such license issued shall show such data as well
19 as the date and time of issuance.

20 C. All licenses are nontransferable. No person shall alter,
21 change, lend or transfer any license. No person shall use or borrow
22 a license which has not been issued to that person by the Director,
23 the Department or by any of its agents pursuant to the provisions of
24 this section.

1 D. No person may engage in activities requiring a license
2 without that person's carrying such license on their person and
3 producing the same for an inspection upon the demand of any ~~Oklahoma~~
4 ~~citizen or~~ game warden.

5 E. Any person required to produce a license must also identify
6 themselves as the person to whom such license was issued, and
7 failure or refusal to comply shall be deemed prima facie evidence of
8 a violation of this section.

9 F. Unless otherwise provided in this Code:

10 ~~1. Hunting licenses issued pursuant to paragraph 1 of~~
11 ~~subsection C and paragraphs 1 and 3 of subsection E of Section 4-112~~
12 ~~of this title and paragraphs 1 and 3 of subsection B of Section 4-~~
13 ~~113 of this title shall expire on December 31 of the year issued.~~
14 ~~Hunting licenses issued pursuant to paragraph 2 of subsection C and~~
15 ~~paragraphs 2 and 4 of subsection E of Section 4-112 of this title~~
16 ~~and paragraphs 2 and 4 of subsection B of Section 4-113 of this~~
17 ~~title shall expire on June 30 of the fiscal year issued. All other~~
18 ~~licenses shall terminate December 31 for the year issued; and~~

19 ~~2. Any, any~~ person convicted of violating any of the provisions
20 of this title may have any or all licenses held by that person or
21 the privilege of applying for, purchasing or exercising the benefits
22 conferred by the licenses revoked by the Department in accordance
23 with rules promulgated by the Commission or by a court of competent
24 jurisdiction for a period of not less than one (1) year. For

1 purposes of this paragraph, a court conviction, a plea of guilty, a
2 plea of nolo contendere, the imposition of a deferred or suspended
3 sentence by a court, or forfeiture of bond shall be deemed a
4 conviction.

5 G. Should any license or permit issued pursuant to Part 1 of
6 Article IV of this title be lost or destroyed, duplicates will be
7 issued by the Department at a fee ~~of One Dollar and fifty cents~~
8 ~~(\$1.50)~~ determined by the Commission.

9 H. Upon harvesting any whitetail or mule deer, or any other
10 wildlife where the hunter, according to Commission rules, is
11 required to check the wildlife in at a Department check station, the
12 taker of the wildlife shall:

13 1. Securely attach the name of the taker, time of harvest, date
14 of harvest and license number to the carcass of the wildlife;

15 2. Check in the carcass of the wildlife electronically using
16 the online check station provided on the official website of the
17 Oklahoma Department of Wildlife Conservation or as prescribed by
18 rule of the Commission, within twenty-four (24) hours of leaving the
19 hunt area and in all cases prior to processing the carcass; and

20 3. Not remove evidence of the sex of the animal until after the
21 carcass of the animal has been checked in.

22 I. It shall be unlawful for any license or permit holder to
23 knowingly make a false statement or give false information to any
24 authorized hunter check station or to an authorized Department

1 employee when complying with the provisions of subsection H of this
2 section. Information which may be collected at a Department check
3 station shall include but not be limited to the name, address,
4 license or permit number and signature of the taker, the date, time,
5 county, method or weapon of the kill, sex and weight of carcass,
6 whether or not the animal was taken on public hunting land and if so
7 in what area, or any other information which may be required by the
8 Commission.

9 J. 1. Any person convicted of violating the provisions of this
10 section or of making a false statement or giving any false
11 information in order to acquire any license or permit, pursuant to
12 the provisions of this section, shall be punishable by a fine of not
13 less than One Hundred Dollars (\$100.00) nor more than Two Hundred
14 Fifty Dollars (\$250.00), or by imprisonment in the county jail for a
15 period not to exceed ten (10) days, or by both such fine and
16 imprisonment. Any person convicted of a second or subsequent
17 violation of the provisions of this section or of making a false
18 statement or giving any false information in order to acquire any
19 license or permit, pursuant to the provisions of this section, shall
20 be punishable by a fine of not less than Two Hundred Fifty Dollars
21 (\$250.00) nor more than Seven Hundred Fifty Dollars (\$750.00), or by
22 imprisonment in the county jail for a period not to exceed ten (10)
23 days, or by both such fine and imprisonment.

24

1 2. Any hunting or fishing license issued to a person by the
2 Department of Wildlife Conservation shall be automatically revoked
3 upon conviction of the person of violating the provisions of this
4 section. The revocation shall be for a period set by the court of
5 not less than one (1) year nor more than ten (10) years. If the
6 court does not set a period, the revocation shall be for one (1)
7 year from the date of the conviction. During this period of
8 revocation, the Department shall not issue the person a hunting or
9 fishing license. If the court does not set a revocation period, the
10 Department shall not issue that person a license within one (1) year
11 of the conviction of the person pursuant to this section. A person
12 who has a license or permit revoked pursuant to this section shall
13 surrender the revoked license or permit to the court. The court
14 shall send the Department of Wildlife Conservation the revoked
15 license and a copy of the judgment of conviction. For purposes of
16 this section, "conviction" shall include a plea of guilty or nolo
17 contendere to an offense or the imposition of deferred adjudication
18 for an offense.

19 K. Any person who has had their license privileges revoked
20 shall not be entitled to purchase, apply for, or exercise the
21 benefits conferred by any license until the revocation period has
22 expired or the person has obtained approval from the Director. Any
23 person violating the provisions of this subsection, upon conviction,
24 shall be punished by a fine of not more than Five Hundred Dollars

1 (\$500.00), or by imprisonment in a county jail for a term of not
2 more than ninety (90) days or by both the fine and imprisonment.
3 Upon conviction under this subsection, the previously granted
4 license revocation period shall be extended by two (2) additional
5 years.

6 SECTION 7. AMENDATORY 29 O.S. 2011, Section 4-110, as
7 last amended by Section 2, Chapter 229, O.S.L. 2017 (29 O.S. Supp.
8 2020, Section 4-110), is amended to read as follows:

9 Section 4-110. A. Except as otherwise provided in the Oklahoma
10 Wildlife Conservation Code, no person shall fish, pursue, harass,
11 catch, kill, take in any manner, use, have in possession, sell, or
12 transport all or any portion of fish without having first procured a
13 license for such from the Director or from any of the authorized
14 agents of the Department of Wildlife Conservation. The Oklahoma
15 Wildlife Conservation Commission may designate two (2) days per year
16 in which residents and nonresidents may fish without first procuring
17 a fishing license pursuant to the provisions of this section.

18 B. ~~The following legal residents of Oklahoma shall be exempt~~
19 ~~from the annual fishing license requirements of subsection C of this~~
20 ~~section and the following nonresidents shall be exempt from the~~
21 ~~annual nonresident fishing licenses required pursuant to subsection~~
22 ~~E of this section:~~

23 1. ~~Legal residents under sixteen (16) years of age and~~
24 ~~nonresidents under sixteen (16) years of age from states which do~~

1 ~~not require nonresident fishing licenses for persons under sixteen~~
2 ~~(16) years of age;~~

3 2. ~~Legal residents sixty-five (65) years of age or older and~~

8 ~~of age who is in the physical custody of a child care facility as~~
9 ~~defined by Section 402 of Title 10 of the Oklahoma Statutes;~~

10 ~~9. Any legal resident or nonresident who is legally blind or~~
11 ~~who has any other physical impairment, as certified by a physician~~
12 ~~licensed in this state or any state which borders this state, which~~
13 ~~prevents the person from properly using fishing apparatus without~~
14 ~~the assistance of another person, and any one person actually~~
15 ~~accompanying and actually assisting such legally blind or otherwise~~

22 section who does not meet the requirements of subsection ~~K~~ F of this
23 section, may purchase a substitute temporary thirty-day license from
24 the arresting game warden in lieu of posting bond. The Commission

1 shall by rule determine the fee for a substitute license purchased
2 ~~pursuant to the provisions of this subsection shall be:~~

16 2020, Section 4-112), is amended to read as follows:

17 Section 4-112. A. Except as otherwise provided for in the
18 Oklahoma Wildlife Conservation Code or the Oklahoma Farmed Cervidae
19 Act, no person may hunt, pursue, trap, harass, catch, kill, take or
20 attempt to take in any manner, use, have in possession, sell, or
21 transport all or any portion of any wildlife except fish, without
22 having first procured a license from the Department of Wildlife
23 Conservation. The Oklahoma Wildlife Conservation Commission shall
24 designate a consecutive Saturday and Sunday in September of each

1 year as free hunting days in which landowners and residents of this
2 state may hunt without first procuring a hunting license pursuant to
3 the provisions of this section.

4 B. ~~The following legal residents of Oklahoma shall be exempt~~
5 ~~from the annual hunting license requirement of paragraph 1 of~~
6 ~~subsection E of this section and the following nonresidents shall be~~

9 or noncommercial game breeder of the propagated bird which is being
10 released for the training purposes, stating the number of birds and
11 the date obtained or has proof that the bird was reared by the
12 trainer; and

13 4. All propagated birds so used are tagged or banded prior to
14 their release. The use of a bird hunting dog may be permitted in
15 the legal hunting of quail, dove, prairie chickens, pheasant and
16 waterfowl.

17 B. A person may carry a pistol while training a bird dog
18 without having met the provisions of paragraphs 1 through 4 of
19 subsection A of this section.
