15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 59 O.S. 2011, Section 1002, is
17	amended to read as follows:
18	Section 1002. A. The Construction Industries Board is hereby
19	authorized, empowered, and directed to make, prescribe, enforce,
20	amend, and repeal rules governing the following:
21	1. The examination and licensing of persons desiring or
22	intending to engage in the business, trade or calling of plumbing
23	contractor or journeyman plumber, implementing the provisions of The
24	

1 Plumbing License Law of 1955, including, but not limited to, 2 defining categories and limitations for such licenses; 3 2. The registering of and issuing of certificates to persons 4 desiring or intending to work or act as a plumber's apprentice; 5 3. The establishment and levying of administrative fines; The initiation of disciplinary proceedings; 6 4. 7 5. The requesting of prosecution of and initiation of injunctive proceedings against any person who violates any of the 8 9 provisions of The Plumbing License Law of 1955 or any rule 10 promulgated pursuant to The Plumbing License Law of 1955; 11 6. The establishment of minimum standards of plumbing 12 installation; and 13 7. The establishment of bonding and insurance requirements for 14 the issuance of a license as a plumbing contractor; provided, such 15 rules shall not be inconsistent with the terms and conditions 16 hereinafter provided. 17 Such bonding requirements shall allow the filing of cash or Β. 18 a certificate of deposit in lieu of a bond. A state bond or cash or 19 certificate of deposit filed in lieu of a bond and which is posted 20 pursuant to the provisions of this section shall be deemed 21 sufficient to meet the requirements of any municipality, provided 22 that a copy of said bond or documentation of cash or certificate of 23 deposit filed in lieu of a bond shall be filed by the contractor 24 prior to the commencement of any plumbing work with any municipality

1 in which the licensee does work if required by local ordinances or 2 rules.

3	SECTION 2. It being immediately necessary for the preservation
4	of the public peace, health or safety, an emergency is hereby
5	declared to exist, by reason whereof this act shall take effect and
6	be in full force from and after its passage and approval.
