7	private organizations for services; authorizing State Department of Health to enter into contracts with

9	which relates to grant compliance and monitoring; requiring Department to monitor and review
10	organizations and directing termination of funding under certain circumstances; updating statutory
11	language; providing an effective date; and declaring an emergency.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 63 O.S. 2021, Section 1-740.17, is
16	amended to read as follows:
17	Section 1-740.17. A. The State Department of Health shall
18	make:
19	1. Make grants, from funds appropriated by the Legislature
20	specifically for this purpose for the Choosing Childbirth Act, to a
21	grant-supervising entity for the purpose of reimbursing private
22	organizations in Oklahoma <u>this state</u> for the reasonable expenses of
23	programs providing the following services: listed in subsection B of
24	this section; or

5 <u>B. Services provided pursuant to the Choosing Childbirth Act</u>
6 shall include:

1. Providing information on, referral to and assistance in 7 securing the services of relevant existing programs or agencies that 8 9 assist women in Oklahoma this state to carry their children to term, 10 and/or providing services that assist women to carry their children to term including, but not limited to, agencies and programs that 11 12 will provide medical attention for the pregnant woman for the duration of her pregnancy, nutritional support services, housing 13 assistance, adoption services, education and employment assistance 14 and parenting education and support services; 15

Providing women in Oklahoma this state, in person and
 through community outreach, information and/or services that
 encourage and assist them to carry their children to term; and

3. Providing services including, but not limited to, healthcare services to mothers and infants for the purpose of reducing the rates of maternal mortality and infant mortality in this state by three percent (3%) within five (5) years of the effective date of this act not later than July 1, 2026; provided, however, no funds

shall be provided to an organization that provides, or whose
 affiliates provide, abortion services.

3 B. C. To be eligible for a service grant <u>or a contract</u>, an 4 organization shall:

5 1. Be registered with the Oklahoma Secretary of State as a not6 for-profit corporation located in Oklahoma;

7 2. Have If the Department utilizes a grant-supervising entity,
8 have the grant amount approved by a grant-supervising entity;.

9 3. For services described in paragraphs 1 and 2 of subsection A
10 <u>B</u> of this section, provide each pregnant woman counseled with
11 accurate information on the developmental characteristics of unborn
12 children including offering the printed information described in
13 Section 1-738.3 of Title 63 of the Oklahoma Statutes;

14 4. <u>3.</u> Assure that the grant's sole purposes are any funds 15 provided pursuant to the Choosing Childbirth Act are used only to 16 assist and encourage women to carry their children to term and to 17 maximize their potentials thereafter <u>as provided in paragraphs 1 and</u> 18 <u>2 of subsection B of this section</u> or to reduce the rates of maternal 19 mortality and infant mortality in this state as provided in 20 paragraph 3 of subsection A B of this section; and

5. <u>4.</u> Assure that none of the funds provided pursuant to the
Choosing Childbirth Act, nor any other funds or services provided by
the organization, are used to encourage or counsel a woman to have

an abortion not necessary to prevent her death, to provide her such
 an abortion or to refer her for such an abortion.
 SECTION 2. AMENDATORY 63 O.S. 2021, Section 1-740.18, is
 amended to read as follows:

Section 1-740.18. The State Department of Health shall make
grants to a grant-supervising entity under the Choosing Childbirth
Act from funds appropriated by the Legislature specifically for this
purpose. The State Department of Health

9 A. If the State Department of Health utilizes a grant-10 supervising entity to implement the Choosing Childbirth Act, the Department shall annually monitor and review the grant-supervising 11 12 entity to assure that the grant-supervising entity carefully adheres to the purposes and requirements of the Choosing Childbirth Act, and 13 it shall cease funding a grant-supervising entity that fails to do 14 so if the Department proves specific findings of noncompliance, 15 subject to judicial review. 16

B. If the Department contracts directly with private 17 organizations in this state to implement the Choosing Childbirth 18 Act, the Department shall annually monitor and review the 19 organizations to assure that the organizations carefully adhere to 20 the purposes and requirements of the Choosing Childbirth Act, and it 21 shall cease funding an organization that fails to do so if the 22 Department proves specific findings of noncompliance, subject to 23 24 judicial review.
