12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 4-301 of Title 29, unless there
15 is created a duplication in numbering, reads as follows:

16 A. Except as otherwise provided, no person may hunt, pursue,
17 trap, harass, catch, kill, take, or attempt to take in any manner,
18 use, have in possession, sell, or transport all or any portion of
19 any wildlife including fish, or enter any land owned, leased or
20 managed by the Department of Wildlife Conservation unless the person
21 has first obtained a license, permit or stamp from the Director or
22 any authorized agents of the Department of Wildlife Conservation.
23 Each person shall have the license, permit or stamp in their
24 possession when hunting, fishing, taking or transporting any

1 wildlife, and when entering any land owned, leased or managed by the
2 Department.

3 B. The Oklahoma Wildlife Conservation Commission shall
4 prescribe by rule the form, type, design, manner of issuance and the
5 fee for these licenses, permits and stamps and any rules necessary
6 to implement the provisions of this section; provided that the
7 Commission shall offer, but not be limited to, a three-hundred-
8 sixty-five-day hunting and fishing license.

9 C. The Commission may by rule or resolution designate
10 discounts, sales or exemptions to any license, permit or stamp.

11 SECTION 2. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 4-302 of Title 29, unless there
13 is created a duplication in numbering, reads as follows:

14 A. Except as otherwise provided, no person may breed, possess
15 or raise, sell, buy, transport out of state, export, take for
16 commercial purposes any wildlife including fish, without having
17 first procured a license for such purposes from the Director of
18 Wildlife Conservation pursuant to the rules promulgated by the
19 Commission.

20 B. The Oklahoma Wildlife Conservation Commission shall
21 prescribe, by rule, the form, type, design, manner of issuance and
22 the fee for these licenses, permits and stamps; and any rules
23 necessary to implement the provisions of this section.

24

1 C. 1. Any person convicted of violating the provisions of this
2 section shall have the commercial license revoked and forfeit the
3 privileges provided by the license. No new license shall be issued
4 for a period of at least six (6) months from and after the date on
5 which the revocation order becomes effective.

6 2. Any person convicted of violating the provisions of this
7 section shall be punished by a fine of no less than One Thousand
8 Dollars (\$1,000.00) or by imprisonment in the county jail for a
9 period not to exceed six (6) months, or by confiscation of gear, or
10 by a combination of fine, imprisonment, and confiscation.

11 SECTION 3. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 4-303 of Title 29, unless there
13 is created a duplication in numbering, reads as follows:

14 A. Except as otherwise provided in this title or in the
15 Oklahoma Farmed Cervidae Act, no person may breed or raise wildlife
16 for personal consumption or noncommercial purposes, or kill or
17 capture wildlife or take their nests or eggs for scientific purposes
18 without having first procured a license from the State Wildlife
19 Conservation Director.

20 B. The Oklahoma Wildlife Conservation Commission shall
21 prescribe, by rule, the form, type, design, manner of issuance and
22 the fee for these licenses, permits and stamps; and any rules
23 necessary to implement the provisions of this section.

24

1 C. 1. Any person convicted of violating the provisions of this
2 section shall have the noncommercial license revoked and forfeit the
3 privileges provided by the license. No new license shall be issued
4 for a period of at least six (6) months from and after the date on
5 which the revocation order becomes effective.

6 2. Any person convicted of violating the provisions of this
7 section shall be punished by a fine of not less than Fifty Dollars
8 (\$50.00) nor more than Five Hundred Dollars (\$500.00).

9 SECTION 4. AMENDATORY 29 O.S. 2011, Section 4-101, as
10 amended by Section 1, Chapter 341, O.S.L. 2013 (29 O.S. Supp. 2020,
11 Section 4-101), is amended to read as follows:

12 Section 4-101. A. All licenses and permits issued by the
13 ~~Director of State Wildlife Conservation~~ Director, the Department of
14 Wildlife Conservation or by any of its agents shall be used only in
15 conformity with the provisions of this title and the rules
16 promulgated by the Oklahoma Wildlife Conservation Commission.

17 B. All persons making application for any licenses required by
18 this section shall produce a valid license to operate a motor
19 vehicle or other positive proof of identification, age and
20 residency, and any such license issued shall show such data as well
21 as the date and time of issuance.

22 C. All licenses are nontransferable. No person shall alter,
23 change, lend or transfer any license. No person shall use or borrow
24 a license which has not been issued to that person by the Director,

1 the Department or by any of its agents pursuant to the provisions of
2 this section.

3 D. No person may engage in activities requiring a license
4 without that person's carrying such license on their person and
5 producing the same for an inspection upon the demand of any Oklahoma
6 citizen or game warden.

7 E. Any person required to produce a license must also identify
8 themselves as the person to whom such license was issued, and
9 failure or refusal to comply shall be deemed prima facie evidence of
10 a violation of this section.

11 F. Unless otherwise provided in this Code:

12 ~~1. Hunting licenses issued pursuant to paragraph 1 of~~
13 ~~subsection C and paragraphs 1 and 3 of subsection E of Section 4-112~~
14 ~~of this title and paragraphs 1 and 3 of subsection B of Section 4-~~
15 ~~113 of this title shall expire on December 31 of the year issued.~~
16 ~~Hunting licenses issued pursuant to paragraph 2 of subsection C and~~
17 ~~paragraphs 2 and 4 of subsection E of Section 4-112 of this title~~
18 ~~and paragraphs 2 and 4 of subsection B of Section 4-113 of this~~
19 ~~title shall expire on June 30 of the fiscal year issued. All other~~
20 ~~licenses shall terminate December 31 for the year issued; and~~

21 ~~2. Any, any~~ person convicted of violating any of the provisions
22 of this title may have any or all licenses held by that person or
23 the privilege of applying for, purchasing or exercising the benefits
24 conferred by the licenses revoked by the Department in accordance

1 with rules promulgated by the Commission or by a court of competent
2 jurisdiction for a period of not less than one (1) year. For
3 purposes of this paragraph, a court conviction, a plea of guilty, a
4 plea of nolo contendere, the imposition of a deferred or suspended
5 sentence by a court, or forfeiture of bond shall be deemed a
6 conviction.

7 G. Should any license or permit issued pursuant to Part 1 of
8 Article IV of this title be lost or destroyed, duplicates will be
9 issued by the Department at a fee of ~~One Dollar and fifty cents~~
10 ~~(\$1.50)~~ determined by the Commission.

11 H. Upon harvesting any whitetail or mule deer, or any other
12 wildlife where the hunter, according to Commission rules, is
13 required to check the wildlife in at a Department check station, the
14 taker of the wildlife shall:

15 1. Securely attach the name of the taker, time of harvest, date
16 of harvest and license number to the carcass of the wildlife;

17 2. Check in the carcass of the wildlife electronically using
18 the online check station provided on the official website of the
19 Oklahoma Department of Wildlife Conservation or as prescribed by
20 rule of the Commission, within twenty-four (24) hours of leaving the
21 hunt area and in all cases prior to processing the carcass; and

22 3. Not remove evidence of the sex of the animal until after the
23 carcass of the animal has been checked in.

24

1 I. It shall be unlawful for any license or permit holder to
2 knowingly make a false statement or give false information to any
3 authorized hunter check station or to an authorized Department
4 employee when complying with the provisions of subsection H of this
5 section. Information which may be collected at a Department check
6 station shall include but not be limited to the name, address,
7 license or permit number and signature of the taker, the date, time,
8 county, method or weapon of the kill, sex and weight of carcass,
9 whether or not the animal was taken on public hunting land and if so
10 in what area, or any other information which may be required by the
11 Commission.

12 J. 1. Any person convicted of violating the provisions of this
13 section or of making a false statement or giving any false
14 information in order to acquire any license or permit, pursuant to
15 the provisions of this section, shall be punishable by a fine of not
16 less than One Hundred Dollars (\$100.00) nor more than Two Hundred
17 Fifty Dollars (\$250.00), or by imprisonment in the county jail for a
18 period not to exceed ten (10) days, or by both such fine and
19 imprisonment. Any person convicted of a second or subsequent
20 violation of the provisions of this section or of making a false
21 statement or giving any false information in order to acquire any
22 license or permit, pursuant to the provisions of this section, shall
23 be punishable by a fine of not less than Two Hundred Fifty Dollars
24 (\$250.00) nor more than Seven Hundred Fifty Dollars (\$750.00), or by

1 imprisonment in the county jail for a period not to exceed ten (10)
2 days, or by both such fine and imprisonment.

3 2. Any hunting or fishing license issued to a person by the
4 Department of Wildlife Conservation shall be automatically revoked
5 upon conviction of the person of violating the provisions of this
6 section. The revocation shall be for a period set by the court of
7 not less than one (1) year nor more than ten (10) years. If the
8 court does not set a period, the revocation shall be for one (1)
9 year from the date of the conviction. During this period of
10 revocation, the Department shall not issue the person a hunting or
11 fishing license. If the court does not set a revocation period, the
12 Department shall not issue that person a license within one (1) year
13 of the conviction of the person pursuant to this section. A person
14 who has a license or permit revoked pursuant to this section shall
15 surrender the revoked license or permit to the court. The court
16 shall send the Department of Wildlife Conservation the revoked
17 license and a copy of the judgment of conviction. For purposes of
18 this section, "conviction" shall include a plea of guilty or nolo
19 contendere to an offense or the imposition of deferred adjudication
20 for an offense.

21 K. Any person who has had their license privileges revoked
22 shall not be entitled to purchase, apply for, or exercise the
23 benefits conferred by any license until the revocation period has
24 expired or the person has obtained approval from the Director. Any

1 person violating the provisions of this subsection, upon conviction,
2 shall be punished by a fine of not more than Five Hundred Dollars
3 (\$500.00), or by imprisonment in a county jail for a term of not
4 more than ninety (90) days or by both the fine and imprisonment.
5 Upon conviction under this subsection, the previously granted
6 license revocation period shall be extended by two (2) additional
7 years.

8 SECTION 5. AMENDATORY 29 O.S. 2011, Section 4-110, as
9 last amended by Section 2, Chapter 229, O.S.L. 2017 (29 O.S. Supp.
10 2020, Section 4-110), is amended to read as follows:

11 Section 4-110. A. Except as otherwise provided in the Oklahoma
12 Wildlife Conservation Code, no person shall fish, pursue, harass,
13 catch, kill, take in any manner, use, have in possession, sell, or
14 transport all or any portion of fish without having first procured a
15 license for such from the Director or from any of the authorized
16 agents of the Department of Wildlife Conservation. The Oklahoma
17 Wildlife Conservation Commission may designate two (2) days per year
18 in which residents and nonresidents may fish without first procuring
19 a fishing license pursuant to the provisions of this section.

20 B. ~~The following legal residents of Oklahoma shall be exempt~~
21 ~~from the annual fishing license requirements of subsection C of this~~
22 ~~section and the following nonresidents shall be exempt from the~~
23 ~~annual nonresident fishing licenses required pursuant to subsection~~
24 ~~E of this section:~~

1 ~~1. Legal residents under sixteen (16) years of age and~~
2 ~~nonresidents under sixteen (16) years of age from states which do~~
3 ~~not require nonresident fishing licenses for persons under sixteen~~
4 ~~(16) years of age;~~

5 ~~2. Legal residents sixty-five (65) years of age or older and~~

13 ~~(60%) or more and registered with the veterans registry created by~~
14 ~~the Oklahoma Department of Veterans Affairs; provided, that if the~~
15 ~~veteran has previously received an exemption pursuant to this~~

3 ~~institution or developmentally disabled persons when accompanied by~~

6 ~~7. Any legal resident or nonresident under eighteen (18) years~~
7 ~~of age who is in the legal and physical custody of the State of~~

10 ~~of age who is in the physical custody of a child care facility as~~

13 ~~who has any other physical impairment, as certified by a physician~~
14 ~~licensed in this state or any state which borders this state, which~~

22 ~~trainee of this state, provided that the trainees shall have on~~
23 ~~their persons a duly authorized identification card issued by their~~
24 ~~respective Job Corps Center and shall present the card upon request,~~

1 ~~in lieu of a fishing license. The trainees shall return their cards~~
2 ~~to their respective Job Corps Center when the trainees leave their~~
3 ~~respective Job Corps training programs;~~

16 Section 4-112. A. Except as otherwise provided for in the
17 Oklahoma Wildlife Conservation Code or the Oklahoma Farmed Cervidae
18 Act, no person may hunt, pursue, trap, harass, catch, kill, take or
19 attempt to take in any manner, use, have in possession, sell, or
20 transport all or any portion of any wildlife except fish, without
21 having first procured a license from the Department of Wildlife
22 Conservation. The Oklahoma Wildlife Conservation Commission shall
