14	SECTION 1. AMENDATORY 22 O.S. 2021, Section 152, is
15	amended to read as follows:
16	Section 152. A. Prosecutions for the crimes of bribery,
17	embezzlement of public money, bonds, securities, assets or property
18	of the state or any county, school district, municipality or other
19	subdivision thereof, or of any misappropriation of public money,
20	bonds, securities, assets or property of the state or any county,
21	school district, municipality or other subdivision thereof,
22	falsification of public records of the state or any county, school
23	district, municipality or other subdivision thereof, and conspiracy
24	to defraud the State of Oklahoma or any county, school district,

1 municipality or other subdivision thereof in any manner or for any 2 purpose shall be commenced within seven (7) years after the discovery of the crime; provided, however, prosecutions for the 3 crimes of embezzlement or misappropriation of public money, bonds, 4 5 securities, assets or property of any school district, including those relating to student activity funds, or the crime of 6 falsification of public records of any independent school district, 7 the crime of criminal conspiracy, the crime of embezzlement pursuant 8 9 to Sections 1451 through 1461 of Title 21 of the Oklahoma Statutes, 10 the crime of False Personation or Identity Theft pursuant to Sections 1531 through 1533.3 of Title 21 of the Oklahoma Statutes, 11 12 the financial exploitation of a vulnerable adult pursuant to Sections 843.1, 843.3 and 843.4 of Title 21 of the Oklahoma 13 Statutes, or Medicaid fraud pursuant to Section 1005 of Title 56 of 14 the Oklahoma Statutes, shall be commenced within five (5) years 15 after the discovery of the crime. 16

B. Prosecutions for criminal violations of any state income tax
laws shall be commenced within five (5) years after the commission
of such violation.

C. 1. Prosecutions for sexual crimes against children,
specifically rape or forcible sodomy, sodomy, lewd or indecent
proposals or acts against children, involving minors in pornography
pursuant to Section 886, 888, 1111, 1111.1, 1113, 1114, 1021.2,
1021.3, 1040.12a or 1123 of Title 21 of the Oklahoma Statutes, child

 <u>pursuant to this subsection or a claim that the person knows lacks</u>
 <u>factual foundation may be reported to local law enforcement for</u>
 <u>criminal investigation and, upon conviction, shall be guilty of a</u>
 felony.

D. Prosecutions for criminal violations of any provision of the
Oklahoma Wildlife Conservation Code shall be commenced within three
(3) years after the commission of such offense.

9 E. Prosecutions for the crime of criminal fraud or workers' 10 compensation fraud pursuant to Section 1541.1, 1541.2, 1662 or 1663 11 of Title 21 of the Oklahoma Statutes shall commence within three (3) 12 years after the discovery of the crime, but in no event greater than 13 seven (7) years after the commission of the crime.

F. Prosecution for the crime of false or bogus check pursuant to Section 1541.1, 1541.2, 1541.3 or 1541.4 of Title 21 of the Oklahoma Statutes shall be commenced within five (5) years after the commission of such offense.

G. Prosecution for the crime of solicitation for murder in the first degree pursuant to Section 701.16 of Title 21 of the Oklahoma Statutes shall be commenced within seven (7) years after the discovery of the crime. For purposes of this subsection, "discovery" means the date upon which the crime is made known to anyone other than a person involved in the solicitation.

H. In all other cases a prosecution for a public offense must
 be commenced within three (3) years after its commission.

I. Prosecution for the crime of accessory after the fact must be commenced within the same statute of limitations as that of the felony for which the person acted as an accessory.

J. Prosecution for the crime of arson pursuant to Section 1401,
1402, 1403, 1404 or 1405 of Title 21 of the Oklahoma Statutes shall
be commenced within seven (7) years after the commission of the
crime.

10 K. Prosecutions for criminal violations in which a deadly 11 weapon is used to commit a felony or prosecutions for criminal 12 violations in which a deadly weapon is used in an attempt to commit 13 a felony shall be commenced within seven (7) years after the 14 commission of the crime.

15 L. No prosecution under subsection C of this section shall be based upon the memory of the victim that has been recovered through psychotherapy unless there is some evidence independent of such repressed memory.

19 Any person who knowingly and willfully makes a false claim
20 pursuant to subsection C of this section or a claim that the person
21 knows lacks factual foundation may be reported to local law
22 enforcement for criminal investigation and, upon conviction, shall
23 be guilty of a felony.

1	M. As used in paragraph 1 of subsection C of this section,
2	"discovery" means the date that a physical or sexually related crime
3	involving a victim eighteen (18) years of age or older is reported
4	to a law enforcement agency. Prosecutions for the crime of human
5	trafficking pursuant to Section 748 of Title 21 of the Oklahoma
6	Statutes shall be commenced within three (3) years after discovery
7	of the crime. For purposes of this subsection, "discovery" means
8	the date upon which the crime is reported to a law enforcement
9	agency.
