14	SECTION 1. AMENDATORY 82 O.S. 2011, Section 1085.12, is
15	amended to read as follows:
16	Section 1085.12. A. The Oklahoma Water Resources Board shall
17	appoint an Executive Director, who shall have had at least six (6)
18	years practical and administrative experience in water resource
19	management $_{m{ au}}$ and fix his <u>or her</u> duties and compensation. The
20	Oklahoma Water Resources Board is specifically authorized to
21	delegate to such Executive Director such of its powers and duties as
22	it may deem proper, including powers and duties involving the
23	exercise of official discretion. The authority hereby granted to
24	the <del>Oklahoma Water Resources</del> Board to delegate powers and duties to

1 the Executive Director shall extend to any powers and duties given 2 or transferred to the Oklahoma Water Resources Board under this act 3 title, or under any other law conferring powers or imposing duties 4 upon the Oklahoma Water Resources Board, and shall also extend to 5 any powers conferred or duties imposed upon the Oklahoma Water 6 Resources Board by any future law, unless such future laws shall any 7 law expressly negate negates the authority to make such delegation. 8 Any other part of this act title, or any other law granting 9 authority to the Oklahoma Water Resources Board to delegate any 10 powers or duties, shall not be deemed to be a limitation upon the 11 authority conferred by this section. The Executive Director shall 12 exercise any such delegated powers and perform such delegated 13 duties, in accordance with any rules, regulations or orders made by 14 the Oklahoma Water Resources Board which are applicable thereto. 15 Provided, however, the Oklahoma Water Resources Board shall not 16 delegate to such director any power of determining policy, the 17 execution of any contract or the final adjudication of any claims, 18 applications or controversies, all of which powers and duties shall 19 be exercised solely by the Oklahoma Water Resources Board. 20 In addition to the powers and duties specified in subsection Β. 21 A of this section, the Executive Director shall have the power and 22 duty to issue temporary permits and regular permits meeting the
