11 An Act relating to courts; amending 20 O.S. 2011,  
12 Section 16.1, which relates to the Administrative  
13 Director of the Courts; clarifying duties of the  
14 Administrative Director; and providing an effective  
15 date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 20 O.S. 2011, Section 16.1, is  
18 amended to read as follows:

19 Section 16.1 ~~There~~ A. As provided in Section 6 of Article VII  
20 of the Oklahoma Constitution, there shall be appointed by the  
21 Supreme Court an Administrative Director of the Courts, who shall  
22 serve at the pleasure of the Supreme Court to assist the Chief  
23 Justice in performance of administrative duties.

1        B. The Administrative Director of the Courts shall be  
2 responsible for and have control over matters concerning the budget,  
3 personnel, technology, purchases and other administrative operations  
4 over all courts of this state, including the Court of Civil Appeals  
5 and the Court of Criminal Appeals, and performing such additional  
6 duties as may be assigned by the Chief Justice.

7            SECTION 2. This act shall become effective November 1, 2021.
