12 An Act relating to the Office of the Attorney  
13 General; making an appropriation; identifying source  
14 of funds; providing amount; specifying purpose;  
15 providing an effective date; and declaring an  
16 emergency.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. There is hereby appropriated to the Office of the  
19 Attorney General from any monies not otherwise appropriated from the  
20 General Revenue Fund of the State Treasury for the fiscal year  
21 ending June 30, 2023, the sum of Five Million Three Hundred Thousand  
22 Dollars (\$5,300,000.00) or so much thereof as may be necessary to  
23 implement the provisions of Enrolled House Bill No. 4210 of the 2nd  
24 Session of the 58th Oklahoma Legislature.

1 SECTION 2. This act shall become effective July 1, 2022.

2 SECTION 3. It being immediately necessary for the preservation  
3 of the public peace, health or safety, an emergency is hereby  
4 declared to exist, by reason whereof this act shall take effect and  
5 be in full force from and after its passage and approval.
