WHEREAS, federal, state, local and tribal police officers, sheriffs and other law enforcement officers in the State of Oklahoma and across the United States serve with valor, dignity, and integrity; and

WHEREAS, law enforcement officers are charged with pursuing justice for all individuals and performing the duties of a law enforcement officer with fidelity to the constitutional rights of the public that the law enforcement officers serve; and

WHEREAS, the Oklahoma House of Representatives expresses strong support for law enforcement officers in Oklahoma and across the United States in the efforts that those officers undertake to build safer and more secure communities; and

WHEREAS, the Oklahoma House of Representatives recognizes the law enforcement community for the continual selfless acts of sacrifice and bravery carried out by the members of that community; and
