12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY Section 3, Chapter 252, O.S.L.
14	2018 (63 O.S. Supp. 2020, Section 2-1002), is amended to read as
15	follows:
16	Section 2-1002. A. The Opioid Overdose Fatality Review Board
17	shall be composed of twenty (20) <u>twenty-one (21)</u> members, or their
18	designees, as follows:
19	1. Ten <u>Eleven</u> of the members shall be:
20	a. the Attorney General or designee,
21	b. the Chief Medical Examiner or designee,
22	c. the State Commissioner of Health or designee,
23	d. the Chief of Injury Prevention Services of the State
24 2 -	Department of Health or designee,

1	e. the President of the Oklahoma State Medical
2	Association or designee,
3	f. the Director of the Oklahoma Bureau of Narcotics and
4	Dangerous Drugs Control or designee,
5	g. the Commissioner of the Department of Mental Health
6	and Substance Abuse Services or designee,
7	h. the President of the Oklahoma Osteopathic Association
8	or designee,
9	i. the Director of the Department of Human Services or
10	designee, and
11	j. the Director of the Oklahoma State Bureau of
12	Investigation or designee, and
13	k. the President of the Association of Oklahoma Narcotic
14	Enforcers or designee; and
15	2. Ten of the members shall be appointed by the Attorney
16	General, shall serve for terms of two (2) years and shall be
17	eligible for reappointment. The members shall be persons having
18	training and experience in matters related to opioid abuse and
19	prevention. The appointed members shall include:
20	a. a county sheriff selected from a list of three names
21	submitted by the executive board of the Oklahoma
22	Sheriffs' Association,

2 three names submitted by the Oklahoma Supreme Court. 3 Β. Every two (2) years the Board shall elect from among its 4 membership a chair and a vice-chair. The Board shall meet at least 5 quarterly and may meet more frequently as necessary as determined by 6 the chair. Members shall serve without compensation but may be 7 reimbursed for necessary travel out of funds available to the Office 8 of the Attorney General and the Department of Mental Health and 9 Substance Abuse Services τ pursuant to the State Travel Reimbursement 10 Act; provided, that the reimbursement shall be paid in the case of 11 state employee members by the agency employing the member. 12 C. With funds appropriated or otherwise available for that 13

¹³ purpose, the Office of the Attorney General, jointly with the ¹⁴ Department of Mental Health and Substance Abuse Services, shall ¹⁵ provide administrative assistance and services to the Opioid ¹⁶ Overdose Fatality Review Board.
