8 An Act relating to agriculture; creating the  
9 International Livestock Judging Competition,  
10 Shooting, and Precision Sports Grant Act; creating  
11 the International Livestock Judging Competition,  
12 Shooting, and Precision Sports Revolving Fund;  
13 directing the Department of Agriculture, Food, and  
14 Forestry to administer the act; directing the State  
15 Board of Agriculture to promulgate rules and adopt  
16 certain guidelines; providing for grants; identifying  
17 eligible grant recipients; providing for grant  
18 limitations; providing for codification; and  
19 providing an effective date.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. NEW LAW A new section of law to be codified  
22 in the Oklahoma Statutes as Section 21-1 of Title 2, unless there is  
23 created a duplication in numbering, reads as follows:

24 This act shall be known and may be cited as the "International  
Livestock Judging Competition, Shooting, and Precision Sports Grant  
Act".

1 SECTION 2. NEW LAW A new section of law to be codified  
2 in the Oklahoma Statutes as Section 21-2 of Title 2, unless there is  
3 created a duplication in numbering, reads as follows:

4 A. There is hereby created in the State Treasury a revolving  
5 fund for the Oklahoma Department of Agriculture, Food, and Forestry  
6 to be designated the "International Livestock Judging Competition,  
7 Shooting, and Precision Sports Revolving Fund". The fund shall be a  
8 continuing fund, not subject to fiscal year limitations, and shall  
9 consist of all monies received by the State Board of Agriculture  
10 from state-appropriated funds, federal funds, donations, grants, and  
11 contributions from any public or private source and designated for  
12 the purpose set forth in this section. All monies accruing to the  
13 credit of the fund are hereby appropriated and may be budgeted and  
14 expended by the Oklahoma Department of Agriculture, Food, and  
15 Forestry for the purpose of administering the International  
16 Livestock Judging Competition, Shooting, and Precision Sports Grant  
17 Act. Expenditures from the fund shall be made upon warrants issued  
18 by the State Treasurer against claims filed as prescribed by law  
19 with the Director of the Office of Management and Enterprise  
20 Services for approval and payment.

21 B. The International Livestock Judging Competition, Shooting,  
22 and Precision Sports Revolving Fund shall never exceed Five Hundred  
23 Thousand Dollars (\$500,000.00) at any given time.

1 SECTION 3. NEW LAW A new section of law to be codified  
2 in the Oklahoma Statutes as Section 21-3 of Title 2, unless there is  
3 created a duplication in numbering, reads as follows:

4 A. The Department of Agriculture, Food, and Forestry shall  
5 administer the provisions of the International Livestock Judging  
6 Competition, Shooting, and Precision Sports Grant Act.

7 B. The State Board of Agriculture shall promulgate rules and  
8 adopt eligibility guidelines necessary to enforce and administer the  
9 International Livestock Judging Competition, Shooting, and Precision  
10 Sports Grant Act, including an application process for grants.  
11 Teams that receive grants must be comprised of Oklahoma students who  
12 are members of a National FFA Organization chapter or 4-H team that  
13 has won a national competition and is eligible to compete in an  
14 international livestock judging competition or members of a shooting  
15 and precision sports team that is eligible to compete in a national  
16 or international sports competition.

17 C. Grants shall be awarded to match the funds the teams have  
18 raised in a one-to-one ratio (1:1), the total amount not to exceed  
19 the estimated cost of the trip for an international livestock  
20 judging competition.

21 SECTION 4. This act shall become effective November 1, 2024.
