8 An Act relating to appropriations; creating the
9 Oklahoma Career Tech Higher Education Expansion
10 Revolving Fund; providing funding sources; declaring
purpose of fund; providing an effective date; and
declaring an emergency.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. There is hereby created in the State Treasury a
15 revolving fund for the Oklahoma Department of Career and Technology
16 Education to be designated the "Oklahoma Career Tech Higher
17 Education Expansion Revolving Fund". The fund shall be a continuing
18 fund, not subject to fiscal year limitations, and shall consist of
19 all monies received by the Oklahoma Department of Career and
20 Technology Education from monies appropriated or apportioned by the
21 Legislature and gifts, donations, and bequests. All monies accruing
22 to the credit of said fund are hereby appropriated and may be
23 budgeted and expended by the Oklahoma Department of Career and
24 Technology Education for the purpose of expanding career technology

1 education in areas where career technology institutions do not
2 currently exist in the northwestern region of Oklahoma as determined
3 by the Oklahoma Department of Career and Technology Education.
4 Expenditures from said fund shall be made upon warrants issued by
5 the State Treasurer against claims filed as prescribed by law with
6 the Director of the Office of Management and Enterprise Services for
7 approval and payment.

8 SECTION 2. This act shall become effective July 1, 2024.

9 SECTION 3. It being immediately necessary for the preservation
10 of the public peace, health or safety, an emergency is hereby
11 declared to exist, by reason whereof this act shall take effect and
12 be in full force from and after its passage and approval.
