Investigations, the Oklahoma State Bureau of  
Narcotics and Dangerous Drugs Control, the  
Department of Public Safety, the Department of  
Public Safety Patrol Academy Revolving Fund, the  
Office of the Attorney General, the Oklahoma  
Sheriff's Office Funding Assistance Revolving Fund,  
the Court of Criminal Appeals, district attorneys  
and the District Attorneys Council, the Domestic  
Violence and Sexual Assault Services Revolving  
Fund, the Supreme Court, the Oklahoma Indigent  
Defense System, the Pardon and Parole Board, the  
Council on Judicial Complaints, the Oklahoma Energy

1 Initiative Revolving Fund, the Multiple Injury  
2 Trust Fund, Special Cash Fund, the Oklahoma Capital  
3 Assets Maintenance and Protection Fund, the  
4 Progressing Rural Economic Prosperity Fund, and the  
5 Oklahoma Quick Action Closing Fund; stating amounts  
6 of the appropriations; stating purposes and  
7 restrictions; authorizing certain expenditures;  
8 directing certain transfers; and providing an  
9 effective date.

10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 EDUCATION

12 SECTION 1. There is hereby appropriated to the State Board of  
13 Education from any monies not otherwise appropriated from the  
14 General Revenue Fund of the State Treasury for the fiscal year  
15 ending June 30, 2025, the sum of One Billion Seven Hundred Ninety-  
16 two Million Six Hundred Thirty-one Thousand Seven Hundred Ninety-  
17 nine Dollars (\$1,792,631,799.00) or so much thereof as may be  
18 necessary for the financial support of public schools.

19 SECTION 2. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 Special Cash Fund of the State Treasury the sum of Twenty Million  
22 Dollars (\$20,000,000.00) or so much thereof as may be necessary for  
23 the financial support of public schools.

24 SECTION 3. There is hereby appropriated to the State Board of  
Education from any monies not otherwise appropriated from the  
Education Reform Revolving Fund, created in Section 34.89 of Title  
62 of the Oklahoma Statutes, the sum of One Billion Sixty-seven

1 Million Nine Hundred Fifteen Thousand Nine Hundred Twenty-four  
2 Dollars (\$1,067,915,924.00) or so much thereof as may be necessary  
3 for the financial support of public schools.

4 SECTION 4. The State Board of Education is hereby authorized to  
5 expend during the fiscal year ending June 30, 2025, from the Common  
6 Education Technology Revolving Fund of the State Treasury, the sum  
7 of Forty-seven Million Twenty-five Thousand Seven Hundred One  
8 Dollars (\$47,025,701.00) or so much thereof as may be necessary for  
9 the financial support of public schools.

10 SECTION 5. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Mineral Leasing Fund of the State Treasury for the fiscal year  
13 ending June 30, 2025, the sum of Four Million Five Hundred Twelve  
14 Thousand Five Hundred Dollars (\$4,512,500.00) or so much thereof as  
15 may be necessary for the financial support of public schools.

16 SECTION 6. There is hereby appropriated to the State Board of  
17 Education from any monies not otherwise appropriated from the  
18 Mineral Leasing Fund of the State Treasury for the fiscal year  
19 ending June 30, 2023, the sum of Seven Hundred Eighty Thousand Six  
20 Hundred Seventy-eight Dollars (\$780,678.00) or so much thereof as  
21 may be necessary for the financial support of public schools.

22 SECTION 7. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2025, the sum of Twenty-seven Million  
2 Seven Hundred Eighty-seven Thousand Five Hundred Dollars  
3 (\$27,787,500.00) or so much thereof as may be necessary for the  
4 financial support of public schools.

5 SECTION 8. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
8 fiscal year ending June 30, 2023, the sum of Three Million Six  
9 Hundred Thousand Nine Hundred Seventy-seven Dollars (\$3,600,977.00)  
10 or so much thereof as may be necessary for the financial support of  
11 public schools.

12 SECTION 9. There is hereby appropriated to the State Board of  
13 Education from any monies not otherwise appropriated from the  
14 General Revenue Fund of the State Treasury for the fiscal year  
15 ending June 30, 2025, the sum of One Hundred Twenty-six Million One  
16 Hundred Eighty-nine Thousand Twenty-six Dollars (\$126,189,026.00) or  
17 so much thereof as may be necessary for the support of public school  
18 activities.

19 SECTION 10. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 General Revenue Fund of the State Treasury for the fiscal year  
22 ending June 30, 2025, the sum of Three Hundred Sixty-five Million  
23 Seven Hundred Ninety-three Thousand Four Hundred Seventy Dollars  
24

1 (\$365,793,470.00) or so much thereof as may be necessary for the  
2 Certified Employee Health Benefit Allowance.

3 SECTION 11. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2025, the sum of Two Hundred Four Million Two  
7 Hundred Eleven Thousand Three Hundred Fifty-nine Dollars  
8 (\$204,211,359.00) or so much thereof as may be necessary for the  
9 Support Personnel Health Benefit Allowance.

10 SECTION 12. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 General Revenue Fund of the State Treasury for the fiscal year  
13 ending June 30, 2025, the sum of Nineteen Million One Hundred Forty-  
14 five Thousand Three Hundred Sixty-six Dollars (\$19,145,366.00) or so  
15 much thereof as may be necessary for administrative and support  
16 functions of the State Department of Education.

17 SECTION 13. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 General Revenue Fund of the State Treasury for the fiscal year  
20 ending June 30, 2023, the sum of Forty-five Million One Hundred  
21 Ninety Thousand Dollars (\$45,190,000.00) or so much thereof as may  
22 be necessary for the purchase of textbooks and instructional  
23 materials.

1 SECTION 14. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
4 fiscal year ending June 30, 2025, the sum of Three Million Eighty-  
5 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much  
6 thereof as may be necessary for transfer to the School Consolidation  
7 Assistance Fund.

8 SECTION 15. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
11 fiscal year ending June 30, 2023, the sum of Four Hundred Thousand  
12 One Hundred Nine Dollars (\$400,109.00) or so much thereof as may be  
13 necessary for transfer to the School Consolidation Assistance Fund.

14 SECTION 16. There is hereby appropriated to the State Board of  
15 Education from any monies not otherwise appropriated from the  
16 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
17 fiscal year ending June 30, 2025, the sum of Three Million Eighty-  
18 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much  
19 thereof as may be necessary for transfer to the Teachers' Retirement  
20 System Dedicated Revenue Revolving Fund.

21 SECTION 17. There is hereby appropriated to the State Board of  
22 Education from any monies not otherwise appropriated from the  
23 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
24 fiscal year ending June 30, 2023, the sum of Four Hundred Thousand

1 One Hundred Nine Dollars (\$400,109.00) or so much thereof as may be  
2 necessary for transfer to the Teachers' Retirement System Dedicated  
3 Revenue Revolving Fund.

4 SECTION 18. There is hereby appropriated to the State Board of  
5 Education from any monies not otherwise appropriated from the  
6 General Revenue Fund of the State Treasury for the fiscal year  
7 ending June 30, 2025, the sum of Two Million Six Hundred Fifty  
8 Thousand Dollars (\$2,650,000.00) for the purpose of compensating  
9 student teachers as defined by Section 1-116 of Title 70 of the  
10 Oklahoma Statutes.

11 SECTION 19. There is hereby appropriated to the State Board of  
12 Education for deposit in the State Public Common School Building  
13 Equalization Fund, created in Section 32 of Article X of the  
14 Oklahoma Constitution, from any monies not otherwise appropriated  
15 from the General Revenue Fund of the State Treasury for the fiscal  
16 year ending June 30, 2025, One Hundred Twenty-five Million Dollars  
17 (\$125,000,000.00) to be distributed as redbud school grants as  
18 provided in Section 3-104 of Title 70 of the Oklahoma Statutes.

19 SECTION 20. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 Special Cash Fund of the State Treasury, the sum of Two Million Five  
22 Hundred Thousand Dollars (\$2,500,000.00) to be transferred to the  
23 Public School Paid Maternity Leave Revolving Fund (294) pursuant to  
24



1 the provisions of Section 6-104.8 of Title 70 of the Oklahoma  
2 Statutes.

3 SECTION 21. For the fiscal year ending June 30, 2025, the State  
4 Board of Education is hereby authorized to transfer from the  
5 Teachers' Retirement System Dedicated Revenue Revolving Fund to the  
6 Teachers' Retirement System of Oklahoma, the sum of Four Hundred  
7 Forty-eight Million Three Hundred Fourteen Thousand Four Hundred  
8 Fifty-seven Dollars (\$448,314,457.00) and from the funds  
9 appropriated in Sections 16 and 17 of this act, in the amounts  
10 provided in those sections for the purposes prescribed in Section  
11 34.93 of Title 62 of the Oklahoma Statutes.

12 SECTION 22. There is hereby appropriated to the Oklahoma Arts  
13 Council from any monies not otherwise appropriated from the General  
14 Revenue Fund of the State Treasury for the fiscal year ending June  
15 30, 2025, the sum of Three Million Nine Hundred Fifty-two Thousand  
16 Three Hundred Twenty-five Dollars (\$3,952,325.00) or so much thereof  
17 as may be necessary to perform the duties imposed upon the Oklahoma  
18 Arts Council by law.

19 SECTION 23. There is hereby appropriated to the State Board of  
20 Career and Technology Education from any monies not otherwise  
21 appropriated from the General Revenue Fund of the State Treasury for  
22 the fiscal year ending June 30, 2025, the sum of One Hundred Sixty-  
23 three Million Nine Hundred One Thousand Five Hundred Five Dollars  
24 (\$163,901,505.00) or so much thereof as may be necessary to perform

1 the duties imposed upon the State Board of Career and Technology  
2 Education by law.

3 SECTION 24. There is hereby appropriated to the State Board of  
4 Career and Technology Education from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2023, the sum of Twenty-eight  
7 Million Five Hundred Ninety Thousand Dollars (\$28,590,000.00) or so  
8 much thereof as may be necessary to perform the duties imposed upon  
9 the State Board of Career and Technology Education by law.

10 SECTION 25. There is hereby appropriated to the State Board of  
11 Career and Technology Education from any monies not otherwise  
12 appropriated from the Oklahoma Education Lottery Trust Fund of the  
13 State Treasury for the fiscal year ending June 30, 2025, the sum of  
14 Three Million Three Hundred Ninety-six Thousand Two Hundred Fifty  
15 Dollars (\$3,396,250.00) pursuant to Section 713 of Title 3A of the  
16 Oklahoma Statutes for allocation by the State Board of Career and  
17 Technology Education for the education and general operating budgets  
18 of the institutions and for other programs, construction,  
19 renovations, or repairs administered by the State Board of Career  
20 and Technology Education.

21 SECTION 26. There is hereby appropriated to the State Board of  
22 Career and Technology Education from any monies not otherwise  
23 appropriated from the Oklahoma Education Lottery Trust Fund of the  
24 State Treasury for the fiscal year ending June 30, 2023, the sum of

1 Four Hundred Forty Thousand One Hundred Nineteen Dollars  
2 (\$440,119.00) pursuant to Section 713 of Title 3A of the Oklahoma  
3 Statutes for allocation by the State Board of Career and Technology  
4 Education for the education and general operating budgets of the  
5 institutions and for other programs, construction, renovations, or  
6 repairs administered by the State Board of Career and Technology  
7 Education.

8 SECTION 27. There is hereby appropriated to the Office of  
9 Educational Quality and Accountability from any monies not otherwise  
10 appropriated from the General Revenue Fund of the State Treasury for  
11 the fiscal year ending June 30, 2025, the sum of Two Million Ninety-  
12 seven Thousand Two Hundred Nine Dollars (\$2,097,209.00) or so much  
13 thereof as may be necessary to perform the duties imposed upon the  
14 Office of Educational Quality and Accountability by law. Of those  
15 funds appropriated, the sum of Sixty Thousand Dollars (\$60,000.00)  
16 shall be deposited in the Teaching Certification Scholarship  
17 Revolving Fund, created pursuant to Section 6-187C of Title 70 of  
18 the Oklahoma Statutes. Of those funds appropriated, the sum of One  
19 Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in  
20 the Education Leadership Oklahoma Revolving Fund, created pursuant  
21 to Section 6-204.3 of Title 70 of the Oklahoma Statutes.

22 SECTION 28. There is hereby appropriated to the Oklahoma  
23 Educational Television Authority from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2025, the sum of Two Million Nine  
2 Hundred Fifty-four Thousand Four Dollars (\$2,954,004.00) or so much  
3 thereof as may be necessary to perform the duties imposed upon the  
4 Oklahoma Educational Television Authority by law.

5 SECTION 29. There is hereby appropriated to the Oklahoma  
6 Educational Television Authority from any monies not otherwise  
7 appropriated from the General Revenue Fund of the State Treasury for  
8 the fiscal year ending June 30, 2023, the sum of Two Million Eight  
9 Hundred Fifty Thousand Dollars (\$2,850,000.00) or so much thereof as  
10 may be necessary for the replacement of rural transmitters.

11 SECTION 30. There is hereby appropriated to the Oklahoma State  
12 Regents for Higher Education from any monies not otherwise  
13 appropriated from the General Revenue Fund of the State Treasury for  
14 the fiscal year ending June 30, 2025, the sum of Eight Hundred  
15 Sixty-six Million Five Hundred Eighty-seven Thousand One Hundred  
16 Twenty-three Dollars (\$866,587,123.00) or so much thereof as may be  
17 necessary for allocation by the Oklahoma State Regents for Higher  
18 Education pursuant to the provisions of Article XIII-A of the  
19 Oklahoma Constitution for the education and general operating  
20 budgets of the institutions and for other programs, construction,  
21 renovations, or repairs administered by the Oklahoma State Regents  
22 for Higher Education. Of those funds appropriated, the sum of Three  
23 Million One Hundred Forty-nine Thousand Eight Hundred Ninety-seven  
24 Dollars (\$3,149,897.00) shall be transferred to the Oklahoma Tuition

1 Equalization Grant Trust Fund to implement the provisions of the  
2 Oklahoma Tuition Equalization Grant Act, and the sum of Twelve  
3 Million Five Hundred Thousand Dollars (\$12,500,000.00) shall be  
4 transferred to the Oklahoma National Guard Educational Assistance  
5 Revolving Fund, created in Section 3232 of Title 70 of the Oklahoma  
6 Statutes.

7 SECTION 31. The Oklahoma State Regents for Higher Education are  
8 hereby authorized to expend during the fiscal year ending June 30,  
9 2025, the sum of Forty-seven Million Twenty-five Thousand Seven  
10 Hundred One Dollars (\$47,025,701.00) from the Higher Education  
11 Capital Revolving Fund of the State Treasury for allocation by the  
12 Oklahoma State Regents for Higher Education pursuant to the  
13 provisions of Article XIII-A of the Oklahoma Constitution for the  
14 education and general operating budgets of the institutions and for  
15 other programs, construction, renovations, or repairs administered  
16 by the Oklahoma State Regents for Higher Education.

17 SECTION 32. The Oklahoma State Regents for Higher Education are  
18 hereby authorized to expend during the fiscal year ending June 30,  
19 2025, the sum of Forty-seven Million Twenty-five Thousand Seven  
20 Hundred One Dollars (\$47,025,701.00) from the Oklahoma Student Aid  
21 Revolving Fund of the State Treasury for allocation by the Oklahoma  
22 State Regents for Higher Education pursuant to the provisions of  
23 Article XIII-A of the Oklahoma Constitution for the education and  
24 general operating budgets of the institutions and for other

1 programs, construction, renovations, or repairs administered by the  
2 Oklahoma State Regents for Higher Education.

3 SECTION 33. There is hereby appropriated to the Oklahoma State  
4 Regents for Higher Education from any monies not otherwise  
5 appropriated from the Oklahoma Education Lottery Trust Fund of the  
6 State Treasury for the fiscal year ending June 30, 2025, the sum of  
7 Twenty-four Million Three Hundred Ninety-one Thousand Two Hundred  
8 Fifty Dollars (\$24,391,250.00) pursuant to Section 713 of Title 3A  
9 of the Oklahoma Statutes for allocation by the Oklahoma State  
10 Regents for Higher Education pursuant to the provisions of Article  
11 XIII-A of the Oklahoma Constitution for construction, renovations,  
12 or repairs administered by the Oklahoma State Regents for Higher  
13 Education or for any other purpose authorized by Section 713 of  
14 Title 3A of the Oklahoma Statutes.

15 SECTION 34. There is hereby appropriated to the Oklahoma State  
16 Regents for Higher Education from any monies not otherwise  
17 appropriated from the Oklahoma Education Lottery Trust Fund of the  
18 State Treasury for the fiscal year ending June 30, 2023, the sum of  
19 Three Million One Hundred Sixty Thousand Eight Hundred Fifty-seven  
20 Dollars (\$3,160,857.00) pursuant to Section 713 of Title 3A of the  
21 Oklahoma Statutes for allocation by the Oklahoma State Regents for  
22 Higher Education pursuant to the provisions of Article XIII-A of the  
23 Oklahoma Constitution for construction, renovations, or repairs  
24 administered by the Oklahoma State Regents for Higher Education or

1 for any other purpose authorized by Section 713 of Title 3A of the  
2 Oklahoma Statutes.

3 SECTION 35. There is hereby appropriated to the Oklahoma State  
4 Regents for Higher Education from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2025, the sum of Eighteen Million  
7 Eight Hundred Twenty-two Thousand Six Hundred Fifteen Dollars  
8 (\$18,822,615.00) or so much thereof as may be necessary for  
9 expenditures for concurrent enrollment pursuant to Section 628.13 of  
10 Title 70 of the Oklahoma Statutes.

11 SECTION 36. There is hereby appropriated to the Oklahoma State  
12 Regents for Higher Education from any monies not otherwise  
13 appropriated from the General Revenue Fund of the State Treasury for  
14 the fiscal year ending June 30, 2023, the sum of Four Million Two  
15 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars  
16 (\$4,232,974.00) or so much thereof as may be necessary for the  
17 general operating budget of the administrative offices of the  
18 Oklahoma State Regents for Higher Education.

19 SECTION 37. There is hereby appropriated to the Oklahoma State  
20 Regents for Higher Education from any monies not otherwise  
21 appropriated from the General Revenue Fund of the State Treasury for  
22 the fiscal year ending June 30, 2021, the sum of Twelve Million Five  
23 Hundred Thousand Dollars (\$12,500,000.00) for the purpose of  
24 purchasing casualty and property insurance.

1 SECTION 38. There is hereby appropriated to the Commissioners  
2 of the Land Office from any monies not otherwise appropriated from  
3 the Commissioners of the Land Office Fund of the State Treasury for  
4 the fiscal year ending June 30, 2025, the sum of Six Million Seven  
5 Hundred Three Thousand Four Hundred Twenty-one Dollars  
6 (\$6,703,421.00) or so much thereof as may be necessary to perform  
7 the duties imposed upon the Commissioners of the Land Office by law.

8 SECTION 39. There is hereby appropriated to the Oklahoma  
9 Department of Libraries from any monies not otherwise appropriated  
10 from the General Revenue Fund of the State Treasury for the fiscal  
11 year ending June 30, 2025, the sum of Five Million Three Hundred

14 the duties imposed upon the Oklahoma State Bureau of Investigation  
15 by law. Of the funds appropriated, a maximum of One Hundred  
16 Thousand Dollars (\$100,000.00) may be transferred to an agency  
17 special account for the purpose of purchasing evidence items, paying  
18 fees to informers or special employees, paying expenses incurred in  
19 the prosecution and defense of civil actions, and paying other  
20 expenses as incurred under the Evidence Fund activity in trying to  
21 apprehend and convict violators of the laws of the state. The  
22 Oklahoma State Bureau of Investigation shall report income to the  
23 Evidence Fund annually pursuant to the provisions of Sections 34.36  
24 and 34.42 of Title 62 of the Oklahoma Statutes. Of the funds



1 appropriated herein, the Oklahoma State Bureau of Investigation is  
2 authorized to transfer the sum of Two Hundred Fifty Thousand Dollars  
3 (\$250,000.00) to the Alaunna Raffield Revolving Fund, created  
4 pursuant to subsection B of Section 150.2 of Title 74 of Oklahoma  
5 Statutes.

6 SECTION 132. There is hereby appropriated to the Oklahoma State  
7 Bureau of Investigation from any monies not otherwise appropriated  
8 from the General Revenue Fund of the State Treasury for the fiscal  
9 year ending June 30, 2024, the sum of Four Million Nine Hundred  
10 Thousand Dollars (\$4,900,000.00) or so much thereof as may be  
11 necessary to perform the duties imposed upon the Oklahoma State  
12 Bureau of Investigation by law.

13 SECTION 133. There is hereby appropriated to the Council on Law  
14 Enforcement Education and Training from any monies not otherwise  
15 appropriated from the General Revenue Fund of the State Treasury for  
16 the fiscal year ending June 30, 2025, the sum of Five Million Two  
17 Hundred Eighty-nine Thousand One Hundred Ninety-four Dollars  
18 (\$5,289,194.00) or so much thereof as may be necessary to perform  
19 the duties imposed upon the Council on Law Enforcement Education and  
20 Training by law.

21 SECTION 134. There is hereby appropriated to the Council on Law  
22 Enforcement Education and Training from any monies not otherwise  
23 appropriated from the CLEET Fund for the fiscal year ending June 30,  
24 2025, the sum of Two Million Three Hundred Fifty-three Thousand

1 Sixty-four Dollars (\$2,353,064.00) or so much thereof as may be  
2 necessary to perform the duties imposed upon the Council on Law  
3 Enforcement Education and Training by law.

4 SECTION 135. There is hereby appropriated to the Council on Law  
5 Enforcement Education and Training from any monies not otherwise  
6 appropriated from the CLEET Fund for the fiscal year ending June 30,  
7 2023, the sum of Forty-one Thousand Nine Hundred Sixteen Dollars

16 (\$112,722,534.00) or so much thereof as may be necessary to perform  
17 the duties imposed upon the Department of Public Safety by law.

18 SECTION 140. There is hereby appropriated to the Department of  
19 Public Safety from any monies not otherwise appropriated from the  
20 General Revenue Fund of the State Treasury for the fiscal year  
21 ending June 30, 2023, the sum of Thirteen Million Two Hundred  
22 Seventy-four Thousand Nine Hundred Twenty Dollars (\$13,274,920.00)  
23 or so much thereof as may be necessary to perform the duties imposed  
24 upon the Department of Public Safety by law. Of the funds

1 appropriated herein, the Department of Public Safety is authorized

3 or so much as may be necessary to perform the duties imposed upon  
4 the Commission by law.

5 SECTION 173. There is hereby appropriated to the Oklahoma  
6 Energy Initiative Revolving Fund, created in Section 802.4 of Title  
7 17 of the Oklahoma Statutes, from any monies not otherwise  
8 appropriated from the General Revenue Fund of the State Treasury for  
9 the fiscal year ending June 30, 2021, the sum of Four Million  
10 Dollars (\$4,000,000.00) or so much thereof as may be necessary for  
11 the purpose of purchasing new or updating existing seismic  
12 monitoring equipment for the Oklahoma Geological Survey.

13 SECTION 174. There is hereby appropriated to the Oklahoma Quick  
14 Action Closing Fund, created pursuant to Section 48.2 of Title 62 of  
15 the Oklahoma Statutes, from any monies not otherwise appropriated  
16 from the General Revenue Fund of the State Treasury for the fiscal  
17 year ending June 30, 2023, the sum of Twenty Million Dollars  
18 (\$20,000,000.00), to be budgeted and expended by the Governor as  
19 authorized by law.

20 SECTION 175. There is hereby appropriated to the Oklahoma  
21 Capital Assets Maintenance and Protection Fund, created in Enrolled  
22 Senate Bill No. 1399 of the 2nd Session of the 59th Oklahoma  
23 Legislature, from any monies not otherwise appropriated from the  
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2023, Three Hundred Fifty Million Dollars  
2 (\$350,000,000.00) or so much thereof as may be necessary for the  
3 implementation of the provisions of Enrolled Senate Bill No. 1399 of  
4 the 2nd Session of the 59th Oklahoma Legislature.

5 SECTION 176. There is hereby appropriated to the Legacy Capital  
6 Financing Fund, created in Section 187B of Title 73 of the Oklahoma  
7 Statutes, from any monies not otherwise appropriated from the  
8 General Revenue Fund of the State Treasury for the fiscal year  
9 ending June 30, 2023, the sum of One Hundred Seventy-seven Million  
10 Dollars (\$177,000,000.00) to be administered in accordance with law.

11 SECTION 177. Appropriations, authorizations, and distributions  
12 directed in this act to or from a revolving fund of the State  
13 Treasury enacted during the 2nd Regular Session of the 59th Oklahoma  
14 Legislature shall be executable upon the later of the effective date  
15 for such applicable section of this act or upon the date of such  
16 fund's creation.

17 SECTION 178. Sections 1 through 156 and Sections 173 through  
18 176 of this act shall become effective July 1, 2024.
