All monies accruing to the credit of the 3 fund are hereby appropriated and may be budgeted and expended by the 4 5 Oklahoma Water Resources Board for the purpose provided for in this section. Expenditures from the fund shall be made upon warrants 6 issued by the State Treasurer against claims filed as prescribed by 7 law with the Director of the Office of Management and Enterprise 8 9 Services for approval and payment.

B. Notwithstanding any other provision of law, income and earnings on the fund shall accrue to the fund and may be used for the purposes provided for in this section.
