Multiple Injury Trust Fund, Special Cash Fund, the
Oklahoma Capital Assets Maintenance and Protection
Fund, the Progressing Rural Economic Prosperity Fund,
and the Oklahoma Quick Action Closing Fund; stating
amounts of the appropriations; stating purposes and
restrictions; authorizing certain expenditures;
directing certain transfers; and providing an
effective date.

2 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

3 EDUCATION

4 SECTION 1. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2025, the sum of One Billion Seven Hundred Ninety-
8 two Million Six Hundred Thirty-one Thousand Seven Hundred Ninety-
9 nine Dollars (\$1,792,631,799.00) or so much thereof as may be
10 necessary for the financial support of public schools.

11 SECTION 2. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Special Cash Fund of the State Treasury the sum of Twenty Million
14 Dollars (\$20,000,000.00) or so much thereof as may be necessary for
15 the financial support of public schools.

16 SECTION 3. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 Education Reform Revolving Fund, created in Section 34.89 of Title
19 62 of the Oklahoma Statutes, the sum of One Billion Sixty-seven
20 Million Nine Hundred Fifteen Thousand Nine Hundred Twenty-four
21 Dollars (\$1,067,915,924.00) or so much thereof as may be necessary
22 for the financial support of public schools.

23 SECTION 4. The State Board of Education is hereby authorized to
24 expend during the fiscal year ending June 30, 2025, from the Common

1 Education Technology Revolving Fund of the State Treasury, the sum
2 of Forty-seven Million Twenty-five Thousand Seven Hundred One
3 Dollars (\$47,025,701.00) or so much thereof as may be necessary for
4 the financial support of public schools.

5 SECTION 5. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Mineral Leasing Fund of the State Treasury for the fiscal year
8 ending June 30, 2025, the sum of Four Million Five Hundred Twelve
9 Thousand Five Hundred Dollars (\$4,512,500.00) or so much thereof as
10 may be necessary for the financial support of public schools.

11 SECTION 6. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Mineral Leasing Fund of the State Treasury for the fiscal year
14 ending June 30, 2023, the sum of Seven Hundred Eighty Thousand Six
15 Hundred Seventy-eight Dollars (\$780,678.00) or so much thereof as
16 may be necessary for the financial support of public schools.

17 SECTION 7. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the
20 fiscal year ending June 30, 2025, the sum of Twenty-seven Million
21 Seven Hundred Eighty-seven Thousand Five Hundred Dollars
22 (\$27,787,500.00) or so much thereof as may be necessary for the
23 financial support of public schools.

1 SECTION 8. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the
4 fiscal year ending June 30, 2023, the sum of Three Million Six
5 Hundred Thousand Nine Hundred Seventy-seven Dollars (\$3,600,977.00)
6 or so much thereof as may be necessary for the financial support of
7 public schools.

8 SECTION 9. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2025, the sum of One Hundred Twenty-six Million One
12 Hundred Eighty-nine Thousand Twenty-six Dollars (\$126,189,026.00) or
13 so much thereof as may be necessary for the support of public school
14 activities.

15 SECTION 10. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 General Revenue Fund of the State Treasury for the fiscal year
18 ending June 30, 2025, the sum of Three Hundred Sixty-five Million
19 Seven Hundred Ninety-three Thousand Four Hundred Seventy Dollars
20 (\$365,793,470.00) or so much thereof as may be necessary for the
21 Certified Employee Health Benefit Allowance.

22 SECTION 11. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2025, the sum of Two Hundred Four Million Two
2 Hundred Eleven Thousand Three Hundred Fifty-nine Dollars
3 (\$204,211,359.00) or so much thereof as may be necessary for the
4 Support Personnel Health Benefit Allowance.

5 SECTION 12. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2025, the sum of Nineteen Million One Hundred Forty-
9 five Thousand Three Hundred Sixty-six Dollars (\$19,145,366.00) or so
10 much thereof as may be necessary for administrative and support
11 functions of the State Department of Education.

12 SECTION 13. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 General Revenue Fund of the State Treasury for the fiscal year
15 ending June 30, 2023, the sum of Forty-five Million One Hundred
16 Ninety Thousand Dollars (\$45,190,000.00) or so much thereof as may
17 be necessary for the purchase of textbooks and instructional
18 materials.

19 SECTION 14. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 Oklahoma Education Lottery Trust Fund of the State Treasury for the
22 fiscal year ending June 30, 2025, the sum of Three Million Eighty-
23 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much
24

1 thereof as may be necessary for transfer to the School Consolidation
2 Assistance Fund.

3 SECTION 15. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2023, the sum of Four Hundred Thousand
7 One Hundred Nine Dollars (\$400,109.00) or so much thereof as may be
8 necessary for transfer to the School Consolidation Assistance Fund.

9 SECTION 16. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 Oklahoma Education Lottery Trust Fund of the State Treasury for the
12 fiscal year ending June 30, 2025, the sum of Three Million Eighty-
13 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much
14 thereof as may be necessary for transfer to the Teachers' Retirement
15 System Dedicated Revenue Revolving Fund.

16 SECTION 17. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 Oklahoma Education Lottery Trust Fund of the State Treasury for the
19 fiscal year ending June 30, 2023, the sum of Four Hundred Thousand
20 One Hundred Nine Dollars (\$400,109.00) or so much thereof as may be
21 necessary for transfer to the Teachers' Retirement System Dedicated
22 Revenue Revolving Fund.

23 SECTION 18. There is hereby appropriated to the State Board of
24 Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2025, the sum of Two Million Six Hundred Fifty
3 Thousand Dollars (\$2,650,000.00) for the purpose of compensating
4 student teachers as defined by Section 1-116 of Title 70 of the
5 Oklahoma Statutes.

6 SECTION 19. There is hereby appropriated to the State Board of
7 Education for deposit in the State Public Common School Building
8 Equalization Fund, created in Section 32 of Article X of the
9 Oklahoma Constitution, from any monies not otherwise appropriated
10 from the General Revenue Fund of the State Treasury for the fiscal
11 year ending June 30, 2025, One Hundred Twenty-five Million Dollars
12 (\$125,000,000.00) to be distributed as redbud school grants as
13 provided in Section 3-104 of Title 70 of the Oklahoma Statutes.

14 SECTION 20. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 Special Cash Fund of the State Treasury, the sum of Two Million Five
17 Hundred Thousand Dollars (\$2,500,000.00) to be transferred to the
18 Public School Paid Maternity Leave Revolving Fund (294) pursuant to
19 the provisions of Section 6-104.8 of Title 70 of the Oklahoma
20 Statutes.

21 SECTION 21. For the fiscal year ending June 30, 2025, the State
22 Board of Education is hereby authorized to transfer from the
23 Teachers' Retirement System Dedicated Revenue Revolving Fund to the
24 Teachers' Retirement System of Oklahoma, the sum of Four Hundred

1 Forty-eight Million Three Hundred Fourteen Thousand Four Hundred
2 Fifty-seven Dollars (\$448,314,457.00) and from the funds
3 appropriated in Sections 16 and 17 of this act, in the amounts
4 provided in those sections for the purposes prescribed in Section
5 34.93 of Title 62 of the Oklahoma Statutes.

6 SECTION 22. There is hereby appropriated to the Oklahoma Arts
7 Council from any monies not otherwise appropriated from the General
8 Revenue Fund of the State Treasury for the fiscal year ending June
9 30, 2025, the sum of Three Million Nine Hundred Fifty-two Thousand
10 Three Hundred Twenty-five Dollars (\$3,952,325.00) or so much thereof
11 as may be necessary to perform the duties imposed upon the Oklahoma
12 Arts Council by law.

13 SECTION 23. There is hereby appropriated to the State Board of
14 Career and Technology Education from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury for
16 the fiscal year ending June 30, 2025, the sum of One Hundred Sixty-
17 three Million Nine Hundred One Thousand Five Hundred Five Dollars
18 (\$163,901,505.00) or so much thereof as may be necessary to perform
19 the duties imposed upon the State Board of Career and Technology
20 Education by law.

21 SECTION 24. There is hereby appropriated to the State Board of
22 Career and Technology Education from any monies not otherwise
23 appropriated from the General Revenue Fund of the State Treasury for
24 the fiscal year ending June 30, 2023, the sum of Twenty-eight

1 Million Five Hundred Ninety Thousand Dollars (\$28,590,000.00) or so
2 much thereof as may be necessary to perform the duties imposed upon
3 the State Board of Career and Technology Education by law.

4 SECTION 25. There is hereby appropriated to the State Board of
5 Career and Technology Education from any monies not otherwise
6 appropriated from the Oklahoma Education Lottery Trust Fund of the
7 State Treasury for the fiscal year ending June 30, 2025, the sum of
8 Three Million Three Hundred Ninety-six Thousand Two Hundred Fifty
9 Dollars (\$3,396,250.00) pursuant to Section 713 of Title 3A of the
10 Oklahoma Statutes for allocation by the State Board of Career and
11 Technology Education for the education and general operating budgets
12 of the institutions and for other programs, construction,
13 renovations, or repairs administered by the State Board of Career
14 and Technology Education.

15 SECTION 26. There is hereby appropriated to the State Board of
16 Career and Technology Education from any monies not otherwise
17 appropriated from the Oklahoma Education Lottery Trust Fund of the
18 State Treasury for the fiscal year ending June 30, 2023, the sum of
19 Four Hundred Forty Thousand One Hundred Nineteen Dollars
20 (\$440,119.00) pursuant to Section 713 of Title 3A of the Oklahoma
21 Statutes for allocation by the State Board of Career and Technology
22 Education for the education and general operating budgets of the
23 institutions and for other programs, construction, renovations, or
24

1 repairs administered by the State Board of Career and Technology
2 Education.

3 SECTION 27. There is hereby appropriated to the Office of
4 Educational Quality and Accountability from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2025, the sum of Two Million Ninety-
7 seven Thousand Two Hundred Nine Dollars (\$2,097,209.00) or so much
8 thereof as may be necessary to perform the duties imposed upon the
9 Office of Educational Quality and Accountability by law. Of those
10 funds appropriated, the sum of Sixty Thousand Dollars (\$60,000.00)
11 shall be deposited in the Teaching Certification Scholarship
12 Revolving Fund, created pursuant to Section 6-187C of Title 70 of
13 the Oklahoma Statutes. Of those funds appropriated, the sum of One
14 Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in
15 the Education Leadership Oklahoma Revolving Fund, created pursuant
16 to Section 6-204.3 of Title 70 of the Oklahoma Statutes.

17 SECTION 28. There is hereby appropriated to the Oklahoma
18 Educational Television Authority from any monies not otherwise
19 appropriated from the General Revenue Fund of the State Treasury for
20 the fiscal year ending June 30, 2025, the sum of Two Million Nine
21 Hundred Fifty-four Thousand Four Dollars (\$2,954,004.00) or so much
22 thereof as may be necessary to perform the duties imposed upon the
23 Oklahoma Educational Television Authority by law.

24

1 SECTION 29. There is hereby appropriated to the Oklahoma
2 Educational Television Authority from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2023, the sum of Two Million Eight
5 Hundred Fifty Thousand Dollars (\$2,850,000.00) or so much thereof as
6 may be necessary for the replacement of rural transmitters.

7 SECTION 30. There is hereby appropriated to the Oklahoma State
8 Regents for Higher Education from any monies not otherwise
9 appropriated from the General Revenue Fund of the State Treasury for
10 the fiscal year ending June 30, 2025, the sum of Eight Hundred
11 Sixty-six Million Five Hundred Eighty-seven Thousand One Hundred
12 Twenty-three Dollars (\$866,587,123.00) or so much thereof as may be
13 necessary for allocation by the Oklahoma State Regents for Higher
14 Education pursuant to the provisions of Article XIII-A of the
15 Oklahoma Constitution for the education and general operating
16 budgets of the institutions and for other programs, construction,
17 renovations, or repairs administered by the Oklahoma State Regents
18 for Higher Education. Of those funds appropriated, the sum of Three
19 Million One Hundred Forty-nine Thousand Eight Hundred Ninety-seven
20 Dollars (\$3,149,897.00) shall be transferred to the Oklahoma Tuition
21 Equalization Grant Trust Fund to implement the provisions of the
22 Oklahoma Tuition Equalization Grant Act, and the sum of Twelve
23 Million Five Hundred Thousand Dollars (\$12,500,000.00) shall be
24 transferred to the Oklahoma National Guard Educational Assistance

1 Revolving Fund, created in Section 3232 of Title 70 of the Oklahoma
2 Statutes.

3 SECTION 31. The Oklahoma State Regents for Higher Education are
4 hereby authorized to expend during the fiscal year ending June 30,
5 2025, the sum of Forty-seven Million Twenty-five Thousand Seven
6 Hundred One Dollars (\$47,025,701.00) from the Higher Education
7 Capital Revolving Fund of the State Treasury for allocation by the
8 Oklahoma State Regents for Higher Education pursuant to the
9 provisions of Article XIII-A of the Oklahoma Constitution for the
10 education and general operating budgets of the institutions and for
11 other programs, construction, renovations, or repairs administered
12 by the Oklahoma State Regents for Higher Education.

13 SECTION 32. The Oklahoma State Regents for Higher Education are
14 hereby authorized to expend during the fiscal year ending June 30,
15 2025, the sum of Forty-seven Million Twenty-five Thousand Seven
16 Hundred One Dollars (\$47,025,701.00) from the Oklahoma Student Aid
17 Revolving Fund of the State Treasury for allocation by the Oklahoma
18 State Regents for Higher Education pursuant to the provisions of
19 Article XIII-A of the Oklahoma Constitution for the education and
20 general operating budgets of the institutions and for other
21 programs, construction, renovations, or repairs administered by the
22 Oklahoma State Regents for Higher Education.

23 SECTION 33. There is hereby appropriated to the Oklahoma State
24 Regents for Higher Education from any monies not otherwise

1 appropriated from the Oklahoma Education Lottery Trust Fund of the
2 State Treasury for the fiscal year ending June 30, 2025, the sum of
3 Twenty-four Million Three Hundred Ninety-one Thousand Two Hundred
4 Fifty Dollars (\$24,391,250.00) pursuant to Section 713 of Title 3A
5 of the Oklahoma Statutes for allocation by the Oklahoma State
6 Regents for Higher Education pursuant to the provisions of Article
7 XIII-A of the Oklahoma Constitution for construction, renovations,
8 or repairs administered by the Oklahoma State Regents for Higher
9 Education or for any other purpose authorized by Section 713 of
10 Title 3A of the Oklahoma Statutes.

11 SECTION 34. There is hereby appropriated to the Oklahoma State
12 Regents for Higher Education from any monies not otherwise
13 appropriated from the Oklahoma Education Lottery Trust Fund of the
14 State Treasury for the fiscal year ending June 30, 2023, the sum of
15 Three Million One Hundred Sixty Thousand Eight Hundred Fifty-seven
16 Dollars (\$3,160,857.00) pursuant to Section 713 of Title 3A of the
17 Oklahoma Statutes for allocation by the Oklahoma State Regents for
18 Higher Education pursuant to the provisions of Article XIII-A of the
19 Oklahoma Constitution for construction, renovations, or repairs
20 administered by the Oklahoma State Regents for Higher Education or
21 for any other purpose authorized by Section 713 of Title 3A of the
22 Oklahoma Statutes.

23 SECTION 35. There is hereby appropriated to the Oklahoma State
24 Regents for Higher Education from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2025, the sum of Eighteen Million
3 Eight Hundred Twenty-two Thousand Six Hundred Fifteen Dollars
4 (\$18,822,615.00) or so much thereof as may be necessary for
5 expenditures for concurrent enrollment pursuant to Section 628.13 of
6 Title 70 of the Oklahoma Statutes.

7 SECTION 36. There is hereby appropriated to the Oklahoma State
8 Regents for Higher Education from any monies not otherwise
9 appropriated from the General Revenue Fund of the State Treasury for
10 the fiscal year ending June 30, 2023, the sum of Four Million Two
11 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars
12 (\$4,232,974.00) or so much thereof as may be necessary for the
13 general operating budget of the administrative offices of the
14 Oklahoma State Regents for Higher Education.

15 SECTION 37. There is hereby appropriated to the Oklahoma State
16 Regents for Higher Education from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2021, the sum of Twelve Million Five
19 Hundred Thousand Dollars (\$12,500,000.00) for the purpose of
20 purchasing casualty and property insurance.

21 SECTION 38. There is hereby appropriated to the Commissioners
22 of the Land Office from any monies not otherwise appropriated from
23 the Commissioners of the Land Office Fund of the State Treasury for
24 the fiscal year ending June 30, 2025, the sum of Six Million Seven

1 Hundred Three Thousand Four Hundred Twenty-one Dollars
2 (\$6,703,421.00) or so much thereof as may be necessary to perform
3 the duties imposed upon the Commissioners of the Land Office by law.

4 SECTION 39. There is hereby appropriated to the Oklahoma
5 Department of Libraries from any monies not otherwise appropriated
6 from the General Revenue Fund of the State Treasury for the fiscal
7 year ending June 30, 2025, the sum of Five Million Three Hundred
8 Ninety Thousand Eight Hundred Sixty-two Dollars (\$5,390,862.00) or
9 so much thereof as may be necessary to perform the duties imposed
10 upon the Oklahoma Department of Libraries by law.

11 SECTION 40. There is hereby appropriated to the Oklahoma
12 Department of Libraries from any monies not otherwise appropriated
13 from the General Revenue Fund of the State Treasury for the fiscal
14 year ending June 30, 2021, the sum of Four Hundred Forty-eight
15 Thousand One Dollars (\$448,001.00) or so much thereof as may be
16 necessary to perform the duties imposed upon the Oklahoma Department
17 of Libraries by law.

18 SECTION 41. There is hereby appropriated to the Health Care
19 Workforce Training Commission from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2025, the sum of Ten Million Four
22 Hundred Eleven Thousand Seven Hundred Fourteen Dollars
23 (\$10,411,714.00) or so much thereof as may be necessary to perform

6 duties imposed upon the Council on Law Enforcement Education and
7 Training by law.

8 SECTION 136. There is hereby appropriated to the Council on Law
9 Enforcement Education and Training from any monies not otherwise
10 appropriated from the General Revenue Fund of the State Treasury for
11 the fiscal year ending June 30, 2024, the sum of Two Hundred Eighty-
12 seven Thousand Five Hundred Dollars (\$287,500.00) or so much thereof
13 as may be necessary to perform the duties imposed upon the Council
14 on Law Enforcement Education and Training by law.

15 SECTION 137. There is hereby appropriated to the Board of
16 Medicolegal Investigations from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2025, the sum of Sixteen Million
19 Three Hundred Nineteen Thousand One Hundred Forty-four Dollars
20 (\$16,319,144.00) or so much thereof as may be necessary to perform
21 the duties imposed upon the Board of Medicolegal Investigations by
22 law.

23 SECTION 138. There is hereby appropriated to the Oklahoma State
24 Bureau of Narcotics and Dangerous Drugs Control from any monies not

1 otherwise appropriated from the General Revenue Fund of the State
2 Treasury for the fiscal year ending June 30, 2025, the sum of Three
3 Million One Hundred Forty-five Thousand Three Hundred Thirty Dollars
4 (\$3,145,330.00) or so much thereof as may be necessary to perform
5 the duties imposed upon the Oklahoma State Bureau of Narcotics and
6 Dangerous Drugs Control by law.

7 SECTION 139. There is hereby appropriated to the Department of
8 Public Safety from any monies not otherwise appropriated from the
9 General Revenue Fund of the State Treasury for the fiscal year
10 ending June 30, 2025, the sum of One Hundred Twelve Million Seven
11 Hundred Twenty-two Thousand Five Hundred Thirty-four Dollars
12 (\$112,722,534.00) or so much thereof as may be necessary to perform
13 the duties imposed upon the Department of Public Safety by law.

14 SECTION 140. There is hereby appropriated to the Department of
15 Public Safety from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2023, the sum of Thirteen Million Two Hundred
18 Seventy-four Thousand Nine Hundred Twenty Dollars (\$13,274,920.00)
19 or so much thereof as may be necessary to perform the duties imposed
20 upon the Department of Public Safety by law. Of the funds
21 appropriated herein, the Department of Public Safety is authorized
22 to transfer an amount not to exceed Four Million Dollars
23 (\$4,000,000.00) to the Department of Public Safety Patrol Academy
24 Revolving Fund, created by Section 2-146 of Title 47 of the Oklahoma

1 Statutes, and the sum of Four Million Dollars (\$4,000,000.00) shall
2 be used for facility upgrades, repair, expansion, and replacement of
3 Oklahoma Highway Patrol facilities located in Ardmore, Oklahoma.

4 JUDICIARY

5 SECTION 141. There is hereby appropriated to the Office of the
6 Attorney General from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2025, the sum of Twenty-seven Million Four Hundred
9 Twenty-four Thousand Seventy-nine Dollars (\$27,424,079.00) or so
10 much thereof as may be necessary to perform the duties imposed upon
11 the Office of the Attorney General by law.

12 SECTION 142. The Office of the Attorney General is authorized
13 to transfer an amount not to exceed Three Hundred Twenty Thousand
14 Four Hundred Thirty Dollars (\$320,430.00) from the Attorney
15 General's Evidence Fund (700), created by Section 19 of Title 74 of
16 the Oklahoma Statutes, to the Attorney General's Revolving Fund
17 (200), created by Section 20 of Title 74 of the Oklahoma Statutes.

18 SECTION 143. There is hereby appropriated to the Domestic
19 Violence and Sexual Assault Services Revolving Fund, created in
20 Enrolled Senate Bill No. 2039 of the 2nd Session of the 59th
21 Oklahoma Legislature, from any monies not otherwise appropriated
22 from the General Revenue Fund of the State Treasury for the fiscal
23 year ending June 30, 2025, the sum of Seventeen Million Dollars
24 (\$17,000,000.00) or so much as may be necessary to carry out the

1 provisions of Enrolled Senate Bill No. 2039 of the 2nd Session of
2 the 59th Oklahoma Legislature.

3 SECTION 144. There is hereby appropriated to the Office of the
4 Attorney General from any monies not otherwise appropriated from the
5 General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2022, the sum of One Million Five Hundred Nine
7 Thousand Three Hundred Seventy-eight Dollars (\$1,509,378.00) to
8 transfer to the Legal Services Revolving Fund (250), created
9 pursuant to subsection G of Section 921.1 of Title 12 of the
10 Oklahoma Statutes.

11 SECTION 145. There is hereby appropriated to the Oklahoma
12 Sheriff's Office Funding Assistance Revolving Fund, created in
13 Enrolled House Bill No. 2914 of the 2nd Session of the 59th Oklahoma
14 Legislature, from any monies not otherwise appropriated from the
15 General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2021, the sum of Eighteen Million Dollars
17 (\$18,000,000.00) or so much thereof as may be necessary to carry out
18 the provisions of Enrolled House Bill No. 2914 of the 2nd Session of
19 the 59th Oklahoma Legislature.

20 SECTION 146. There is hereby appropriated to the Court of
21 Criminal Appeals from any monies not otherwise appropriated from the
22 General Revenue Fund of the State Treasury for the fiscal year
23 ending June 30, 2025, the sum of Four Million Six Hundred Eleven
24 Thousand Three Hundred Dollars (\$4,611,300.00) or so much thereof as

1 may be necessary to perform the duties imposed upon the Court of
2 Criminal Appeals by law.

3 SECTION 147. There is hereby appropriated to the District
4 Attorneys Council from any monies not otherwise appropriated from
5 the General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2025, the sum of Eighty-one Million One Hundred
7 Three Thousand Four Hundred Ninety-two Dollars (\$81,103,492.00) or
8 so much thereof as may be necessary to perform the duties imposed
9 upon the district attorneys and the District Attorneys Council by
10 law. Of the funds appropriated herein, the District Attorneys
11 Council shall transfer up to the sum of Four Hundred Ninety-one
12 Thousand Fourteen Dollars (\$491,014.00) or so much thereof as may be
13 required by the district attorneys and the District Attorneys
14 Council to the District Attorneys Evidence Fund for necessary
15 expenses relative to any case within the official responsibility of
16 the offices of the district attorneys as provided by Section 215.40
17 of Title 19 of the Oklahoma Statutes. Of the funds appropriated

14 (\$20,716,418.00) or so much thereof as may be necessary for the
15 financial support of the district courts.

16 SECTION 151. There is hereby appropriated to the Supreme Court
17 from any monies not otherwise appropriated from the General Revenue
18 Fund of the State Treasury for the fiscal year ending June 30, 2025,
19 the sum of Sixty-three Million Four Hundred Twenty-one Thousand
20 Twenty-four Dollars (\$63,421,024.00) or so much thereof as may be
21 necessary to perform the duties imposed upon the district courts by
22 law.

23 SECTION 152. There is hereby appropriated to the Oklahoma
24 Indigent Defense System from any monies not otherwise appropriated

1 from the General Revenue Fund of the State Treasury for the fiscal
2 year ending June 30, 2025, the sum of Twenty-four Million Eight
3 Hundred Seventy Thousand One Hundred Twenty-five Dollars
4 (\$24,870,125.00) or so much thereof as may be necessary to perform
5 the duties imposed upon the Oklahoma Indigent Defense System by law.

6 SECTION 153. There is hereby appropriated to the Pardon and
7 Parole Board from any monies not otherwise appropriated from the
8 General Revenue Fund of the State Treasury for the fiscal year
9 ending June 30, 2025, the sum of Two Million Six Hundred Four
10 Thousand Four Hundred Forty-six Dollars (\$2,604,446.00) or so much
11 thereof as may be necessary to perform the duties imposed upon the
12 Pardon and Parole Board by law.

13 SECTION 154. There is hereby appropriated to the Supreme Court
14 from the General Revenue Fund of the State Treasury for the fiscal
15 year ending June 30, 2025, the sum of Twenty-eight Million Four
16 Hundred Eight Thousand Two Hundred Thirty-two Dollars
17 (\$28,408,232.00) or so much thereof as may be necessary to perform
18 the duties imposed upon the Supreme Court or Court of Civil Appeals
19 by law. Of the funds appropriated herein, the Supreme Court is
20 authorized to transfer up to Ten Million Five Hundred Thousand
21 Dollars (\$10,500,000.00) to the Family Representation and Advocacy

14 Education from any monies not otherwise appropriated from the
15 General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2021, the sum of Seventy-eight Million Four Hundred
17 Thousand Dollars (\$78,400,000.00) to be transferred to the Ad
18 Valorem Reimbursement Fund, created pursuant to Section 193 of Title
19 62 of the Oklahoma Statutes, for the purpose of reimbursing counties
20 for school districts that claim a loss of revenue due to a tax
21 exemption granted pursuant to the provisions of Section 6B of
22 Article X of the Oklahoma Constitution.

23 SECTION 158. There is hereby appropriated to the Oklahoma Tax
24 Commission from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year

3 eight Thousand Dollars (\$5,658,000.00) to be transferred to the Ad
4 Valorem Reimbursement Fund, created pursuant to Section 193 of Title

6 that claim a loss of revenue due to a tax exemption granted to
7 veterans and their surviving spouses pursuant to the provisions of

13 Thousand Dollars (\$4,640,000.00) or so much thereof as may be
14 necessary to pay obligations of the fund.

15 SECTION 160. There is hereby appropriated to the State Board of
16 Education from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2023, the sum of Sixteen Million One
18 Hundred Thousand Dollars (\$16,100,000.00) or so much thereof as may

18 146 of Title 47 of the Oklahoma Statutes, from the General Revenue
19 Fund of the State Treasury for the fiscal year ending June 30, 2021,
20 the sum of Two Million Five Hundred Thousand Dollars (\$2,500,000.00)
21 or so much thereof as may be necessary to carry out the provisions
22 of such section.

23 SECTION 165. There is hereby appropriated to the District
24 Attorneys Council from any monies not otherwise appropriated from

1 the General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2021, the sum of One Million Four Hundred Fifty
3 Thousand Dollars (\$1,450,000.00) or so much thereof as may be
4 necessary to perform the duties imposed upon the Council by law. Of
5 the funds appropriated in this section, the Council may transfer an
6 amount not to exceed One Million Four Hundred Fifty Thousand Dollars
7 (\$1,450,000.00) to the Sexual Assault Examination Fund, created by

9 SECTION 166. There is hereby appropriated to the Office of the

16 Fund of the State Treasury from any monies not otherwise

18 Forty Million Dollars (\$40,000,000.00) for availability of
19 appropriation.

20 SECTION 168. There is hereby appropriated to the Special Cash
21 Fund of the State Treasury from any monies not otherwise
22 appropriated from the State Insurance Commissioner Revolving Fund
23 (200), the sum of Seven Million Eight Hundred Thousand Dollars
24 (\$7,800,000.00) for availability of appropriation.

1 SECTION 169. There is hereby appropriated to the Special Cash
2 Fund of the State Treasury from any monies not otherwise
3 appropriated from the Revolving Fund for the Office of the Secretary
4 of State (200), the sum of Seven Million Eight Hundred Thousand
5 Dollars (\$7,800,000.00) for availability of appropriation.

6 SECTION 170. There is hereby appropriated to the Special Cash
7 Fund of the State Treasury from any monies not otherwise
8 appropriated from the Medical Marijuana Tax Fund (205), the sum of
9 Twenty-eight Million One Hundred Thousand Dollars (\$28,100,000.00)
10 for availability of appropriation.

11 SECTION 171. There is hereby appropriated to the Progressing
12 Rural Economic Prosperity Fund, created in Section 256 of Title 62
13 of the Oklahoma Statutes, from the funds appropriated to the
14 Oklahoma Department of Commerce in Section 1 of Enrolled House Bill
15 No. 1038 of the 1st Extraordinary Session of the 59th Oklahoma
16 Legislature, the sum of Seventy Million Dollars (\$70,000,000.00) for
17 availability of appropriation.

18 SECTION 172. There is hereby appropriated to the Oklahoma
19 Workforce Commission from any monies not otherwise appropriated from
20 the General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2023, the sum of One Million Dollars (\$1,000,000.00)
22 or so much as may be necessary to perform the duties imposed upon
23 the Commission by law.

1 SECTION 173. There is hereby appropriated to the Oklahoma
2 Energy Initiative Revolving Fund, created in Section 802.4 of Title
3 17 of the Oklahoma Statutes, from any monies not otherwise
4 appropriated from the General Revenue Fund of the State Treasury for
5 the fiscal year ending June 30, 2021, the sum of Four Million
6 Dollars (\$4,000,000.00) or so much thereof as may be necessary for
7 the purpose of purchasing new or updating existing seismic
8 monitoring equipment for the Oklahoma Geological Survey.

9 SECTION 174. There is hereby appropriated to the Oklahoma Quick
10 Action Closing Fund, created pursuant to Section 48.2 of Title 62 of
11 the Oklahoma Statutes, from any monies not otherwise appropriated
12 from the General Revenue Fund of the State Treasury for the fiscal
13 year ending June 30, 2023, the sum of Twenty Million Dollars
14 (\$20,000,000.00), to be budgeted and expended by the Governor as
15 authorized by law.

16 SECTION 175. There is hereby appropriated to the Oklahoma
17 Capital Assets Maintenance and Protection Fund, created in Enrolled
18 Senate Bill No. 1399 of the 2nd Session of the 59th Oklahoma
19 Legislature, from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2023, Three Hundred Fifty Million Dollars
22 (\$350,000,000.00) or so much thereof as may be necessary for the
23 implementation of the provisions of Enrolled Senate Bill No. 1399 of
24 the 2nd Session of the 59th Oklahoma Legislature.

1 SECTION 176. There is hereby appropriated to the Legacy Capital
2 Financing Fund, created in Section 187B of Title 73 of the Oklahoma
3 Statutes, from any monies not otherwise appropriated from the
4 General Revenue Fund of the State Treasury for the fiscal year
5 ending June 30, 2023, the sum of One Hundred Seventy-seven Million
6 Dollars (\$177,000,000.00) to be administered in accordance with law.

7 SECTION 177. Appropriations, authorizations, and distributions
8 directed in this act to or from a revolving fund of the State
9 Treasury enacted during the 2nd Regular Session of the 59th Oklahoma
10 Legislature shall be executable upon the later of the effective date
11 for such applicable section of this act or upon the date of such
12 fund's creation.

13 SECTION 178. Sections 1 through 156 and Sections 173 through
14 176 of this act shall become effective July 1, 2024.
