10 identifying source; establishing amount; providing
purpose; providing for noncodification; and declaring
an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law not to be
16 codified in the Oklahoma Statutes reads as follows:

17 There is hereby appropriated to the Office of Management and
18 Enterprise Services from monies not otherwise appropriated from the
19 Statewide Recovery Fund of the State Treasury created in Enrolled
20 House Bill No. 3349 of the 2nd Session of the 58th Oklahoma
21 Legislature, the sum of Four Million Seven Hundred Thousand Dollars
22 (\$4,700,000.00) or so much thereof as may be necessary to pay for
23 expenses arising from implementing programs and expenditures in
24 accordance with actions taken by the Joint Committee on Pandemic

1 Relief Funding. Such funds shall be utilized in a manner consistent
2 with the recommendations adopted by the Joint Committee on Pandemic
3 Relief Funding on May 11, 2023.

4 SECTION 2. NEW LAW A new section of law not to be
5 codified in the Oklahoma Statutes reads as follows:

6 There is hereby appropriated to the ARPA Administrative Costs
7 Fund created in Enrolled House Bill No. 2940 of the 1st Session of
8 the 59th Oklahoma Legislature from monies not otherwise appropriated
9 from the Statewide Recovery Fund of the State Treasury created in
10 Enrolled House Bill No. 3349 of the 2nd Session of the 58th Oklahoma
11 Legislature, the sum of Five Million Eight Hundred Four Thousand
12 Dollars (\$5,804,000.00) or so much thereof as may be necessary to
13 pay for future administrative expenses approved by the Joint
14 Committee on Pandemic Relief Funding in association with
15 implementing, administering, or overseeing programs funded by the
16 Statewide Recovery Fund created in Enrolled House Bill No. 3349 of
17 the 2nd Session of the 58th Oklahoma Legislature.

18 SECTION 3. It being immediately necessary for the preservation
19 of the public peace, health or safety, an emergency is hereby
20 declared to exist, by reason whereof this act shall take effect and
21 be in full force from and after its passage and approval.
