15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 22 O.S. 2021, Section 152, as
17 amended by Section 1, Chapter 174, O.S.L. 2022 (22 O.S. Supp. 2023,
18 Section 152), is amended to read as follows:

19 Section 152. A. Prosecutions for the crimes of bribery,
20 embezzlement of public money, bonds, securities, assets or property
21 of the state or any county, school district, municipality or other
22 subdivision thereof, or of any misappropriation of public money,
23 bonds, securities, assets or property of the state or any county,
24 school district, municipality or other subdivision thereof,

1 falsification of public records of the state or any county, school
2 district, municipality or other subdivision thereof, and conspiracy
3 to defraud the State of Oklahoma or any county, school district,
4 municipality or other subdivision thereof in any manner or for any
5 purpose shall be commenced within seven (7) years after the
6 discovery of the crime; provided, however, prosecutions for the
7 crimes of embezzlement or misappropriation of public money, bonds,
8 securities, assets or property of any school district, including
9 those relating to student activity funds, or the crime of
10 falsification of public records of any independent school district,
11 the crime of criminal conspiracy, the crime of embezzlement pursuant
12 to Sections 1451 through 1461 of Title 21 of the Oklahoma Statutes,
13 the crime of False Personation or Identity Theft pursuant to
14 Sections 1531 through 1533.3 of Title 21 of the Oklahoma Statutes,
15 the financial exploitation of a vulnerable adult pursuant to
16 Sections 843.1, 843.3 and 843.4 of Title 21 of the Oklahoma
17 Statutes, or Medicaid fraud pursuant to Section 1005 of Title 56 of
18 the Oklahoma Statutes, shall be commenced within five (5) years
19 after the discovery of the crime.

20 B. Prosecutions for criminal violations of any state income tax
21 laws shall be commenced within five (5) years after the commission
22 of such violation.

23 C. 1. Prosecutions for sexual crimes against children,
24 specifically rape or forcible sodomy, sodomy, lewd or indecent

1 proposals or acts against children, involving minors in pornography
2 pursuant to Section 886, 888, 1111, 1111.1, 1113, 1114, 1021.2,
3 1021.3, 1040.12a or 1123 of Title 21 of the Oklahoma Statutes, child
4 abuse pursuant to Section 843.5 of Title 21 of the Oklahoma
5 Statutes, and child trafficking pursuant to Section 866 of Title 21
6 of the Oklahoma Statutes shall be commenced by the forty-fifth
7 birthday of the alleged victim. Prosecutions for such crimes
8 committed against victims eighteen (18) years of age or older, and
9 sexual abuse of a vulnerable adult pursuant to Section 843.1 of
10 Title 21 of the Oklahoma Statutes shall be commenced within twelve
11 (12) years after the discovery of the crime. As used in this
12 paragraph, "discovery" means the date that a physical or sexually
13 related crime involving a victim eighteen (18) years of age or older
14 is reported to a law enforcement agency.

15 2. However, prosecutions for the crimes listed in paragraph 1
16 of this subsection may be commenced at any time after the commission
17 of the offense if:

- 18 a. physical evidence is collected and preserved that is
19 capable of being tested to obtain a profile from
20 deoxyribonucleic acid (DNA), and
- 21 b. the identity of the offender is subsequently
22 established through the use of a DNA profile using
23 evidence listed in subparagraph a of this paragraph.

24

1 A prosecution under this exception must be commenced within
2 three (3) years from the date on which the identity of the suspect
3 is established by DNA testing.

4 3. No prosecution under this subsection shall be based upon the
5 memory of the victim that has been recovered through psychotherapy
6 unless there is some evidence independent of such repressed memory.

7 4. Any person who knowingly and willfully makes a false claim
8 pursuant to this subsection or a claim that the person knows lacks
9 factual foundation may be reported to local law enforcement for
10 criminal investigation and, upon conviction, shall be guilty of a
11 felony.

12 D. Prosecutions for criminal violations of any provision of the
13 Oklahoma Wildlife Conservation Code shall be commenced within three
14 (3) years after the commission of such offense.

15 E. Prosecutions for the crime of criminal fraud or workers'
16 compensation fraud pursuant to Section 1541.1, 1541.2, 1662 or 1663
17 of Title 21 of the Oklahoma Statutes shall commence within three (3)
18 years after the discovery of the crime, but in no event greater than
19 seven (7) years after the commission of the crime.

20 F. Prosecution for the crime of false or bogus check pursuant
21 to Section 1541.1, 1541.2, 1541.3 or 1541.4 of Title 21 of the
22 Oklahoma Statutes shall be commenced within five (5) years after the
23 commission of such offense.

1 G. Prosecution for the crime of solicitation for murder in the
2 first degree pursuant to Section 701.16 of Title 21 of the Oklahoma
3 Statutes shall be commenced within seven (7) years after the
4 discovery of the crime. For purposes of this subsection,
5 "discovery" means the date upon which the crime is made known to
6 anyone other than a person involved in the solicitation.

7 H. In all other cases a prosecution for a public offense must
8 be commenced within three (3) years after its commission.

9 I. Prosecution for the crime of accessory after the fact must
10 be commenced within the same statute of limitations as that of the
11 felony for which the person acted as an accessory.

12 J. Prosecution for the crime of arson pursuant to Section 1401,
13 1402, 1403, 1404 or 1405 of Title 21 of the Oklahoma Statutes shall
14 be commenced within seven (7) years after the commission of the
15 crime.

16 K. Prosecutions for criminal violations in which a deadly
17 weapon is used to commit a felony or prosecutions for criminal
18 violations in which a deadly weapon is used in an attempt to commit
19 a felony shall be commenced within seven (7) years after the
20 commission of the crime.

21 L. Prosecutions for the crime of human trafficking pursuant to
22 Section 748 of Title 21 of the Oklahoma Statutes shall be commenced
23 within three (3) years after discovery of the crime. For purposes
24

1 of this subsection, "discovery" means the date upon which the crime
2 is reported to a law enforcement agency.

3 SECTION 2. AMENDATORY 22 O.S. 2021, Section 1402, is
4 amended to read as follows:

5 Section 1402. As used in the Oklahoma Racketeer-Influenced and
6 Corrupt Organizations Act:

7 1. "Beneficial interest" includes:

8 a. the interest of a person as a beneficiary pursuant to
9 a trust, in which the trustee holds legal title to
10 personal or real property, or

11 b. the interest of a person as a beneficiary pursuant to
12 any other arrangement under which any other person
13 holds legal title to personal or real property for the
14 benefit of such person.

15 The term beneficial interest does not include the interest of a
16 stockholder in a corporation or the interest of a partner in either
17 a general or limited partnership;

18 2. "Enterprise" includes any individual, sole proprietorship,
19 partnership, corporation, trust, governmental entity, or other legal
20 entity, or any union, association, unincorporated association or
21 group of persons, associated in fact although not a legal entity,
22 involved in any lawful or unlawful project or undertaking or any
23 foreign organization that the United States Secretary of State has
24

1 designated a foreign terrorist organization pursuant to Title 8
2 U.S.C.A., Section 1189;

3 3. "Innocent party" includes bona fide purchasers and victims;

4 4. "Lien notice" means the notice pursuant to the provisions of
5 Section 1412 of this title;

6 5. "Pattern of racketeering activity" means two or more
7 occasions of conduct:

8 a. that include each of the following:

9 (1) constitute racketeering activity,

10 (2) are related to the affairs of the enterprise,

11 (3) are not isolated, and

12 (4) are not so closely related to each other and
13 connected in point of time and place that they
14 constitute a single event, and

15 b. where each of the following is present:

16 (1) at least one of the occasions of conduct occurred
17 after November 1, 1988,

18 (2) the last of the occasions of conduct occurred
19 within three (3) years, excluding any period of
20 imprisonment served by any person engaging in the
21 conduct, of a prior occasion of conduct, and

22 (3) for the purposes of Section 1403 of this title
23 each of the occasions of conduct constituted a
24 felony pursuant to the laws of this state;

1 6. "Pecuniary value" means:

2 a. anything of value in the form of money, a negotiable
3 instrument, or a commercial interest, or anything
4 else, the primary significance of which is economic
5 advantage, or

6 b. any other property or service that has a value in
7 excess of One Hundred Dollars (\$100.00);

8 7. "Person" means any individual or entity holding or capable
9 of holding a legal or beneficial interest in property;

10 8. "Personal property" includes any personal property, or any
11 interest in such personal property, or any right, including bank
12 accounts, debts, corporate stocks, patents or copyrights. Personal
13 property and beneficial interest in personal property shall be
14 deemed to be located where the trustee, the personal property, or
15 the instrument evidencing the right is located;

16 9. "Principal" means a person who engages in conduct
17 constituting a violation of the Oklahoma Racketeer-Influenced and
18 Corrupt Organizations Act or who is legally accountable for the
19 conduct of another who engages in a violation of the Oklahoma
20 Racketeer-Influenced and Corrupt Organizations Act;

21 10. "Racketeering activity" means engaging in, attempting to
22 engage in, conspiring to engage in, or soliciting, coercing, or
23 intimidating another person to engage in any conduct which is
24 chargeable or indictable as constituting a felony violation of one

1 or more of the following provisions of the Oklahoma Statutes,
2 regardless of whether such act is in fact charged or indicted:

3 a. relating to homicide pursuant to the provisions of
4 Section 651, 652, 653, 701.7, 701.8, 701.16, 711 or
5 716 of Title 21 of the Oklahoma Statutes or relating
6 to concealment of homicidal death pursuant to the
7 provisions of Section 543 of Title 21 of the Oklahoma
8 Statutes,

9 b. relating to kidnapping pursuant to the provisions of
10 Section 741, 745, 891 or 1119 of Title 21 of the
11 Oklahoma Statutes,

12 c. relating to sex offenses pursuant to the provisions of
13 Section 886, 888, 1021, 1021.2, 1021.4, 1024.2, 1111,
14 1111.1, 1114 or 1123 of Title 21 of the Oklahoma
15 Statutes,

16 d. relating to bodily harm pursuant to the provisions of
17 Section 645, 650, 650.2, 1289.16, 1302, 1303 or 1767.1
18 of Title 21 of the Oklahoma Statutes,

19 e. relating to theft, where the offense constitutes a
20 felony, pursuant to the provisions of Section 1704,
21 1707, 1708, 1709, 1710, 1711, 1713, 1716, 1719, 1720,
22 1721, 1722, 1723 or 1731 of Title 21 of the Oklahoma
23 Statutes,

24

- 1 f. relating to forgery pursuant to the provisions of
2 Section 1561, 1562, 1571, 1572, 1574, 1575, 1577,
3 1578, 1579, 1580, 1581, 1582, 1583, 1584, 1585, 1586,
4 1587, 1588, 1589, 1590, 1591 or 1593 of Title 21 of
5 the Oklahoma Statutes,
- 6 g. relating to robbery pursuant to the provisions of

4 In addition, "racketeering activity" may be proven by proof of
5 engaging in, attempting to engage in, conspiring to engage in, or
6 soliciting, coercing, or intimidating another person to engage in
7 any of the above described conduct within another state, regardless
8 of whether said conduct is chargeable or indictable in that state;

9 11. "Real property" means any real property or any interest in
10 real property, including any lease of, or mortgage upon real
11 property. Real property and beneficial interest in real property
12 shall be deemed to be located where the real property is located;

13 12. "Trustee" includes trustees, a corporate as well as a
14 natural person and a successor or substitute trustee in accordance
15 with the Oklahoma Trust Act; and

16 13. "Unlawful debt" means any money or other thing of value
17 constituting principal or interest of a debt that is unenforceable
18 in the courts of Oklahoma, because the debt was incurred or
19 contracted in violation of a law relating to the business of
20 gambling activity or in violation of federal or state law but does
21 not include any debt owed to a bank, savings and loan association,
22 credit union or supervised lender licensed by the Oklahoma
23 Administrator of Consumer Credit or to any debt referred or assigned
24 to a debt collection agency, which referral or assignment is

1 accepted in good faith by the debt collection agency as a debt
2 collectible under the Uniform Commercial Code or other laws of this
3 state and enforceable in the courts of this state.

4 SECTION 3. AMENDATORY 56 O.S. 2021, Section 1006, is
5 amended to read as follows:

6 Section 1006. A. Any person found to have committed any
7 violation of paragraphs 1 through 6 of subsection A of Section 1005
8 of this title shall be deemed guilty of Medicaid fraud.

9 B. 1. Any person committing Medicaid fraud where the aggregate
10 amount of payments illegally claimed or received is ~~Two Thousand~~
11 ~~Five Hundred Dollars (\$2,500.00)~~ One Thousand Dollars (\$1,000.00) or
12 more shall be guilty of a felony, and upon conviction thereof shall
13 pay a fine of not more than three times the amount of payments
14 illegally claimed or received or Ten Thousand Dollars (\$10,000.00)
15 whichever is greater, or be imprisoned for not more than three (3)
16 years, or by both such fine and imprisonment.

17 2. Any person committing Medicaid fraud where the aggregate
18 amount of payments illegally claimed or received is less than ~~Two~~
19 ~~Thousand Five Hundred Dollars (\$2,500.00)~~ One Thousand Dollars
20 (\$1,000.00) shall be guilty of a misdemeanor and upon conviction
21 thereof shall pay a fine of not more than three times the amount of
22 payments illegally claimed or received or One Thousand Dollars
23 (\$1,000.00) whichever is greater, or imprisoned for not more than
24 one (1) year, or by both such fine and imprisonment.

1 Any person who violates paragraph 7 of subsection A of Section
2 1005 of this title shall be guilty of a felony, and upon conviction
3 thereof shall pay a fine of not more than three times the amount of
4 payments (claimed or received) equaling the services which would
5 have been reflected in the absent records or Ten Thousand Dollars
6 (\$10,000.00), whichever is greater, or be imprisoned for not more
7 than three (3) years, or by both such fine and imprisonment.
8 Additionally, the person found guilty hereunder shall be liable for
9 the cost of the investigation, litigation, and attorney fees, which,
10 in addition to all fines assessed, shall be deposited in the
11 Attorney General's Medicaid Revolving Fund.

12 SECTION 4. This act shall become effective November 1, 2024.
