13 An Act relating to obscene material; amending 21 O.S.
14 2021, Section 1024.1, which relates to the Oklahoma
15 Law on Obscenity and Child Pornography; updating
16 statutory citations and language; adding definition;
17 defining terms; making certain acts unlawful;
18 providing exemption from liability under certain
19 circumstances; providing penalties; providing
20 preemption provisions; providing for codification;
21 and declaring an emergency.

22 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

23 SECTION 1. AMENDATORY 21 O.S. 2021, Section 1024.1, is
24 amended to read as follows:

25 Section 1024.1 A. As used in Sections 1021, ~~1021.1~~ through
26 ~~1021.4~~, ~~Sections 1022 through 1024~~ 1024.4, and Sections 1040.8
27 through 1040.24 of this title, "child pornography" means and
28 includes any visual depiction or individual image stored or

1 contained in any format on any medium including, but not limited to,
2 film, motion picture, videotape, photograph, negative, undeveloped
3 film, slide, photographic product, reproduction of a photographic
4 product, play or performance wherein a minor under the age of
5 eighteen (18) years is engaged in any act with a person, other than
6 his or her spouse, of sexual intercourse which is normal or
7 perverted, in any act of anal sodomy, in any act of sexual activity
8 with an animal, in any act of sadomasochistic abuse including, but
9 not limited to, flagellation or torture, or the condition of being
10 fettered, bound or otherwise physically restrained in the context of
11 sexual conduct, in any act of fellatio or cunnilingus, in any act of
12 excretion in the context of sexual conduct, in any lewd exhibition
13 of the uncovered genitals in the context of masturbation or other
14 sexual conduct, or where the lewd exhibition of the uncovered
15 genitals, buttocks or, if such minor is a female, the breast, has
16 the purpose of sexual stimulation of the viewer, or wherein a person
17 under the age of eighteen (18) years observes such acts or
18 exhibitions. Each visual depiction or individual image shall
19 constitute a separate item and multiple copies of the same identical
20 material shall each be counted as a separate item.

21 B. As used in Sections 1021 through 1024.4 and Sections 1040.8
22 through 1040.24 of this title:

23 1. "Obscene material" means and includes any representation,
24 performance, depiction or description of sexual conduct, whether in

1 any form or on any medium including still photographs, undeveloped
2 photographs, motion pictures, undeveloped film, videotape, optical,
3 magnetic or solid-state storage, CD or DVD, or a purely photographic
4 product or a reproduction of such product in any book, pamphlet,
5 magazine, or other publication or electronic or photo-optical
6 format, if ~~said~~ such items contain the following elements:

- 7 a. depictions or descriptions of sexual conduct which are
8 patently offensive as found by the average person
9 applying contemporary community standards,
- 10 b. taken as a whole, have as the dominant theme an appeal
11 to prurient interest in sex as found by the average
12 person applying contemporary community standards, and
- 13 c. a reasonable person would find the material or
14 performance taken as a whole lacks serious literary,
15 artistic, educational, political, or scientific
16 purposes or value.

17 The standard for obscenity applied in this section shall not apply
18 to child pornography;

19 2. "Performance" means and includes any display, live or
20 recorded, in any form or medium;

21 3. "Sexual conduct" means and includes any of the following:

- 22 a. acts of sexual intercourse including any intercourse
23 which is normal or perverted, actual or simulated,

24

1 b. acts of ~~deviate~~ deviant sexual conduct, including oral
2 and anal sodomy,

3 c. acts of masturbation,

4 d. acts of sadomasochistic abuse including but not
5 limited to:

6 (1) flagellation or torture by or upon any person who
7 is nude or clad in undergarments or in a costume
8 which is of a revealing nature, or

9 (2) the condition of being fettered, bound, or
10 otherwise physically restrained on the part of
11 one who is nude or so clothed,

12 e. acts of excretion in a sexual context, or

13 f. acts of exhibiting human genitals or pubic areas; ~~and~~

14 4. "Explicit child pornography" means material which a law
15 enforcement officer can immediately identify upon first viewing
16 without hesitation as child pornography; and

17 5. "Obscene material in the presence of minors" means the same
18 as "obscene material" as such term is defined in paragraph 1 of this
19 subsection when a minor is exposed to such material.

20 The types of sexual conduct described in paragraph 3 of this
21 subsection are intended to include situations when, if appropriate
22 to the type of conduct, the conduct is performed alone or between
23 members of the same or opposite sex or between humans and animals in
24 an act of apparent sexual stimulation or gratification.

1 SECTION 2. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1024.6 of Title 21, unless there
3 is created a duplication in numbering, reads as follows:

4 A. As used in this section:

5 1. "Adult performance" means any performance that contains
6 obscene material, if done in view of a minor or in a public place;

7 2. "Obscene material" shall have the same meaning as such term
8 is defined in subsection B of Section 1024.1 of Title 21 of the
9 Oklahoma Statutes;

10 3. "Minor" means an unmarried person under eighteen (18) years
11 of age; and

12 4. "Public place" means any area or space that the general
13 public may freely access without payment for admission; provided,
14 however, any place that limits access pursuant to an admissions
15 process or that restricts minors from entering the area or space to
16 participate or take part in any event shall be exempt from the
17 provisions of this section.

18 B. 1. It shall be unlawful for a person to engage in an adult
19 performance which contains obscene material, or for any political
20 subdivision of this state to allow, permit, organize, or authorize
21 the viewing of an adult performance which contains obscene material,
22 on public property or in a public place where a minor, as part of
23 the general public, will be exposed to view such adult performance.

24

1 2. A political subdivision acting in good faith in accordance
2 with the requirements of this subsection shall not be liable for the
3 acts of an individual or group in violation of this subsection.

4 C. Any person who violates the provisions of subsection B of
5 this section shall, upon conviction, be guilty of a misdemeanor
6 punishable by imprisonment in a county jail for a term not exceeding
7 one (1) year, or by a fine of not less than Five Hundred Dollars
8 (\$500.00) and not exceeding One Thousand Dollars (\$1,000.00), or by
9 both such fine and imprisonment.

10 D. The provisions of this section shall preempt any ordinance,
11 regulation, or restriction that was lawfully adopted or license that
12 was issued by a political subdivision of this state prior to the
13 effective date of this act that is in conflict with the provisions
14 of this section.

15 SECTION 3. It being immediately necessary for the preservation
16 of the public peace, health or safety, an emergency is hereby
17 declared to exist, by reason whereof this act shall take effect and
18 be in full force from and after its passage and approval.
