





15 ~~BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:~~

16 SECTION 1. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 427.27 of Title 63, unless there
18 is created a duplication in numbering, reads as follows:

19 A. There is hereby created the Oklahoma Medical Marijuana
20 Authority Executive Advisory Council.

21 B. The Oklahoma Medical Marijuana Authority Executive Advisory
22 Council shall consist of the following members and all appointees
23 shall serve their terms at the pleasure of the appointing authority
24 and may be removed or replaced without cause:

1 1. One member appointed by the Governor to represent all
2 citizens of this state;

3 2. One member appointed by the Speaker of the House of
4 Representatives who shall be a citizen from a county with a
5 population under twenty-five thousand (25,000) persons, as
6 determined by the latest Federal Decennial Census;

7 3. One member appointed by the President Pro Tempore of the
8 Senate who shall be a citizen from a municipality with a population
9 in excess of seventy-five thousand (75,000) persons, as determined
10 by the latest Federal Decennial Census;

11 4. One member who is a current medical marijuana business
12 license holder appointed by the Speaker of the House of
13 Representatives;

14 5. One member who is a current medical marijuana business
15 license holder appointed by the President Pro Tempore of the Senate;
16 and

17 6. One member appointed by the Governor who holds a medical
18 marijuana patient license.

19 C. The Executive Director of the Oklahoma Medical Marijuana
20 Authority shall chair the Advisory Council and provide staff and
21 administrative support to the Advisory Council.

22 D. The Advisory Council shall select a co-chair from the
23 membership of the Advisory Council.

24

1 E. Each member of the Advisory Council shall serve a term of
2 four (4) years from the date of appointment. Members of the
3 Advisory Council shall not serve more than two consecutive terms.

4 F. A majority of the members of the Advisory Council shall
5 constitute a quorum for the transaction of business and for taking
6 any official action. Official action of the Advisory Council must
7 have a favorable vote by a majority of the members present.

8 G. Appointed members who serve on the Advisory Council shall be
9 exempt from dual-office-holding prohibitions pursuant to Section 6
10 of Title 51 of the Oklahoma Statutes.

11 H. The Advisory Council may advise the Authority of recommended
12 changes to state policy, rules, or statutes.

13 I. The Advisory Council shall prepare and issue a report of its
14 findings and recommendations electronically to the Governor,
15 President Pro Tempore, and Speaker of the House by November 1, 2025,
16 and each year thereafter no later than November 1 of each year.

17 J. Members appointed pursuant to subsection B of this section
18 shall serve without compensation but shall be reimbursed for
19 expenses incurred in the performance of their duties in accordance
20 with the State Travel Reimbursement Act.

21 K. The Oklahoma Medical Marijuana Authority Executive Advisory
22 Council shall meet as often as necessary to conduct business but
23 shall meet not less than four times a year, with an organizational
24 meeting to be held prior to January 1, 2025.

1 L. Any vacancy occurring on the Oklahoma Medical Marijuana
2 Authority Executive Advisory Council shall be filled for the
3 unexpired term of office in the same manner as provided for in
4 subsection B of this section.

5 M. The Advisory Council shall act in accordance with the
6 provisions of the Oklahoma Open Meeting Act, the Oklahoma Open
7 Records Act, and the Administrative Procedures Act.

8 SECTION 2. This act shall become effective November 1, 2024.
