22 B. The Department shall be the legal successor of and, except  
23 as otherwise provided in the Oklahoma Corrections Act of 1967, shall  
24 have the powers and duties vested by law in the Office of Management

1 and Enterprise Services in all matters relating to penal  
2 institutions, heretofore or hereafter established by the Department,  
3 which institutions and community corrections centers shall be under  
4 the administrative direction and control of the Department.

5 SECTION 2. AMENDATORY 57 O.S. 2021, Section 502, is  
6 amended to read as follows:

7 Section 502. As used in this title, unless the context  
8 otherwise requires:

- 9 1. "Board" means the State Board of Corrections;
- 10 2. "Department" means the Department of Corrections of this  
11 state;
- 12 3. "Director" means the Director of the Department of  
13 Corrections;
- 14 4. "Halfway house" means a private facility for the placement  
15 of inmates in a community setting for the purpose of reintegrating  
16 into the community inmates who are nearing their release dates. The  
17 term shall not include private prisons;
- 18 5. "Institutions" means the Oklahoma State Penitentiary located  
19 at McAlester, Oklahoma; the Oklahoma State Reformatory located at  
20 Granite, Oklahoma; the Lexington Assessment and Reception Center  
21 located at Lexington, Oklahoma; the Joseph Harp Correctional Center  
22 located at Lexington, Oklahoma; the Jackie Brannon Correctional  
23 Center located at McAlester, Oklahoma; the Howard ~~C.~~ McLeod  
24 Correctional Center located at ~~Farris~~ Atoka, Oklahoma; the Mack H.

1 Alford Correctional Center located at Stringtown, Oklahoma; the Jim  
2 E. Hamilton Correctional Center located at Hodgen, Oklahoma; the  
3 Mabel Bassett Correctional Center located at McLoud, Oklahoma; the  
4 R.B. "Dick" Conner Correctional Center located at Hominy, Oklahoma;  
5 the James Crabtree Correctional Center located at Helena, Oklahoma;  
6 the Jess Dunn Correctional Center located at Taft, Oklahoma; the  
7 John Lilley Correctional Center located at Boley, Oklahoma; the  
8 William S. Key Correctional Center located at Fort Supply, Oklahoma;  
9 the Dr. Eddie ~~Walter~~ Warrior Correctional Center located at Taft,  
10 Oklahoma; the Northeast Oklahoma ~~Correctional~~ Community Corrections  
11 Center located at Vinita, Oklahoma; the Clara Waters and Kate  
12 Barnard Community Corrections Centers located at Oklahoma City,  
13 Oklahoma; the Community Corrections Centers located at Lawton, Enid,  
14 Oklahoma City and Union City; the Charles E. "Bill" Johnson  
15 Correctional Center, located east of Alva, Oklahoma; the Southern  
16 Oklahoma Resource Center located at Pauls Valley, Oklahoma; and  
17 other facilities under the jurisdiction and control of the  
18 Department of Corrections or hereafter established by the Department  
19 of Corrections;

20 6. "Intermediate revocation facility" means a corrections  
21 center operated by the Department of Corrections or a private  
22 facility or public trust operating pursuant to contract with the  
23 Department of Corrections which provides housing and intensive  
24 programmatic services for offenders who have violated the terms or

1 conditions of probation as determined by a supervising probation  
2 officer. "Intensive programmatic services" offered by the  
3 Department of Corrections includes, but shall not be limited to,  
4 alcohol and substance abuse counseling and treatment, mental health  
5 counseling and treatment and domestic violence courses and treatment  
6 programs;

7 7. "Intermediate sanctions facility" means a community  
8 corrections center operated by the Department of Corrections or a  
9 private facility or public trust operating pursuant to contract with  
10 the Department of Corrections which provides for the housing and  
11 programmatic services of offenders such as probation or parole  
12 violators or community sentenced offenders placed in the facility  
13 for disciplinary sanctions, work release offenders, offenders who  
14 need intensive programmatic services, or offenders who have  
15 demonstrated positive adjustment while in an institutional setting  
16 who need additional programmatic services to enhance their reentry  
17 into society upon release from a prison term; and

18 8. "Private prison contractor" means:

19 a. a nongovernmental entity or public trust which,  
20 pursuant to a contract with the Department of  
21 Corrections, operates an institution within the  
22 Department other than a halfway house or intermediate  
23 sanctions facility, or provides for the housing, care,  
24 and control of inmates and performs other functions

1 related to these responsibilities within a minimum,  
2 medium, or maximum security level facility not owned  
3 by the Department but operated by the contractor, or  
4 b. a nongovernmental entity or public trust which,  
5 pursuant to a contract with the United States or  
6 another state, provides for the housing, care, and  
7 control of minimum or medium security inmates in the  
8 custody of the United States or another state, and  
9 performs other functions related to these  
10 responsibilities other than a halfway house or  
11 intermediate sanctions facility within a facility  
12 owned or operated by the contractor.

13 SECTION 3. This act shall become effective November 1, 2023.
