11 An Act relating to counties and county officers;
12 amending 19 O.S. 2021, Section 339, as amended by
13 Section 1, Chapter 333, O.S.L. 2022 (19 O.S. Supp.
14 2022, Section 339), which relates to general powers
15 of county commissioners; authorizing commissioners to
16 determine years of service for certain employees for
17 continuing education programs; expanding courses
18 offered; and providing an effective date.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. AMENDATORY 19 O.S. 2021, Section 339, as
21 amended by Section 1, Chapter 333, O.S.L. 2022 (19 O.S. Supp. 2022,
22 Section 339), is amended to read as follows:

23 Section 339. A. The board of county commissioners shall have
24 power:

1 1. To make all orders respecting the real property of the
2 county, to sell the public grounds of the county and to purchase
3 other grounds in lieu thereof; and for the purpose of carrying out
4 the provisions of this section it shall be sufficient to convey all
5 the interests of the county in those grounds when an order made for
6 the sale and a deed is executed in the name of the county by the
7 chair of the board of county commissioners, reciting the order, and
8 signed by the chair and acknowledged by the county clerk for and on
9 behalf of the county;

10 2. To audit the accounts of all officers having the care,
11 management, collection or disbursement of any money belonging to the
12 county or appropriated for its benefit;

13 3. To construct and repair bridges and to open, lay out and
14 vacate highways; provided, however, that when any state institution,
15 school or department shall own, lease or otherwise control land on
16 both sides of any established highway, the governing board or body
17 of the same shall have the power to vacate, alter or relocate the
18 highway adjoining the property in the following manner:

19 If it should appear that it would be to the best use and
20 interest of the institution, school or department to vacate, alter
21 or relocate such highway, the governing board or body shall notify
22 the board of county commissioners, in writing, of their intention to
23 hold a public hearing and determine whether to vacate, alter or
24 relocate the highway, setting forth the location and terminals of

1 the road, and all data concerning the proposed right-of-way if
2 changed or relocated, and shall give fifteen (15) days' notice of
3 the hearing by publication in some newspaper in the county or
4 counties in which the road is located, and the hearing shall be held
5 at the county seat of the county in which the road is located, and
6 if a county line road, may be heard in either county. At the
7 hearing testimony may be taken, and any protests or suggestions
8 shall be received as to the proposed measure, and at the conclusion
9 thereof if the governing board or body shall find that it would be
10 to the best use and interest of the institution, school or
11 department, and the public generally, they may make an appropriate
12 order either vacating, altering or relocating the highway, which
13 order shall be final if approved by the board of county
14 commissioners. The institution, school or department may by
15 agreement share the cost of changing any such road. No property
16 owner shall be denied access to a public highway by the order;

17 4. To recommend or sponsor an employee or prospective employee
18 for job-related training and certification in an area that may
19 require training or certification to comply with state or federal
20 law as such training or certification is provided by the Department
21 of Transportation, the Federal Highway Administration, or any other
22 state agency, technology center school, or university;

23 5. To ~~approve~~ determine the years of service required for full-
24 time county employees to qualify for a continuing education program

1 ~~for full-time county employees with at least five (5) consecutive~~
2 ~~years of service to the county.~~ Such programs shall may consist of
3 courses offered by colleges and universities that are members of The
4 Oklahoma State System of Higher Education as well as any other in-
5 state or out-of-state programs or courses which are relevant to the
6 employee's responsibilities as approved by the county commissioners.
7 Such programs shall require that employees maintain at least an A or
8 B average in order to qualify for one hundred percent (100%)
9 reimbursement. Employees who maintain passing or satisfactory
10 grades shall qualify for seventy- five percent (75%) reimbursement
11 under such programs. Such programs shall require that documentation
12 from colleges and universities regarding courses completed, credits
13 earned and tuition charged be submitted to a board of county
14 commissioners within ninety (90) days after the completion of
15 courses. General applications and request forms for such programs
16 shall be submitted to a board of county commissioners or an
17 appropriate human resources department prior to the conclusion of a
18 county's current fiscal year. Employees who elect to participate in
19 such programs shall continue to meet the full responsibilities of
20 their positions, and participation shall not interfere with
21 availability for scheduled work or negatively affect work
22 performance. In order to be eligible for participation in such
23 programs, employees shall not have been formally disciplined within
24 one (1) year prior to submitting their program application. A board

1 of county commissioners shall be authorized to establish a program
2 requiring a one-year commitment of service to the county from
3 individuals who participate in such programs. Under such programs,
4 employees shall only be eligible to receive tuition reimbursements
5 in exchange for employment with the county lasting at least one (1)
6 year;

7 6. Until January 1, 1983, to furnish necessary blank books,
8 plats, blanks and stationery for the clerk of the district court,
9 county clerk, register of deeds, county treasurer and county judge,
10 sheriff, county surveyor and county attorney, justices of the peace,
11 and constables, to be paid for out of the county treasury; also a
12 fireproof vault sufficient in which to keep all the books, records,
13 vouchers and papers pertaining to the business of the county;

14 7. To set off, organize and change the boundaries of townships
15 and to designate and give names therefor; provided, that the
16 boundaries of no township shall be changed within six (6) months
17 next preceding a general election;

18 8. To lease tools, apparatus, machinery or equipment of the
19 county to another political subdivision or a state agency. The
20 Association of County Commissioners of Oklahoma and the Oklahoma
21 State University Center for Local Government Technology together
22 shall establish a system of uniform rates for the leasing of such
23 tools, apparatus, machinery and equipment;

1 9. To jointly, with other counties, buy heavy equipment and to
2 loan or lease such equipment across county lines;

3 10. To develop personnel policies for the county with the
4 approval of a majority of all county elected officers, as evidenced
5 in the minutes of a meeting of the board of county commissioners or
6 the county budget board;

7 11. To purchase, rent, or lease-purchase uniforms, safety
8 devices and equipment for the officers and employees of the county.
9 The county commissioners may pay for any safety training or safety
10 devices and safety equipment out of the general county funds or any
11 county highway funds available to the county commissioners;

12 12. To provide incentive awards for safety-related job
13 performance. However, no employee shall be recognized more than
14 once per calendar year and the award shall not exceed the value of
15 Two Hundred Fifty Dollars (\$250.00); further, no elected official
16 shall be eligible to receive a safety award;

17 13. To provide for payment of notary commissions, filing fees,
18 and the cost of notary seals and bonds;

19 14. To do and perform other duties and acts that the board of
20 county commissioners may be required by law to do and perform;

21 15. To make purchases at a public auction pursuant to the
22 county purchasing procedures in subsection D of Section 1505 of this
23 title;

1 16. To deposit interest income from highway funds in the
2 general fund of the county;

3 17. To submit sealed bids for the purchase of equipment from
4 this state, or any agency or political subdivision of this state;

5 18. To utilize county-owned equipment, labor and supplies at
6 their disposal on property owned by the county, public schools, two-
7 year colleges or technical branches of colleges that are members of
8 The Oklahoma State System of Higher Education, the state and
9 municipalities according to the provisions of Section 36-113 of
10 Title 11 of the Oklahoma Statutes. Cooperative agreements may be
11 general in terms of routine maintenance or specific in terms of
12 construction and agreed to and renewed on an annual basis. Work
13 performed pursuant to Section 36-113 of Title 11 of the Oklahoma
14 Statutes shall comply with the provisions of this section;

15 19. To enter into intergovernmental cooperative agreements with
16 the federally recognized Indian tribes within this state to address
17 issues of construction and maintenance of streets, roads, bridges
18 and highways exclusive of the provisions of Section 1221 of Title 74
19 of the Oklahoma Statutes;

20 20. To execute hold harmless agreements with the lessor in the
21 manner provided by subsection B of Section 636.5 of Title 69 of the
22 Oklahoma Statutes when leasing or lease-purchasing equipment;

1 21. To accept donations of right-of-way or right-of-way
2 easements pursuant to Section 381 et seq. of Title 60 of the
3 Oklahoma Statutes;

4 22. To establish by resolution the use of per diem for specific
5 purposes in accordance with the limitations provided by Sections
6 500.8 and 500.9 of Title 74 of the Oklahoma Statutes;

7 23. To apply to the Department of Environmental Quality for a
8 waste tire permit to bale waste tires for use in approved
9 engineering projects;

10 24. To enter into the National Association of Counties (NACo)
11 Prescription Drug Discount Program;

12 25. To work with federal, state, municipal, and public school
13 district properties in an effort to minimize cost to such entities;

14 26. To provide incentive awards to employees for participating
15 in voluntary wellness programs which result in improved health.
16 Incentive awards may be created by the Wellness Council set forth in
17 Section 1302 of this title;

18 27. To establish a county employee benefit program to encourage
19 outstanding performance in the workplace. Monies may be expended
20 for the purchase of recognition awards for presentation to an
21 employee or members of a work unit. Recognition awards may be
22 presented at a formal or informal ceremony, banquet, reception or
23 luncheon, the cost of which may be expended from monies available in
24 the county department's or division's operating fund;

1 28. To trade in equipment to a vendor or on statewide contract
2 by acquiring used equipment values pursuant to subsection B of
3 Section 421.1 of this title; and

4 29. To expend federal funds made available to a county of the
5 state through the federal Coronavirus Aid, Relief, and Economic
6 Security Act (CARES Act), Pub. L. 116-136, or similar relief funds
7 according to the permissible uses of the applicable federal
8 legislation or guidance issued by any federal agency thereof,
9 regardless of any lack of specific state statutory authorization to
10 perform the duties or functions for which the federal government has
11 provided the funds. The expenditure of the funds in accordance with
12 the federal legislation or guidance issued by any federal agency
13 thereof shall be at the discretion of the board of county
14 commissioners.

15 The receipt of funding through the CARES Act or similar relief
16 funds shall not be considered a supplemental appropriation and shall
17 be exempt from the requirements of Section 1420 of this title. In
18 the event the period allotted for expenditure of federal funds
19 crosses fiscal years, such funds shall not be considered revenue
20 when setting the county's budget for the next fiscal year.

21 B. The county commissioners of a county or, in counties where
22 there is a county budget board, the county budget board may
23 designate money from general county funds for the designated purpose
24

1 of drug enforcement and drug abuse prevention programs within the
2 county.

3 C. When any lease or lease purchase is made on behalf of the
4 county by the board pursuant to the provisions of this section, the
5 county shall be allowed to have trade in values for transactions
6 involving the Oklahoma Central Purchasing Act.

7 D. In order to timely comply with the Oklahoma Vehicle License
8 and Registration Act with regard to county vehicles, the board of
9 county commissioners may, by resolution, create a petty cash
10 account. The board of county commissioners may request a purchase
11 order for petty cash in an amount necessary to pay the expense of
12 license and registration fees for county motor vehicles. Any
13 balance in the petty cash account after the license and registration
14 fees have been paid shall be returned to the account or fund from
15 which the funds originated. The county purchasing agent shall be
16 the custodian of the petty cash account, and the petty cash account
17 shall be subject to audit.

18 E. When the board of county commissioners approves an express
19 trust, pursuant to Sections 176 through 180.4 of Title 60 of the
20 Oklahoma Statutes, for the purpose of operating a county jail, the
21 trustees of the public trust may appoint commissioned peace
22 officers, certified by the Council on Law Enforcement Education and
23 Training, to provide security for inmates that are required to be
24 transported outside of the detention facility, and investigate

1 violations of law within the detention facility. Other personnel
2 necessary to operate the jail may be employed and trained or
3 certified as may be required by applicable state or federal law.

4 SECTION 2. This act shall become effective November 1, 2023.
