9 An Act relating to elections; amending 26 O.S. 2021,  
10 Section 4-101, which relates to voter registration;  
11 modifying conditions for voter eligibility; and  
12 providing an effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 26 O.S. 2021, Section 4-101, is  
15 amended to read as follows:

16 Section 4-101. Every person who is a qualified elector as  
17 defined by Section 1 of Article III of the Oklahoma Constitution  
18 shall be entitled to become a registered voter in the precinct of  
19 his or her residence, with the following conditions:

20 1. Persons convicted of a felony shall be eligible to register  
21 to vote when they have:

22 a. fully served their sentence of court-mandated calendar  
23 days or had their sentence discharged, including any  
24

1 term of incarceration, parole or supervision, or  
2 completed a period of probation ordered by any court,  
3 b. received a commutation that reduced the sentence of  
4 any active felony conviction to time served pursuant  
5 to federal or state law and have no other outstanding  
6 sentence under any other felony conviction,  
7 c. received a commutation pursuant to subsection F of  
8 Section 332.2 of Title 57 of the Oklahoma Statutes for  
9 a crime that has been reclassified from a felony to a  
10 misdemeanor and has no remaining time to serve,  
11 including:  
12 (1) any incomplete term of incarceration,  
13 (2) any remaining parole or supervision, or  
14 (3) any incomplete period of probation, or  
15 d. been granted a pardon pursuant to federal or state law  
16 and have no other outstanding sentence under any other  
17 felony conviction; and

18 2. Any person who has been adjudged to be an incapacitated  
19 person as such term is defined by Section 1-111 of Title 30 of the  
20 Oklahoma Statutes shall be ineligible to register to vote. When  
21 such incapacitated person has been adjudged to be no longer  
22 incapacitated such person shall be eligible to become a registered  
23 voter. The provisions of this paragraph shall not prohibit any  
24 person adjudged to be a partially incapacitated person as such term

1 is defined by Section 1-111 of Title 30 of the Oklahoma Statutes  
2 from being eligible to register to vote unless the order adjudging  
3 the person to be partially incapacitated restricts such person from  
4 being eligible to register to vote.

5 SECTION 2. This act shall become effective January 1, 2025.
