15	SECTION 1. AMENDATORY 21 O.S. 2021, Section 1028, is
16	amended to read as follows:
17	Section 1028. <u>A.</u> It shall be unlawful in the State of

Any person who violates the provisions of this section 7 shall, upon conviction, be guilty of a felony punishable by 8 9 imprisonment in the Department of Corrections for a term of not more 10 than five (5) years, and by a fine as follows: 1. C. Any person who engages in an act of child prostitution as 14 defined in Section 1030 of this title shall, upon conviction, be 15 quilty of a felony punishable by imprisonment in the custody of the 16 Department of Corrections for not more than ten (10) years and by 17 fines as follows: a fine not more than Five Thousand Dollars 18 (\$5,000.00) upon the first conviction, a fine not more than Ten 19 Thousand Dollars (\$10,000.00) upon the second conviction, and a fine 20 not more than Fifteen Thousand Dollars (\$15,000.00) upon the third 21 or subsequent convictions. 22

D. Any person violating any of the provisions of Section 1028,
1029 or 1030 of this title within one thousand (1,000) feet of a
