9 An Act relating to career and technology education;
10 amending 70 O.S. 2021, Section 14-108, which relates
11 to technology center school district governing
12 boards; directing the State Board of Career and
13 Technology Education to divide districts with a
14 certain number of electors into board zones;
15 providing for election of board members after certain
16 date; providing for filling of vacancy if certain
17 member is no longer a resident of certain zone;
18 providing for promulgation of rules; and providing an
19 effective date.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. AMENDATORY 70 O.S. 2021, Section 14-108, is
22 amended to read as follows:

23 Section 14-108. A. The State Board of Career and Technology
24 Education shall prescribe criteria and procedures for the
25 establishment and governance of technology center school districts,
26 as provided by Section 9B~~7~~ of Article X~~7~~ of the Oklahoma
27 Constitution, and such districts so established shall be operated in

1 accordance with rules of the State Board of Career and Technology
2 Education, except as otherwise provided in this title.

3 B. A technology center school district shall be a body
4 corporate and shall possess the usual powers of a corporation for
5 public purposes. Its official name shall be designated by the State
6 Board of Career and Technology Education, in which name it may sue
7 and be sued, and be capable of contracting and being contracted
8 with, and holding real and personal estate.

9 C. The governing board of a technology center school district
10 shall be a board of education consisting of not less than five (5)
11 nor more than seven (7) members. Except as otherwise provided for
12 in ~~subsection~~ subsections D and E of this section, all members of
13 the board of education shall be elected in a manner prescribed by
14 the State Board of Career and Technology Education. The State Board
15 shall promulgate rules prescribing the manner in which the elections
16 required by this subsection are held.

17 D. In a technology center school district that serves seventy
18 or more public school districts, the territory of the school
19 district shall be divided into district zones by the State Board of
20 Career and Technology Education. Between August 1 and December 31
21 of the year following the submission by the United States Department
22 of Commerce to the President of the United States of the official
23 Federal Decennial Census, the Board shall reapportion the territory
24 of the technology center school district into district zones. All

1 boundaries of district zones shall follow clearly visible,
2 definable, and observable physical boundaries which are based upon
3 criteria established and recognized by the Bureau of the Census of
4 the United States Department of Commerce for purposes of defining
5 census blocks for its decennial census and shall follow, as much as
6 possible, precinct boundaries. District zones shall be compact,
7 contiguous and shall be as equal in population as practical with not
8 more than a five-percent variance between the most populous and
9 least populous district zones. The board of education of a
10 technology center school district shall consist of one member
11 elected from each of the district zones of the school district
12 created pursuant to this subsection. The electors of each district
13 zone shall elect a person, who is a resident of the district zone,
14 to represent the district zone on the school board. If during the
15 term of office to which a person was elected, that member ceases to
16 be a resident of the district zone for which the person was elected,
17 the office shall become vacant and the vacancy shall be filled as
18 provided in Section 13A-110 of Title 26 of the Oklahoma Statutes.
19 The State Board of Career and Technology Education shall promulgate
20 rules prescribing the manner in which the elections required by this
21 subsection are held.

22 E. In technology center school districts having a population of
23 more than two hundred twenty-five thousand (225,000) electors, the
24 territory of the district shall be divided into board zones by the

1 State Board of Career and Technology Education. The board of
2 education of the technology center school district shall consist of
3 one member elected from each of the district zones. Beginning with
4 any election held after July 1, 2024, the electors of each district
5 zone shall elect a person who is a resident of the district zone to
6 represent the district zone on the school board. If during the term
7 of office to which a person was elected, that member ceases to be a
8 resident of the district zone for which the person was elected, the
9 office shall become vacant, and the vacancy shall be filled as
10 provided for in Section 13A-110 of Title 26 of the Oklahoma
11 Statutes. The State Board of Career and Technology Education shall
12 promulgate rules prescribing the manner in which the elections
13 required by this subsection are held.

14 F. The board of education of a technology center school
15 district shall have the same powers and duties that boards of
16 education of independent school districts have. It may require
17 nonresident students to pay reasonable tuition fees, which may be
18 paid for a student by the independent or elementary school district
19 in which the student resides.

20 ~~F.~~ G. An election to vote on the question of making a levy of
21 not to exceed five (5) mills on the dollar valuation of the taxable
22 property in a technology center school district under the provisions
23 of subsection ~~A~~ of Section ~~9B~~ of Article ~~X~~ of the Oklahoma
24 Constitution, shall be called by the board of education and

1 conducted by the county election board of such district in the same
2 manner that elections for emergency levies in school districts under
3 the provisions of subsection (d) of Section 9~~(d)~~, of Article X~~7~~ of
4 the Oklahoma Constitution, are called and conducted. When such levy
5 is approved by a majority of the electors of the technology center
6 school district voting on the question at such election, the levy
7 shall be made each fiscal year thereafter until repealed by a
8 majority of the electors of the district voting on the question at
9 an election called for such purpose. An election to vote on the
10 question of making a local incentive levy of not to exceed five (5)
11 mills on the dollar valuation of the taxable property in a
12 technology center school district under the provisions of subsection
13 B of Section 9B of Article X of the Oklahoma Constitution, may be
14 called by the board of education; and elections on a levy for a
15 building fund for an area school district under the provisions of
16 Section 10~~7~~, of Article X~~7~~, of the Oklahoma Constitution, shall be
17 called by the board of education of such district and conducted by
18 the county election board in the same manner that elections for
19 similar levies are called and conducted in independent school
20 districts.

21 G. H. Annual estimates of needs of technology center school
22 districts shall be made and approved in the same manner that those
23 of independent school districts are made and approved. Provided,
24 that the State Board of Career and Technology Education shall

1 prescribe a list of appropriation accounts by which the funds of
2 technology center school districts shall be budgeted, accounted for
3 and expended. Any such estimate of needs may include an estimate of
4 federal funds as probable income from sources other than ad valorem
5 tax of the district and other than any excise or other tax assessed
6 by legislative enactment and distributed in lieu of ad valorem
7 taxes. If a technology center school district lies in more than one
8 county, the district's estimate of needs shall be filed with and
9 approved by the county excise board of the county designated by the
10 school district board of education.

11 ~~H.~~ I. Territory may be annexed to or detached from a technology
12 center school district, in accordance with rules prescribed by the
13 State Board of Career and Technology Education. If the State Board
14 of Career and Technology Education requires the submission of a
15 petition in order for an election to be called for the purpose of
16 annexation or deannexation of territory to a technology center
17 school district, such petition shall not be required to bear a
18 number of technology center school district electors' signatures
19 which exceed fifty percent (50%) of the number of technology center
20 school district electors who voted in the last school board election
21 in the territory proposed to be annexed or deannexed. Provided, the
22 period of time from which the petition is initiated to its time of
23 filing with the State Board shall not exceed ninety (90) days.

1 ~~F.~~ J. Schools of technology center school districts shall be
2 subject to classification, inspection, and accreditation by the
3 State Board of Education.

4 ~~F.~~ K. The technology center school board of education may
5 designate a county treasurer to serve as treasurer of the school
6 district or may appoint an independent treasurer.

7 ~~K.~~ L. Within four (4) years after the creation of a technology
8 center school district, such school district may, at its discretion,
9 permit a teacher to transfer any or all accrued benefits upon
10 employment including credit for years of service in the previous
11 school district by the technology center school district, if the
12 teacher at the time of hiring is employed as a teacher by an
13 independent or elementary school district which is all or partly
14 within the boundaries of the technology center school district or is
15 employed as a teacher in a skills center within the boundaries of
16 the school district.

17 ~~L.~~ M. The board of education of a technology center school
18 district may convey surplus personal property without consideration
19 to:

20 1. A school district that is within the boundary of the
21 technology center school district;

22 2. A public school offering secondary level education which was
23 created and is operated by ~~the State of Oklahoma~~ this state and that
24 is within the boundary of the technology center school district;

1 3. A technology center school district; or

2 4. The Oklahoma Department of Career and Technology Education
3 for the support or delivery of department initiatives.

4 ~~M.~~ N. The board of education of a technology center school
5 district may, without prior approval of the State Board of Career
6 and Technology Education, approve all plans and specifications for
7 technology center school buildings, additions, and major
8 modifications to school buildings that are designed to provide for
9 the offering of vocational-technical education programs and services
10 when the cost of the building project is to be paid with local
11 levies or state bond monies or both local levies and state bond
12 monies.

13 SECTION 2. This act shall become effective July 1, 2024.
