1 of the county in which the crime occurred or a designee, the judge 2 who presided at the trial issuing the sentence of death, the chief of police of the municipality in which the crime occurred, if 3 applicable, and lead law enforcement officials of any state, county 4 5 or local law enforcement agency who investigated the crime or testified in any court or clemency proceeding related to the crime, 6 including but not limited to the sheriff of the county wherein where 7 the conviction was had occurred, to witness the execution; in 8 9 addition, the Cabinet Secretary of Public Safety and Security must 10 shall be invited as well as any other personnel or correctional personnel deemed appropriate and approved by the Director. 11 The 12 warden shall, at the request of the defendant, permit the presence of such ministers chosen by the defendant, not exceeding two, and 13 any persons, relatives, or friends, not to exceed five, as the 14 defendant may name; provided, reporters from recognized members of 15 the news media will shall be admitted upon proper identification, 16 application and approval of the warden. The identity of all persons 17 who participate in or administer the execution process and persons 18 who produce or supply the drugs, medical supplies, or medical 19 equipment for the execution shall be confidential and shall not be 20 subject to discovery in any civil or criminal proceedings. Such 21 confidentiality and exemption from discovery shall include but not 22 be limited to any documents, records, photographs, or other 23 information that may identify or reasonably lead directly or 24

indirectly to the identification of any person or entity who participates in or administers the execution process or any person 2 or entity who produces or supplies the drugs, medical supplies, or 3 4 medical equipment for the execution. The confidentiality 5 requirement and discovery exemption shall apply to any execution process occurring prior to, on, or after the effective date of this 6 act. The purchase of drugs, medical supplies, or medical equipment 7 necessary to carry out the execution shall not be subject to the 8 9 provisions of The the Oklahoma Central Purchasing Act.

In the event the defendant has been sentenced to death in С. 10 one or more criminal proceedings in this state, or has been 11 12 sentenced to death in this state and by one or more courts of competent jurisdiction in another state or pursuant to federal 13 authority, or any combination thereof, and this state has priority 14 to execute the defendant, the warden must shall invite the 15 prosecuting attorney or his or her designee, the judge, and the 16 chief law enforcement official from each jurisdiction where any 17 death sentence has issued. The above mentioned officials designated 18 in this subsection shall be allowed to witness the execution or view 19 the execution by closed circuit television as determined by the 20 Director of the Department of Corrections. 21

1 victim of the defendant may witness the execution. The immediate family members shall be allowed to witness the execution from an 2 area that is separate from the area to which other nonfamily member 3 witnesses are admitted; provided, however, if there are multiple 4 5 deceased victims, the Department shall not be required to provide separate areas for each family of each deceased victim. If 6 facilities are not capable or sufficient to provide all immediate 7 family members with a direct view of the execution, the Department 8 9 of Corrections may broadcast the execution by means of a closed circuit television system to an area in which other immediate family 10 members may be located. 11

12 Immediate family members may request individuals not directly related to the deceased victim but who serve a close supporting role 13 or professional role to the deceased victim or an immediate family 14 member_{au} including_{au} but not limited to_{au} a minister or licensed 15 The warden in consultation with the Director shall counselor. 16 approve or disapprove such requests. Provided further, the 17 Department may set a limit on the number of witnesses or viewers 18 within occupancy limits. 19

As used in this section, "members of the immediate family" means the spouse, a child by birth or adoption, a stepchild, a parent, a grandparent, a grandchild, a sibling of a deceased victim, or the spouse of any immediate family member specified in this subsection.

1 E. Any surviving victim of the defendant who is eighteen (18) 2 years of age or older may view the execution by closed circuit television with the approval of both the Director of the Department 3 of Corrections and the warden. The Director and warden shall 4 5 prioritize persons to view the execution, including immediate family members, surviving victims, and supporting persons, and may set a 6 limit on the number of viewers within occupancy limits. Any 7 surviving victim approved to view the execution of the defendant may 8 9 have an accompanying support person as provided for members of the immediate family of a deceased victim. As used in this subsection, 10 "surviving victim" means any person who suffered serious harm or 11 injury due to the criminal acts of the defendant of which the 12 13 defendant has been convicted in a court of competent jurisdiction. SECTION 2.
