5 An Act relating to information technology  
6 consolidation; amending 62 O.S. 2021, Section 35.3,  
7 which relates to the Information Technology  
8 Consolidation and Coordination Act; modifying  
9 definition; and providing an effective date.

10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY 62 O.S. 2021, Section 35.3, is  
12 amended to read as follows:

13 Section 35.3. As used in the Information Technology  
14 Consolidation and Coordination Act:

15 1. "Appropriated state agency" means any state agency that  
16 receives funding through the annual legislative appropriations  
17 process;

18 2. "Information technology assets" means any equipment or  
19 interconnected system or subsystem of equipment that is used in the  
20 acquisition, storage, manipulation, management, movement, control,  
21 display, switching, interchange, transmission, or reception of data  
22 or information. The term shall include computers, ancillary  
23 equipment, software, firmware and similar procedures, services,  
24 including support services and consulting services, software  
development, and related resources, and shall further include

1 telecommunications fiber networks used for conveying electronic  
2 communication or information systems to multiple physical locations;

3 3. "Information technology position" means a classified or  
4 unclassified position in the following functional areas:

- 5 a. applications programming,
- 6 b. EDP audit,
- 7 c. data examination,
- 8 d. computer applications,
- 9 e. computer data entry,
- 10 f. computer networking,
- 11 g. computer operations,
- 12 h. computer programming,
- 13 i. computer security,
- 14 j. computer software design,
- 15 k. web applications,
- 16 l. database analysis,
- 17 m. data management analysis,
- 18 n. database development,
- 19 o. database programming,
- 20 p. software design/development,
- 21 q. help desk,
- 22 r. imaging,
- 23 s. systems analysis,
- 24 t. systems application planning,

- 1 u. systems application,
- 2 v. systems administration,
- 3 w. systems coordination,
- 4 x. systems integration,
- 5 y. systems operation,
- 6 z. systems planning/development,
- 7 aa. systems programming,
- 8 bb. systems engineering,
- 9 cc. systems service specialist,
- 10 dd. systems support,
- 11 ee. network administration,
- 12 ff. network management,
- 13 gg. network technical,
- 14 hh. operating systems specialist,
- 15 ii. systems program manager,
- 16 jj. telecommunications, whether data or voice,
- 17 kk. software training, and
- 18 ll. technology development or support;

19 4. "Nonappropriated state agency" means any state agency that  
20 does not receive funding through the annual legislative  
21 appropriations process;

22 5. "Shared services" means those state agency functions which  
23 are or could be provided through:  
24

- 1 a. the services and systems specified in subsection A of  
2 Section 35.6 of this title, and  
3 b. the programs, services, software or processes  
4 specified in subsection B of Section 35.6 of this  
5 title; and

6 6. "State agency" means any office, elected or appointed  
7 officer, bureau, board, commission, counsel, unit, division, body,  
8 authority or institution of the executive branch of state government  
9 excluding institutions within The Oklahoma State System of Higher  
10 Education, the Oklahoma Municipal Power Authority, the Oklahoma  
11 State Regents for Higher Education, the Oklahoma State Bureau of  
12 Investigation, District Attorneys Council, the Office of the  
13 Attorney General, the Office of the State Auditor and Inspector, and  
14 the telecommunications network known as OneNet.

15 SECTION 2. This act shall become effective November 1, 2023.
