expenses arising from implementing programs and expenditures in accordance with actions taken by the Joint Committee on Pandemic Relief Funding. Such funds shall be utilized in a manner consistent with the recommendations adopted by the Joint Committee on Pandemic Relief Funding on May 11, 2023.

SECTION 2. NEW LAW A new section of law not to be codified in the Oklahoma Statutes reads as follows:

There is hereby appropriated to the ARPA Administrative Costs
Fund created in Enrolled House Bill No. 2940 of the 1st Session of
the 59th Oklahoma Legislature from monies not otherwise appropriated
from the Statewide Recovery Fund of the State Treasury created in
Enrolled House Bill No. 3349 of the 2nd Session of the 58th Oklahoma
Legislature, the sum of Five Million Eight Hundred Four Thousand
Dollars (\$5,804,000.00) or so much thereof as may be necessary to
pay for future administrative expenses approved by the Joint
Committee on Pandemic Relief Funding in association with
implementing, administering, or overseeing programs funded by the
Statewide Recovery Fund created in Enrolled House Bill No. 3349 of
the 2nd Session of the 58th Oklahoma Legislature.

SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby
