16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. NEW LAW A new section of law not to be
18 codified in the Oklahoma Statutes reads as follows:

19 There is hereby appropriated to the Office of Management and
20 Enterprise Services from monies not otherwise appropriated from the
21 Statewide Recovery Fund of the State Treasury created in Enrolled
22 House Bill No. 3349 of the 2nd Session of the 58th Oklahoma
23 Legislature, the sum of Four Million Seven Hundred Thousand Dollars
24 (\$4,700,000.00) or so much thereof as may be necessary to pay for

1 expenses arising from implementing programs and expenditures in
2 accordance with actions taken by the Joint Committee on Pandemic
3 Relief Funding. Such funds shall be utilized in a manner consistent
4 with the recommendations adopted by the Joint Committee on Pandemic
5 Relief Funding on May 11, 2023.

6 SECTION 2. NEW LAW A new section of law not to be
7 codified in the Oklahoma Statutes reads as follows:

8 There is hereby appropriated to the ARPA Administrative Costs
9 Fund created in Enrolled House Bill No. 2940 of the 1st Session of
10 the 59th Oklahoma Legislature from monies not otherwise appropriated
11 from the Statewide Recovery Fund of the State Treasury created in
12 Enrolled House Bill No. 3349 of the 2nd Session of the 58th Oklahoma
13 Legislature, the sum of Five Million Eight Hundred Four Thousand
14 Dollars (\$5,804,000.00) or so much thereof as may be necessary to
15 pay for future administrative expenses approved by the Joint
16 Committee on Pandemic Relief Funding in association with
17 implementing, administering, or overseeing programs funded by the
18 Statewide Recovery Fund created in Enrolled House Bill No. 3349 of
19 the 2nd Session of the 58th Oklahoma Legislature.

20 SECTION 3. It being immediately necessary for the preservation
21 of the public peace, health or safety, an emergency is hereby

2 be in full force from and after its passage and approval.
