9 CONFERENCE COMMITTEE SUBSTITUTE

10 An Act relating to school mapping data; directing  
11 school districts that map their campuses to use  
12 certain guidelines; defining term; prescribing  
13 requirements for school mapping data; prohibiting  
14 modification or updating of certain data without  
15 certain corresponding updates to certain public  
16 safety agencies; providing for codification;  
17 providing an effective date; and declaring an  
18 emergency.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. NEW LAW A new section of law to be codified  
21 in the Oklahoma Statutes as Section 5-148.4 of Title 70, unless  
22 there is created a duplication in numbering, reads as follows:

23 A. If a public school district in this state chooses to map its  
24 campus, the school district shall use the school mapping data  
25 guidelines provided for in this section. As used in this section,  
26 "school mapping data" means information provided in an electronic or

1 digital format to assist first responders in responding to  
2 emergencies at schools.

3 B. The school mapping data provided shall:

4 1. Be compatible with software platforms used by local, county,  
5 state, and federal public safety agencies that provide emergency  
6 services to the specific school for which the data is provided  
7 without requiring such agencies to purchase additional software or  
8 requiring a fee to view or access the data;

9 2. Be compatible with security software platforms in use by the  
10 specific school for which the data is provided without requiring  
11 public safety agencies or school districts to purchase additional  
12 software or requiring a fee to view or access the data;

13 3. Be in a printable format and, if requested in addition to  
14 subsection A of this section, be in a digital file format that can  
15 be integrated into interactive mobile platforms in use;

16 4. Be verified by the entity producing the data for accuracy by  
17 a walk-through of school buildings and grounds;

18 5. Be oriented true north;

19 6. Be overlaid on current aerial imagery;

20 7. Contain site-specific labeling that matches the structure of  
21 school buildings including room labels, hallway names, and external  
22 door or stairwell numbers and locations of hazards, critical utility  
23 locations, key boxes, automated external defibrillators, and trauma  
24 kits;

1 8. Contain site-specific labeling that matches the school  
2 grounds including parking areas, athletic fields, surrounding roads,  
3 and neighboring properties; and

4 9. Be overlaid with gridded "x" and "y" coordinates.

5 C. School mapping data as defined by this section shall not be  
6 modified or updated independently without corresponding updates to  
7 school mapping data within software platforms used by local, county,  
8 state, and federal public safety agencies that provide emergency  
9 services to the specific school.

10 SECTION 2. This act shall become effective July 1, 2024.

11 SECTION 3. It being immediately necessary for the preservation  
12 of the public peace, health, or safety, an emergency is hereby  
13 declared to exist, by reason whereof this act shall take effect and  
14 be in full force from and after its passage and approval.
