11 COMMITTEE SUBSTITUTE

12 An Act relating to the Oklahoma Historical Society;
13 creating the Oklahoma Museum of Popular Culture
14 Supplemental Revolving Fund; stating source of funds;
15 providing for expenditures; requiring certain
16 determination by the State Treasurer; requiring
17 transfer of funds if certain determination is not
18 made by certain date; providing for codification; and
19 declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 2294.1 of Title 62, unless there
23 is created a duplication in numbering, reads as follows:

24 There is hereby created in the State Treasury a revolving fund
for the Oklahoma Historical Society, to be designated the "Oklahoma
Museum of Popular Culture Supplemental Revolving Fund". The fund
shall be a continuing fund, not subject to fiscal year limitations,

1 and shall consist of all monies received by the Oklahoma Historical
2 Society from appropriations of the Legislature designated for
3 deposit in this fund. All monies accruing to the credit of the fund
4 are hereby appropriated and shall be budgeted and expended to
5 provide funding for repairs, planning, staging, refurbishments, and
6 improvements to real and personal property, and for funding for
7 construction of the Oklahoma Museum of Popular Culture. No
8 expenditures shall be made from the fund until the State Treasurer
9 determines that funds provided by local and county governments, the
10 federal government, or through monetary donations in the amount of
11 Eighteen Million Dollars (\$18,000,000.00) are made for repairs,
12 planning, staging, refurbishments, and improvements to real and
13 personal property, and for funding for construction of the Oklahoma
14 Museum of Popular Culture; provided, no funds collected or received
15 prior to the effective date of this act shall be counted towards the
16 amount. Expenditures from the fund shall be made upon warrants
17 issued by the State Treasurer against claims filed as prescribed by
18 law with the Director of the Office of Management and Enterprise
19 Services for approval and payment. On November 15, 2024, if no
20 determination is made by the Treasurer pursuant to the provisions of
21 this section authorizing expenditures from this fund, all
22 unencumbered funds remaining in the Oklahoma Museum of Popular
23 Culture Supplemental Revolving Fund shall be transferred to the

1 State Treasurer for deposit in the General Revenue Fund of the State
2 Treasury for the fiscal year ending June 30, 2024.

3 SECTION 2. It being immediately necessary for the preservation
4 of the public peace, health or safety, an emergency is hereby
5 declared to exist, by reason whereof this act shall take effect and
6 be in full force from and after its passage and approval.
