14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 70 O.S. 2021, Section 1210.508A,
16 is amended to read as follows:

17 Section 1210.508A. Sections 1210.508A through 1210.508E of this
18 title shall be known and may be cited as the ~~"Reading Sufficiency
19 Act"~~ "Strong Readers Act".

20 SECTION 2. AMENDATORY 70 O.S. 2021, Section 1210.508B,
21 is amended to read as follows:

22 Section 1210.508B. A. The Legislature finds that it is
23 essential for children in the public schools to read early and well
24 in elementary school. The Legislature further finds that clear and

1 visible goals, assessments to determine the reading level at each
2 elementary school, ~~annual~~ use of a scientifically based and
3 researched methodology in reading instruction in addition to regular
4 and periodic measurements of elementary school reading improvement,
5 and accountability in each level of the educational system will
6 result in a significant increase in the number of children reading
7 at or above grade level.

8 B. The purpose of the ~~Reading Sufficiency Act~~ Strong Readers
9 Act is to ensure that ~~each child attains the necessary reading~~
10 ~~skills by completion of the third grade which will enable that~~
11 ~~student to continue development of reading skills and to succeed~~
12 ~~throughout school and life~~ progression from one grade to another is
13 determined, in part, upon proficiency in reading, that school
14 district board of education policies facilitate reading instruction
15 and intervention services to addresses student reading needs, and
16 that each student and his or her parent or legal guardian be
17 informed of that student's reading progress.

18 C. Each public school district in this state shall ensure that
19 all students receive a well-rounded education that is focused on
20 building deep foundations in reading, writing, and mathematics. The
21 State Board of Education shall encourage school districts to
22 integrate the teaching of the other curricular areas in the subject
23 matter standards adopted by the Board with the instruction of
24 reading, writing, and mathematics. All teachers of reading in the

1 public schools in this state in kindergarten through third grade
2 shall incorporate into instruction the five elements of reading
3 instruction which are ~~phonemic~~ phonological awareness, ~~phonics~~
4 decoding, ~~reading~~ fluency, vocabulary, and comprehension.

5 SECTION 3. AMENDATORY 70 O.S. 2021, Section 1210.508C,
6 is amended to read as follows:

7 Section 1210.508C. A. ~~1.~~ To identify students who have a
8 reading deficiency including identifying students with
9 characteristics of dyslexia, each student enrolled in kindergarten
10 and first, second, and third grade in a public school in this state
11 shall be screened at the ~~beginning~~, middle and end of each school
12 year for reading skills including, but not limited to, ~~phonemic~~
13 phonological awareness, ~~letter recognition~~ decoding, fluency,
14 vocabulary, and ~~oral language skills as identified in the subject~~
15 ~~matter standards adopted by the State Board of Education~~
16 comprehension. A screening instrument approved by the State Board
17 of Education, in consultation with the Commission for Educational
18 Quality and Accountability and the Secretary of Education, shall be
19 utilized for the purposes of this section. In determining which
20 screening instrument to approve, the State Board of Education, the
21 Commission for Educational Quality and Accountability, and the
22 Secretary of Education shall take into consideration at a minimum
23 the following factors:

24

1 1. The time required to conduct the screening instrument with
2 the intention of minimizing the impact on instructional time;

3 2. The timeliness in reporting screening instrument results to
4 teachers, administrators, and parents and legal guardians of
5 students; and

6 3. The integration of the screening instrument into reading
7 curriculum.

8 ~~2. For those kindergarten children at risk for reading~~
9 ~~difficulties at the beginning of the year, teachers shall emphasize~~
10 ~~reading skills as identified in the subject matter standards adopted~~
11 ~~by the State Board of Education, monitor progress throughout the~~
12 ~~year and measure mid-year and year-end reading progress.~~

13 ~~3. Kindergarten students who are not meeting grade-level~~
14 ~~targets by mid-year in reading shall be provided a program of~~
15 ~~reading instruction designed to enable the student to acquire the~~
16 ~~appropriate grade-level reading skills.~~

17 ~~4. Classroom assistants, which may include parents,~~
18 ~~grandparents, or other volunteers, shall be provided in kindergarten~~
19 ~~classes to assist with the screening of students if a teacher aide~~
20 ~~is not already employed to assist in a kindergarten classroom.~~

21 ~~B. Each student enrolled in first, second and third grade of~~
22 ~~the public schools of this state shall be assessed at the beginning,~~
23 ~~middle and end of each school year using a screening instrument~~
24 ~~approved by the State Board of Education for the acquisition of~~

1 ~~reading skills including, but not limited to, phonemic awareness,~~
2 ~~phonics, reading fluency, vocabulary, and comprehension.~~

3 ~~C. Any student enrolled in first, second or third grade who is~~
4 ~~assessed and who is not meeting grade level targets in reading shall~~
5 ~~be provided a program of reading instruction designed to enable the~~
6 ~~student to acquire the appropriate grade level reading skills. The~~
7 ~~program of reading instruction shall include provisions of the READ~~
8 ~~Initiative adopted by the school district as provided for in~~
9 ~~subsection P of this section. Throughout the year progress~~
10 ~~monitoring shall continue, and diagnostic assessment, if determined~~
11 ~~appropriate, shall be provided. Year-end reading skills shall be~~
12 ~~measured to determine reading success.~~

13 ~~D. The State Board of Education shall approve screening~~
14 ~~instruments for use at the beginning middle and end of the school~~
15 ~~year, for monitoring of progress, and for measurement of reading~~
16 ~~skills at the end of the school year as required in subsections~~
17 ~~subsection A and B of this section; provided, at least one of the.~~

18 The screening instruments shall meet the following criteria:

- 19 1. Assess for phonemic phonological awareness, phonics
20 decoding, ~~reading~~ fluency, vocabulary, and comprehension;
- 21 2. Document the validity and reliability of each assessment;
- 22 3. Can be used for identifying students who are at risk for
23 reading deficiency and progress monitoring throughout the school
24 year;

1 4. Can be used to assess students with disabilities and English
2 language learners; and

3 5. Accompanied by a data management system that provides
4 profiles ~~for~~ of students, class, grade level, and school building.
5 The profiles shall identify each student's instructional point of
6 need and reading achievement level. The State Board shall also
7 determine other comparable reading assessments for diagnostic
8 purposes to be used for students at risk of reading failure. ~~The~~
9 ~~State Board shall ensure that any assessments approved are in~~
10 ~~alignment with the subject matter standards adopted by the State~~
11 ~~Board of Education.~~

12 ~~E. C.~~ 1. Students who are administered a screening instrument
13 pursuant to subsection A of this section and are found not to be
14 meeting grade-level targets shall be provided a program of reading
15 instruction designed to enable students to acquire the appropriate
16 grade-level reading skills. The program of reading instruction
17 ~~required in subsections A and B of this section shall~~ be based on
18 scientific reading research and align with the subject matter
19 standards adopted by the State Board of Education ~~and shall include~~
20 ~~provisions of the READ Initiative adopted by the school district as~~
21 ~~provided for in subsection P of this section.~~ A program of reading
22 instruction ~~may include, but is not limited to~~ shall include:

23 a. sufficient additional in-school instructional time for
24 the acquisition of ~~phonemic~~ phonological awareness,

1 ~~phonics~~ decoding, ~~reading~~ fluency, vocabulary, and
2 comprehension,

3 b. if necessary and if funding is available, tutorial
4 instruction after regular school hours, on Saturdays,
5 and during summer; however, such instruction may not
6 be counted toward the one-hundred-eighty-day or one-
7 thousand-eighty-hour school year required in Section
8 1-109 of this title, and

9 c. assessments identified for diagnostic purposes and
10 periodic monitoring to measure the acquisition of
11 reading skills including, but not limited to, ~~phonemic~~
12 phonological awareness, ~~phonics~~ decoding, ~~reading~~
13 fluency, vocabulary, and comprehension, as identified
14 in the student's program of reading instruction,

15 d. high-quality instructional materials grounded in
16 scientifically based reading research, and

17 e. a means of providing every family of a student in
18 prekindergarten, kindergarten, and first, second, and
19 third grade access to free online evidence-based
20 literacy instruction resources to support the
21 student's literacy development at home.

22 2. A student enrolled in kindergarten or first ~~or,~~ second,
23 ~~grades or third grade~~ who has been assessed as provided for in
24 ~~subsection B of this section and found not to be meeting grade-level~~

1 ~~targets in reading,~~ exhibits a deficiency in reading at any time
2 based on the screening instrument administered pursuant to
3 subsection A of this section shall ~~be entitled to supplemental~~
4 ~~instructional services and supports in reading until the student is~~
5 ~~determined by the results of a screening instrument to be meeting~~
6 ~~grade-level targets in reading~~ receive an individual reading
7 intervention plan no later than thirty (30) days after the
8 identification of the deficiency in reading. The reading
9 intervention plan shall be provided in addition to core reading
10 instruction that is provided to all students. The reading
11 intervention plan shall:

- 12 a. describe the research-based reading intervention
13 services the student will receive to remedy the
14 deficiency in reading,
- 15 b. provide explicit and systematic instruction in
16 phonological awareness, decoding, fluency, vocabulary,
17 and comprehension, as applicable,
- 18 c. monitor the reading progress of each student's reading
19 skills throughout the school year and adjust
20 instruction according to the student's needs, and
- 21 d. continue until the student is determined to be meeting
22 grade-level targets in reading based on screening
23 instruments administered pursuant to subsection A of
24 this section or assessments identified for diagnostic

1 purposes and periodic monitoring pursuant to
2 subparagraph c of paragraph 1 of this subsection.

3 3. The ~~program of reading instruction~~ intervention plan for
4 each student identified with a deficiency in reading shall be
5 developed by a Student Reading Proficiency Team and shall include
6 supplemental instructional services and supports. Each team shall
7 be composed of:

- 8 a. the parent or guardian of the student,
- 9 b. the teacher assigned to the student who had
10 responsibility for reading instruction in that
11 academic year,
- 12 c. a teacher who is responsible for reading instruction
13 and is assigned to teach in the next grade level of
14 the student, and
- 15 d. a certified reading specialist, if one is available.

16 4. A school district shall notify the parent or legal guardian
17 of any student in kindergarten or first, second, or third grade who
18 exhibits a deficiency in reading at any time based on the screening
19 instrument administered pursuant to subsection A of this section.
20 The notification shall occur no later than fifteen (15) days after
21 the identification of the deficiency in reading.

22 ~~F. The program of reading instruction shall continue until the~~
23 ~~student is determined by the results of approved reading assessments~~
24 ~~to be meeting grade-level targets.~~

1 ~~G. D.~~ 1. Every school district shall adopt, and implement a
2 district ~~reading sufficiency~~ strong readers plan which has had input
3 from school administrators, teachers, and parents and legal
4 guardians and if possible a reading specialist, and which shall be
5 submitted electronically to and approved by the State Board of
6 Education. The plan shall be updated annually. School districts
7 shall not be required to electronically submit the annual updates to
8 the Board if the last plan submitted to the Board was approved and
9 expenditures for the program include only expenses relating to
10 individual and small group tutoring, purchase of and training in the
11 use of screening and assessment measures, summer school programs,
12 and Saturday school programs. If any expenditure for the program is
13 deleted or changed or any other type of expenditure for the program
14 is implemented, the school district shall be required to submit the
15 latest annual update to the Board for approval. The district
16 ~~reading sufficiency~~ strong readers plan shall include a plan for
17 each site which includes an analysis of the data provided by the
18 Oklahoma School Testing Program and other reading assessments
19 utilized as required in this section, and which outlines how each
20 school site will comply with the provisions of the ~~Reading~~
21 ~~Sufficiency~~ Strong Readers Act.

22 2. The State Board of Education shall adopt rules for the
23 implementation and evaluation of the provisions of the ~~Reading~~
24 ~~Sufficiency~~ Strong Readers Act. The evaluation shall include, but

1 not be limited to, an analysis of the data required in subsection ~~S~~
2 K of this section.

3 ~~H. For any third-grade student found not to be meeting grade-~~
4 ~~level targets as determined by reading assessments administered~~
5 ~~pursuant to this section, a new program of reading instruction,~~
6 ~~including provisions of the READ Initiative adopted by the school~~
7 ~~district as provided for in subsection P of this section, shall be~~
8 ~~developed by a Student Reading Proficiency Team and implemented as~~
9 ~~specified in subsection E of this section. In addition to other~~
10 ~~requirements of the Reading Sufficiency Act, the plan may include~~
11 ~~specialized tutoring.~~

12 ~~F. E. 1. Any first-grade, second-grade, or third-grade student~~
13 ~~who demonstrates end of year proficiency in reading at the third-~~
14 ~~grade level through a grade-level appropriate screening instrument~~
15 ~~which meets the acquisition of reading skills criteria approved~~
16 ~~pursuant to subsection B of this section shall not be subject to~~
17 ~~retention pursuant to this section require a program of reading~~
18 ~~instruction or an individual reading intervention plan. After a~~
19 ~~student has demonstrated proficiency through a screening instrument,~~
20 ~~the district shall provide notification to the parent or legal~~
21 ~~guardian of the student that ~~they have~~ he or she has satisfied the~~
22 ~~requirements of the Reading Sufficiency Act and will not be subject~~
23 ~~to retention pursuant to this section Strong Readers Act. The~~

1 district shall continue to monitor the student in the next
2 successive grade level to ensure he or she maintains proficiency.

3 2. ~~If~~ Beginning with the 2024-2025 school year, if a third-
4 grade student is identified at any point of the academic year as
5 having a significant reading deficiency, which shall be defined as
6 not meeting grade-level targets on a screening instrument ~~which~~
7 ~~meets the acquisition of reading skills criteria~~ administered
8 pursuant to subsection ~~B~~ A of this section, the district shall
9 ~~immediately begin a student reading portfolio as provided by~~
10 ~~subsection L of this section and shall provide notice to the parent~~
11 ~~of the deficiency pursuant to subsection J of this section~~ provide
12 the student with intensive intervention services for the appropriate
13 amount of the instructional day consistent with the individual
14 reading intervention plan developed pursuant to paragraph 2 of
15 subsection C of this section and as determined by the Student
16 Reading Proficiency Team. Intensive intervention services shall
17 continue until the student demonstrates proficiency at his or her
18 grade level based on a screening instrument administered pursuant to
19 subsection A of this section.

22 ~~and still has a significant reading deficiency, as identified based~~
23 ~~on assessments administered as provided for in subsection B of this~~

1 ~~through a student portfolio as provided in subsection L of this~~
2 ~~section, or is not subject to a good cause exemption as provided in~~
3 ~~subsection L of this section, then the student shall not be eligible~~

5 ~~4. The minimum criteria for grade-level performance of third-~~
6 ~~grade students pursuant to the Reading Sufficiency Act shall be that~~
7 ~~students are able to read and comprehend grade-level text. To~~
8 ~~determine the promotion and retention of third-grade students~~
9 ~~pursuant to the Reading Sufficiency Act, the State Board of~~
10 ~~Education shall use only the scores for the standards for reading~~
11 ~~foundations/processes and vocabulary portions of the statewide~~
12 ~~third-grade assessment administered pursuant to Section 1210.508 of~~
13 ~~this title and shall not use the scores from the other language arts~~
14 ~~portions of the assessment. The performance levels established by~~
15 ~~the Commission for Educational Quality and Accountability pursuant~~
16 ~~to Section 1210.508 of this title shall ensure that students meeting~~
17 ~~the performance-level criteria are performing at grade level on the~~
18 ~~reading foundations and vocabulary portions of the statewide third-~~

6 ~~exemption as provided in subsection L of this section, and who do~~

11 7. F. Each school district shall annually report in an
12 electronic format to the State Department of Education, the Office
13 of Educational Quality and Accountability, and the Secretary of

15 ~~pursuant to this subsection and the number of students promoted to a~~
16 ~~subsequent grade pursuant to the provisions in paragraph 5 of this~~
17 ~~subsection~~ in kindergarten through third grade per grade level who
18 exhibit grade-level reading proficiency, the number of students per
19 grade level who received intensive intervention services pursuant to
20 paragraph 2 of subsection E of this section, the number of students
21 per grade level who attended a summer academy as provided for in
22 Section 1210.508E of this title, the number of students per grade
23 level who exhibited improved reading proficiency after completion of
24 intensive intervention services, and the number of students per

1 grade level who are still in need of intensive intervention
2 services. The State Department of Education shall publicly report
3 the aggregate and district-specific ~~number of students promoted~~
4 numbers submitted pursuant to this subsection on ~~their~~ its website
5 and shall provide electronic copies of the report to the Governor,
6 Secretary of Education, President Pro Tempore of the Senate, Speaker
7 of the House of Representatives, and to the respective chairs of the
8 committees with responsibility for common education policy in each
9 legislative chamber.

10 ~~J.~~ G. The parent of any student who is found to have a reading
11 deficiency and is not meeting grade-level reading targets and has
12 been provided a program of reading instruction as provided for in
13 paragraph 1 of subsection B C of this section shall be notified in
14 writing of the following:

15 1. That the student has been identified as having a substantial
16 deficiency in reading;

17 2. A description of the current services that are provided to
18 the student pursuant to ~~a conjoint measurement model such that a~~
19 ~~reader and a text are placed on the same scale~~ subsection C of this
20 section;

21 3. A description of the proposed ~~supplemental instructional~~
22 intensive intervention services and supports that will be provided
23 to the student that are designed to remediate the identified area of
24

1 reading deficiency as provided for in paragraph 2 of subsection E of
2 this section;

3 4. That ~~the~~ a student ~~will not be~~ who is promoted to the fourth
4 grade ~~if the reading deficiency is not remediated by the end of the~~
5 ~~third grade, unless the student is otherwise promoted as provided~~
6 ~~for in subsection I of this section or is exempt for good cause as~~
7 ~~set forth in subsection L of this section~~ shall receive supplemental
8 intensive intervention services;

9 5. Strategies for parents to use in helping their child succeed
10 in reading proficiency; and

11 6. The grade-level performance scores of the student;

12 ~~7. That while the results of the statewide assessments~~
13 ~~administered pursuant to Section 1210.508 of this title are the~~
14 ~~initial determinant, they are not the sole determiner of promotion~~
15 ~~and that portfolio reviews and assessments are available; and~~

16 ~~8. The specific criteria and policies of the school district~~
17 ~~for midyear promotion implemented as provided for in paragraph 4 of~~
18 ~~subsection O of this section.~~

19 ~~K. H.~~ H. No student may be assigned to a grade level based solely
20 on age or other factors that constitute social promotion.

21 ~~L. For those students who do not meet the academic requirements~~
22 ~~for promotion and who are not otherwise promoted as provided for in~~
23 ~~subsection I of this section, a school district may promote the~~

24

1 ~~student for good cause only. Good cause exemptions for promotion~~
2 ~~shall be limited to the following:~~

3 ~~1. English language learners who have had less than two (2)~~
4 ~~years of instruction in an English language learner program;~~

5 ~~2. Students with disabilities whose individualized education~~
6 ~~program (IEP), consistent with state law, indicates that the student~~
7 ~~is to be assessed with alternate achievement standards through the~~
8 ~~Oklahoma Alternate Assessment Program (OAAP);~~

9 ~~3. Students who demonstrate an acceptable level of performance~~
10 ~~on an alternative standardized reading assessment approved by the~~
11 ~~State Board of Education;~~

12 ~~4. Students who demonstrate, through a student portfolio, that~~
13 ~~the student is reading on grade level as evidenced by demonstration~~
14 ~~of mastery of the state standards beyond the retention level;~~

15 ~~5. Students with disabilities who participate in the statewide~~
16 ~~assessments administered pursuant to Section 1210.508 of this title~~
17 ~~and who have an individualized education program that reflects that~~
18 ~~the student has received intensive remediation in reading and has~~
19 ~~made adequate progress in reading pursuant to the student's~~
20 ~~individualized education program;~~

21 ~~6. Students who have received intensive remediation in reading~~
22 ~~through a program of reading instruction for two (2) or more years~~
23 ~~but still demonstrate a deficiency in reading and who were~~

8 ~~intensive reading instruction that includes specialized diagnostic~~
9 ~~information and specific reading strategies for each student until~~

11 ~~district shall assist schools and teachers to implement reading~~
12 ~~strategies for the promoted students that research has shown to be~~
13 ~~successful in improving reading among low-performing readers.~~

14 ~~N. Requests to exempt students from the retention requirements~~
15 ~~based on one of the good-cause exemptions as described in subsection~~
16 ~~L of this section shall be made using the following process:~~

17 ~~1. Documentation submitted from the teacher of the student to~~
18 ~~the school principal that indicates the student meets one of the~~
19 ~~good-cause exemptions and promotion of the student is appropriate.~~
20 ~~In order to minimize paperwork requirements, the documentation shall~~
21 ~~consist only of the alternative assessment results or student~~
22 ~~portfolio work and the individual education plan (IEP), as~~
23 ~~applicable;~~

1 ~~2. The principal of the school shall review and discuss the~~
2 ~~documentation with the teacher and, if applicable, the other members~~
3 ~~of the Student Reading Proficiency Team as described in subsection E~~
4 ~~of this section. If the principal determines that the student meets~~
5 ~~one of the good cause exemptions and should be promoted based on the~~
6 ~~documentation provided, the principal shall make a recommendation in~~
7 ~~writing to the school district superintendent; and~~

8 ~~3. After review, the school district superintendent shall~~
9 ~~accept or reject the recommendation of the principal in writing.~~
