11	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
12	SECTION 1. AMENDATORY 10A O.S. 2021, Section 2-7-202, is
13	amended to read as follows:
14	Section 2-7-202. A. There is hereby created the Office of
15	Juvenile Affairs which shall be responsible for programs and
16	services for youthful offenders and juveniles alleged or adjudicated
17	to be delinquent or in need of supervision. Within The Executive
18	Director shall be responsible for established divisions and
19	appointing Division Directors within the Office of Juvenile Affairs.
20	there is hereby created:
21	1. The Division of Institutional Services which shall be
22	responsible for the institutions operated by or contracted for by
23	the Office of Juvenile Affairs;

1	2. The Division of Community-based Youth Services which shall
2	be responsible for contracting with, monitoring, evaluation and
3	support of community-based Youth Services Agencies;
4	3. The Division of Juvenile and Treatment Services which shall
5	be responsible for intake, probation and parole services,
6	supervision and placement of juveniles and the contracting for,
7	monitoring and evaluation of residential and treatment programs
8	other than institutions and community-based Youth Services Agencies;
9	and
10	4. Such other divisions specifically established by the
11	Executive Director of the Office of Juvenile Affairs, with the
12	approval of the Board.
13	The Executive Director of the Office of Juvenile Affairs, with
14	the approval of the Board, shall appoint a Director of the Division
15	of Institutional Services, a Director of the Division of Community-
16	based Youth Services, and a Director of the Division of Juvenile and
17	Treatment Services to serve as the administrative head of each
18	division, respectively. The Division Directors shall have at least
19	six (6) years of experience in the same or similar programs or
20	facilities as they are to supervise and a baccalaureate degree or
21	higher level of education.
22	B. Suitable office space shall be provided by the Office of
23	Management and Enterprise Services to the Office of Juvenile
24	Affairs, to the extent necessary for the Office to implement its

jurisdictional duties provided by the Oklahoma Juvenile Code, and
 the Office may incur necessary expenses for office rent.

C. Effective July 1, 1995, the Office of Juvenile Affairs shall 3 be a Merit System agency and all employees of the Office of Juvenile 4 5 Affairs shall be classified employees who are subject to the Oklahoma Personnel Act and the Merit System of Personnel 6 7 Administration, except as otherwise provided by law. Effective June 1, 2020, employees hired for service at the Southwest Oklahoma 8 Juvenile Center in Manitou shall be considered unclassified and 9 10 employed in a term-limited appointment. If state services continue 11 at the facility after the designated term, the employee may be 12 transferred into a non-term-limited position. Current employees and 13 employees hired prior to June 1, 2020, shall not be subject to this 14 provision.

D. Effective July 1, 1995, within its jurisdictional areas of responsibility, the Office of Juvenile Affairs, acting through the Executive Director, or persons authorized by law, rule or designated by the Executive Director to perform such acts, shall have the power and duty to:

20 1. Advise, consult, cooperate and enter into agreements with 21 agencies of the state, municipalities and counties, other states and 22 the federal government, and other persons;

23 2. Enter into agreements for, accept, administer and use,
24 disburse and administer grants of money, personnel and property from

1 the federal government or any department or agency thereof, or from 2 any state or state agency, or from any other source, to promote and 3 carry on in this state any program within its jurisdictional area of 4 responsibility;

5 3. Require the establishment and maintenance of records and6 reports;

4. Establish a system of training for personnel in order to
8 assure uniform statewide application of law and rules;

9 5. Enforce the provisions of the Oklahoma Juvenile Code and10 rules promulgated thereunder and orders issued pursuant thereto;

Charge and receive fees pursuant to fee schedules
 promulgated by the Board of Juvenile Affairs;

13 7. Conduct studies, research and planning of programs and 14 functions, pursuant to the authority granted by the Oklahoma 15 Juvenile Code;

16 8. Enter into interagency agreements;

9. Provide administrative and support services to the Board of
Juvenile Affairs as necessary to assist the Board in the performance
of their its duties;

20 10. Establish and maintain such facilities and institutions as
21 are necessary or convenient for the operation of programs for
22 children under the jurisdiction of the Office of Juvenile Affairs;
23 11. Lease, from time to time, any real property which the Board
24 of Juvenile Affairs shall determine advisable to more fully carry

1 into effect the operation of the Office of Juvenile Affairs in accordance with applicable state statutes. All such leases for real 2 property shall be subject to the provisions of Section 63 of Title 3 74 of the Oklahoma Statutes; 4 5 12. Purchase or lease any equipment, supplies or materials pursuant to The Oklahoma Central Purchasing Act; 6 7 13. Contract for professional services; Acquire, construct, extend, and operate any and all 8 14. 9 facilities of all kinds which in the judgment of the Executive 10 Director and the approval of the Legislature shall be necessary or 11 convenient to carry out the duties of the Office of Juvenile 12 Affairs, as authorized by law; and 13 15. Establish an employee recruitment and referral incentive 14 program and promulgate internal agency policy for the operation of 15 the program, which may include, but shall not be limited to, program 16 purposes, pay incentives for employees, eligibility requirements, 17 payment conditions and amounts, payment methods, payment recoupment, 18 and record keeping; and

19 <u>16.</u> Exercise all incidental powers which are necessary and 20 proper to implement and administer the purposes of the Oklahoma 21 Juvenile Code.

E. The Office of Juvenile Affairs shall maintain a fair, simple and expeditious system for resolution of grievances of all persons committed to the Office of Juvenile Affairs regarding the substance or application of any written or unwritten policy, rule of the Board of Juvenile Affairs or of an agent or contractor of the Office of Juvenile Affairs or any decision, behavior or action by an employee, agent or contractor or by any other person committed to the Office of Juvenile Affairs.

6 F. Effective November 1, 2012, the Office of Juvenile Affairs 7 shall establish a system of certification in accordance with the Oklahoma Child Care Facilities Licensing Act for the shelters 8 9 managed and operated by the Department of Human Services pursuant to 10 the requirements of Section 1-9-111 of this title. The Office of 11 Juvenile Affairs shall certify shelters pursuant to the requirements 12 of existing rules as established by the Oklahoma Commission on 13 Children and Youth until such time the Office of Juvenile Affairs 14 has promulgated rules for the certification of shelters.

SECTION 2. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
