- 1. The districts shall provide half of the funding for the grants and the State Board of Education shall provide the other half of the grant funding;
- 2. School nurses, audiologists, school counselors, and mental health professionals employed through the grant program shall complete a training program prescribed by the State Department of Education:
- 3. School nurses, audiologists, school counselors, and mental health professionals may be employed by a district on a full-time or part-time basis, or may be employed on a contract basis with a private, third-party provider; and
- 4. School nurses, audiologists, school counselors, and mental health professionals employed through the grant program shall spend a minimum amount of time on their respective nursing, audiology, and counseling duties as required by the State Department of Education.
 - C. As used in this section:
 - 1. "Mental health professionals" means:
 - a. licensed professional counselors (LPCs),
 - b. licensed alcohol and drug counselors (LADCs),
 - c. school psychologists,
 - d. licensed marriage and family therapists (LMFTs),
 - e. licensed clinical social workers (LCSWs), or
 - f. licensed recreational therapists (CTRS/L);

1 2. "School counselor" means a person certified as a school 2 counselor by the State Board of Education who provides student 3 support counseling, academic counseling, or both; and 4 3. "School nurse" shall have the same meaning as defined in 5 paragraph 7 of Section 1-116 of Title 70 of the Oklahoma Statutes. 6 The State Board of Education may promulgate rules to 7 implement the provisions of this section. 8 SECTION 2. This act shall become effective July 1, 2024. 9 SECTION 3.
